- 3. The contract shall be on a comprehensive maintenance service basis i.e. no extra charges for supply of tonner, replacement of any defective parts will be paid by this Ministry. During the currency of the contract period it will be the responsibility of the company to keep the equipment in perfect working order. The repair works will have to be carried out at the location of the equipment except in the exceptional circumstances where the equipment or any component may be required to be taken out for repairs in workshop.

- 4. The payment towards AMC charges would be made on meter reading basis supported by certificate from the concerned users.
- 5. AMC will be terminated any time during the pendency of contract, if the service is found un-satisfactory.

- 6. If any Photostat Machine is not repaired within two days, the firm will provide standby Photostat Machine. In case, the firm fails to repair or provide a stand-by Photostat Machine within 2 days, then a penalty of Rs. 200/- (Rupees two hundred only) per day or part thereof will be charged for delay beyond the two days till such time Photostat Machines are repaired.
- 7. The tenderers are required to prove their competence for undertaking the job in question and also furnish their standing and goodwill through a certificate from a Govt. Department mentioning name, designation and telephone No. of the officer of the department.
- 8. Quotations received after due date and time will not be accepted. The Under Secretary (General Branch) reserves the right to select or reject any of all tenders without assigning any reasons whatsoever and also reserves the right to reduce or increase the number of items offered for maintenance contract. This tender is not transferable.
