The quotations addressed to the undersigned in a sealed cover should reach this Department latest by 3.00 PM on 4th June, 2010. The quotations received in time will be opened at 3.30 PM on the same day (04.06.2010). The quotation should be addressed to the Deputy Secretary (General Administration) Room No.531, Shastri Bhawan, New Delhi and is to be given in Room No.511-B, Shastri Bhawan, New Delhi on or before 3.00 PM on 04.06.2010. The vehicle will be available for inspection between 1.00 PM to 3.00 PM upto 02.06.2010.

3. The quotations received in time will be opened in Room No.531-A, Shastri Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at time of opening of quotations.

4. The sale will be governed by the following conditions:

- (i) The bidder is required to pay Earnest Money of Rs.5000/- for this vehicle.
- (ii) Earnest Money is payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Corporate Affairs, New Delhi. (payment by cheque or cash shall not be accepted)

- (iii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- (iv) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Corporate Affairs within two working days of the acceptance of the bid.
