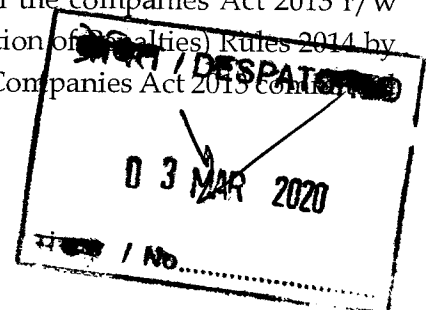

In this circumstance, the matter has been decided ex-parte and the following penalty is levied u/ s 137(3) of the companies Act 2013 r/w section 454 of Companies Act 2013 read with Companies (Adjudication of Penalties) Rules 2014 by the Adjudicating Authority for the violation of section 137(1) of the Companies Act 2013.
