That this office had received a complaint against your company which was sent to you on 31.01.2019 and the same was not replied. Further the office issued you reminder for the complaint and during scrutiny of the documents it is noted that the company has not filed Annual Returns for year 2017-2018 as required under the provisions of the Companies Act 2013.

That therefore this office has issued notice dated 23.07.2019 for violation of Sec 92 of the Companies Act 2013 and subsequently notice for adjudication was also sent vide No. 3679-3681 for hearing.

That on the date of hearing 14.10.2019 neither the directors were present nor any authorized representative was present. That the office further fixed the next date of hearing for 18.12.2019 which was not attended by any person/authorized representative.

In view of the above facts the undersigned has given reasonable opportunity to hear the case and has reasonable cause to believe that the provision of Sec 92 of the Company Act, 2013 which provides for doing filing as per Sec 92 within 60 days from AGM, has not been complied with for the year 2017-2018 by the Company and its directors



and therefore liable for penal action 92(5) of the Companies Act, 2013 r/w sec 454 of the Companies Act 2013.

Hence in exercising of the power conferred U/s 454 (3)(a) r/w Sec 92 of the Companies Act 2013 passed adjudication order imposing penalty as underfor non-compliance of Section 92(4) of Companies Act 2013:
