- The Government has subsequently amended the Public Servants (Furnishing of 2. Information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Returns) Rules, 2014 under the Lokpal and Lokayuktas Act, 2013, vide Notification dated 26th December, 2014, in terms of which, the last date for submission of returns of assets and liabilities by public servants has now been extended to 30th April, 2015. The Government have also modified Form No.II and Form No. IV for filing of returns.
