ORDER

In the above named M/s. Mafatlal Industries Limited

The above named company was incorporated on 20.01.1913 and presently having its Registered office situated at 301-302, Heritage Horizon, Third Floor, Off. C.G. Road, Navrangpura, Ahmedabad-380009

As per the Ministry's order vide letter No. F. No. 07/57/2016/CL-II(WR) dated 20.06.2016, the inspection of books of account and other records of the Company was carried out under section 206(5) of the Companies Act, 2013 by the Directorate (NWR), Ahmedabad. During the course of inspection of the Books of accounts and other records of the company by an officer appointed by the Central Government, under Section 206(5) of the Companies Act, 2013, it was observed and interalia pointed out by the Inspecting officer that provisions of **Section 118(1) of** the Companies Act, 2013 (Corresponding section 193 of the Companies Act, 1956) has been contravened as under:-

"During the inspection of books of accounts and Minutes book of the company from 2015 to 2016, it is observed that the minutes of the meeting of the Nomination and Remuneration Committee of the Board of Directors of the Company that they are typed on one side of the page and leaving the other side of the page blank and pages of the said minutes book is not consecutively numbered, hence in violation of the provisions of section 118(1) of the Companies Act, 2013 (Corresponding Section 193 of the Companies Act, 1956)."

- In view of the above facts the undersigned has reasonable cause to believe that the provision of Section 118 of the Companies Act, 2013 (Corresponding section 193 of the Companies Act, 1956) not been complied with by the Company and its officers in default. The office of the Registrar of Companies, Gujarat, Dadra and Nagar Haveli issued Show Cause Notices to the Company and its Six Respondents Vide Letter No. ROC/GUJ/STA(N)/Sec. 454(118)/3678 to 84 dated 03.07.2017.
- 2) The Company and its officers in default have rendered themselves liable for panel action as provided in sub-section 11 of section 118 of the Companies Act, 2013. As per provision of section 118 (11), there is provision for penalty for which the ROC is empowered to adjudicate the penalty under section 454 (3) of the Companies Act, 2013.

- 3) The undersigned in exercise of power conferred under sub section 3 of section 454 of the Companies Act, 2013 fixed the date of hearing on 13.07.2017 to adjudicate penalty for violation of provision of section 118 (1) read with rule 25 of the Companies (Management and Administration) Rules, 2014.
- 4) In response to the adjudication notice issued by Registrar of Companies, Gujarat vide dated 03.07.2017 to the company and its officers in default in the matter have authorized Shri Umesh Ved, Company Secretary vide authorisation dated 13.07.2017 to appear and represent before the adjudicating authority- Registrar of Companies, Gujarat on the date given above and time for oral and written submission and to all acts and things as may be necessary and incidentally in the matter.
- 5) That during the hearing on 13.07.2017, Mr. Umesh Ved, Paracticing Company Secretary and Authorized representative of the Respondents submitted written submission dated 13.07.2017 before the adjudicating officer. After examination of the said submission, it has been observed that Shri Rashesh Shah was Company Secretary in the company, who had resigned from the company on 13.06.2014. Hence, it was decided that he is not officer in default for the year 2015-16. Shri Umesh Ved further submitted that violation on the part of the Respondents was absolutely unintentional and was committed inadvertently without any malafied intension.

That keeping in mind all the relevant facts and after consideration of the oral submissions made by the Mr. Umesh Ved, Practicing Company Secretary and Authorized Representative of the Respondents, it is observed that the company and Respondent No. 3 to 7 had committed default under section 118 (1) of the Companies Act, 2013 for the Financial Year 2014-15 and 2015-16. And Respondent No. 2 had committed default under section 118(1) of the Companies Act, 2013 for the Financial Year 2014-15. After taking into consideration all the relevant facts of the cases, penalty Rs. 10,000/- on Company and Rs.2000/- on each Respondents are hereby imposed for each year-wise default.

The penalties imposed as under should be paid by the Respondents within prescribed time as the Act and submit the copies of Challan to this office within prescribed time limit as per the Act.-
