The vehicle will be available for inspection between 1.00 PM to 3.00 PM upto 13.05.2011.
3. The quotations received in time will be opened in Room No. 315 Paryavaran Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at time of opening of quotations.

4. The sale will be governed by the following conditions:
