MOHALI GETS INDIA'S FIRST FULLY AC BUS TERMINUS

Chandigarh, 16 December: Days before the election 'code of conduct' comes into force, the Parkash Singh Badal government on Friday inaugurated India's first fully air-conditioned bus terminus, the busopolis, in Mohali (S.A.S. Nagar), Punjab.

"Labeled as country's first such bus stand having facilities like an airport terminal, this bus terminus will remain operational round the clock and cater to bus services belonging to Punjab, Chandigarh, Himachal Pradesh, Jammu and Kashmir, Haryana and Uttrakhand. An official spokesperson said the facilities at the new bus terminus include food court and retail outlets, free Wi-Fi, ATMs, cybercafes, medical aid and pharmacy, multi-level parking, cloak rooms, tourist information booths, AC dormitories, waiting lounges and sniffer dogs to ensure safety of passengers. "The inter-state bus terminus (ISBT) is the first phase of the Rs 700 crore budgeted project that will be completed in three phases. The project will also have a commercial hub, a hotel, and a helipad," he added.
