## **HIGHLIGHTS**

### **I. REGISTERED COMPANIES AS ON 31<sup>ST</sup> DECEMBER, 2019**

1. The total number of companies registered in the country as on 31<sup>st</sup> December, 2019 stood at 1,966,551. Of them 740,354 companies were closed, 2,109 companies were assigned dormant status as per the Companies Act, 2013; 6,498 were under liquidation; 42,033 companies were in the process of being struck-off. After being struck off previously, 68 Companies were in the process of being re-activated. Taking the above into account, there were 1,175,489 active companies as on 31<sup>st</sup> December, 2019.

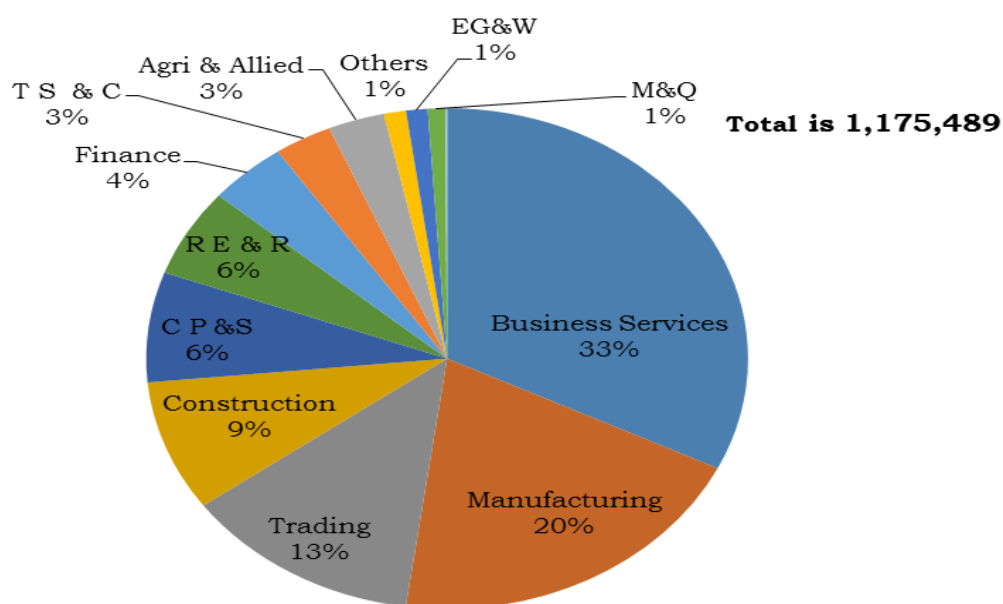
2. Out of the 740,354 closed companies, 10,894 companies were liquidated/dissolved; 687,079 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 24,560 companies were amalgamated/ merged with other companies; 12,947 companies were converted to Limited Liability Partnership (LLP) and 4,874 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31<sup>st</sup> December, 2019.

3. Out of the 1,175,489 active companies, 1,167,867 were limited by shares; 7,316 were limited by guarantee and 306 were unlimited companies. Out of the companies limited by shares, 63,343 were public, 1,104,524 were private including 26,486 One person companies. Among the public limited companies, 6,827 were listed (**Table 1.2**).

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (388,111), followed by Delhi (343,988) and West Bengal (205,670). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (229,501), followed by Delhi (201,402) and West Bengal (125,864) as on 31<sup>st</sup> December, 2019. (**Table-1.3**).

5. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (378,705) followed by Manufacturing (234,897), Trading (150,771) and Construction (99,359). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

**Chart 1.1: Sector-wise Active Companies as on 31st December, 2019**

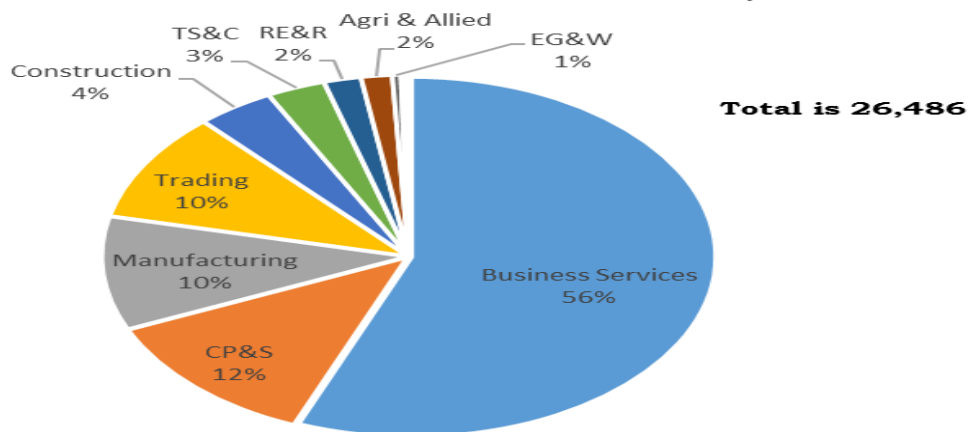

## II. ONE PERSON COMPANY

6. Up to 31<sup>st</sup> December, 2019, a total number of 26,486 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 776.16 crore. Economic activity wise classification of OPCs up to 31<sup>st</sup> December, 2019 reveals that the highest number of OPCs were in Business Services (14,845) followed by Community, Personal & Social Services (3,273), Manufacturing (2,695) and Trading (2,590) (**Chart 2.1**). During the month of December 2019, 809 OPCs were registered with authorized capital of Rs. 27.47 crore. Economic activity wise classification of OPC registered during the month reveals that highest number of 307 OPCs were in Business Services, followed by 159 in manufacturing, 127 in Trading and 119 in Community, personal & Social Services (**Table 2.1**).

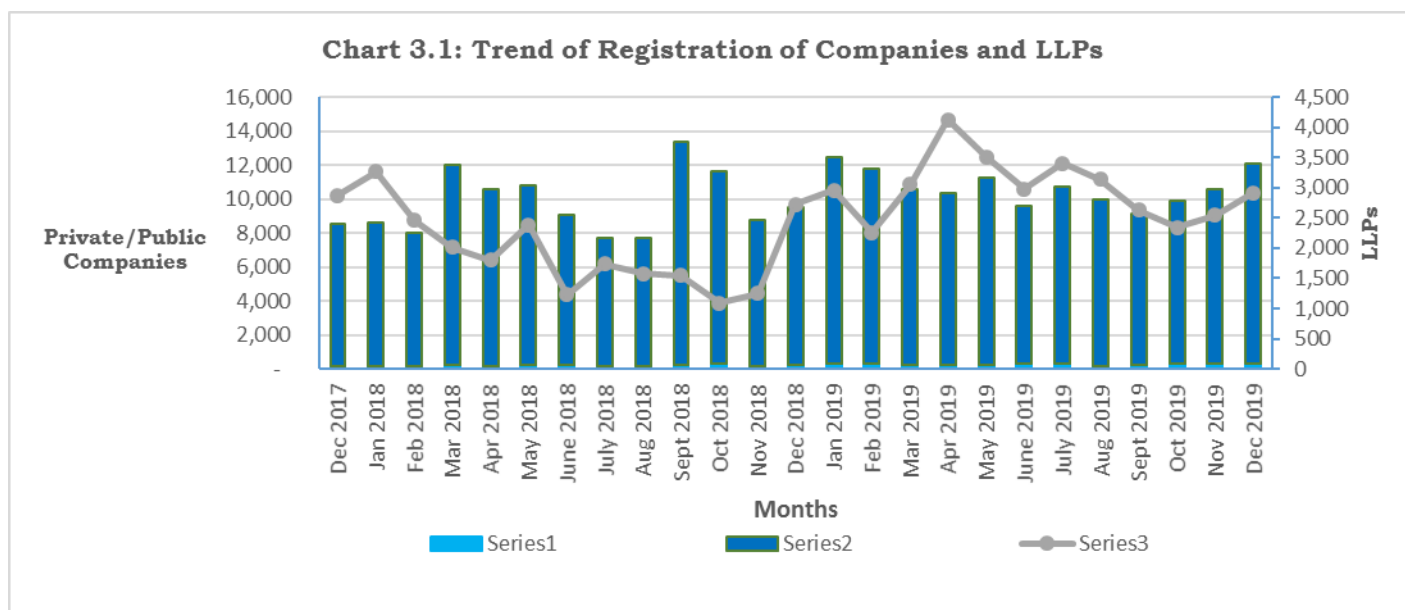
**Chart 2.1: Sector-wise OPC as on 31st December, 2019**

### III. TREND OF REGISTRATION OF NEW COMPANIES

An analysis of registration of new companies during December 2017 to December 2019 shows that monthly registration of companies has increased after hitting lowest of 7,740 Companies in August 2018 (**Chart 3.1**). A total of 12,057 companies were registered in December 2019 as compared to 9,484 in December 2018. An increase (13.7%) in registration of companies has been witnessed in December 2019 over the previous month (**Table 3.1**). A total of 2,916 LLPs were registered in December 2019 as compared to 2,729 LLPs in December 2018 (**Table 3.1**).

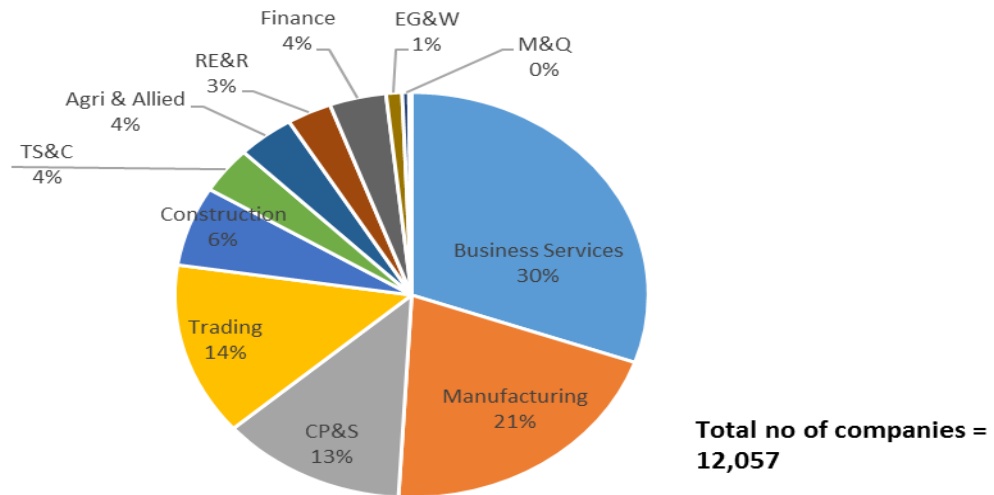


### IV. REGISTRATION OF NEW COMPANIES DURING DECEMBER 2019

8. During the month of December 2019 a total of 12,057 companies were registered with collective authorized capital of Rs. 1,887.21 crore. Of them 11,983 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,887.00 crore; 74 companies were registered as Limited by Guarantee. (**Table-4.1**).

9. Economic-activity wise classification of companies registered during December 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (3,665) followed by Manufacturing (2,471), Trading (1,665), Community, personal & Social Services (1,528), and Construction (767).

**Chart 4.1: Distribution of Companies Registered in December, 2019**



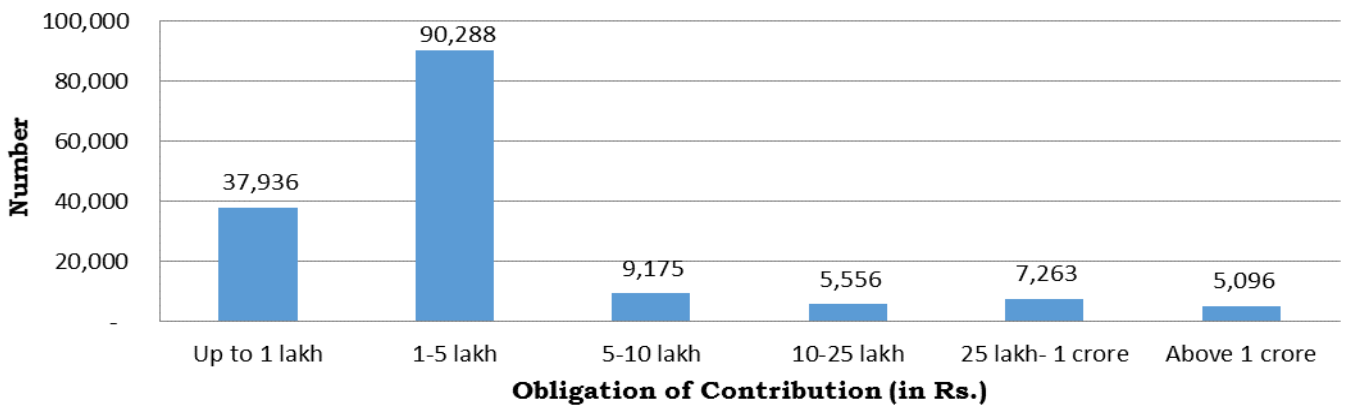

10. In the month of December 2019, out of 12057 newly registered companies, 2,161 (17.92%) companies were registered in Maharashtra, followed by 1,362 (11.30%) in Delhi, and 1,158 (9.60%) in Uttar Pradesh (**Table-4.3**).

**V. Limited Liability Partnerships (LLPs)**

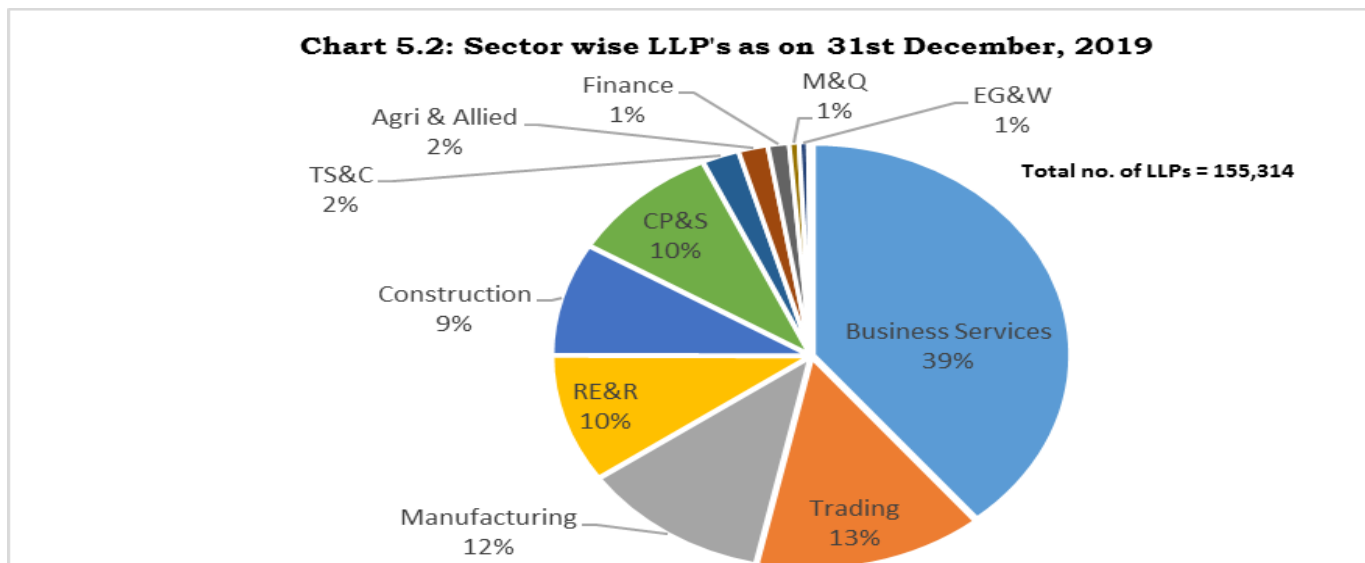
11. As on 31st December 2019, a total number of 155,314 LLPs were active in the country. About 82.56% active LLPs (128,224 in number) have obligation of contribution less than or equal to Rs. 5 lakh each; and only about 3.28% (5,096 in number) of LLPs have obligation of contribution above Rs.1 crore each (**Table-5.1 and Chart 5.1**)

**Chart 5.1: Obligation of Contribution wise distribution of LLPs**



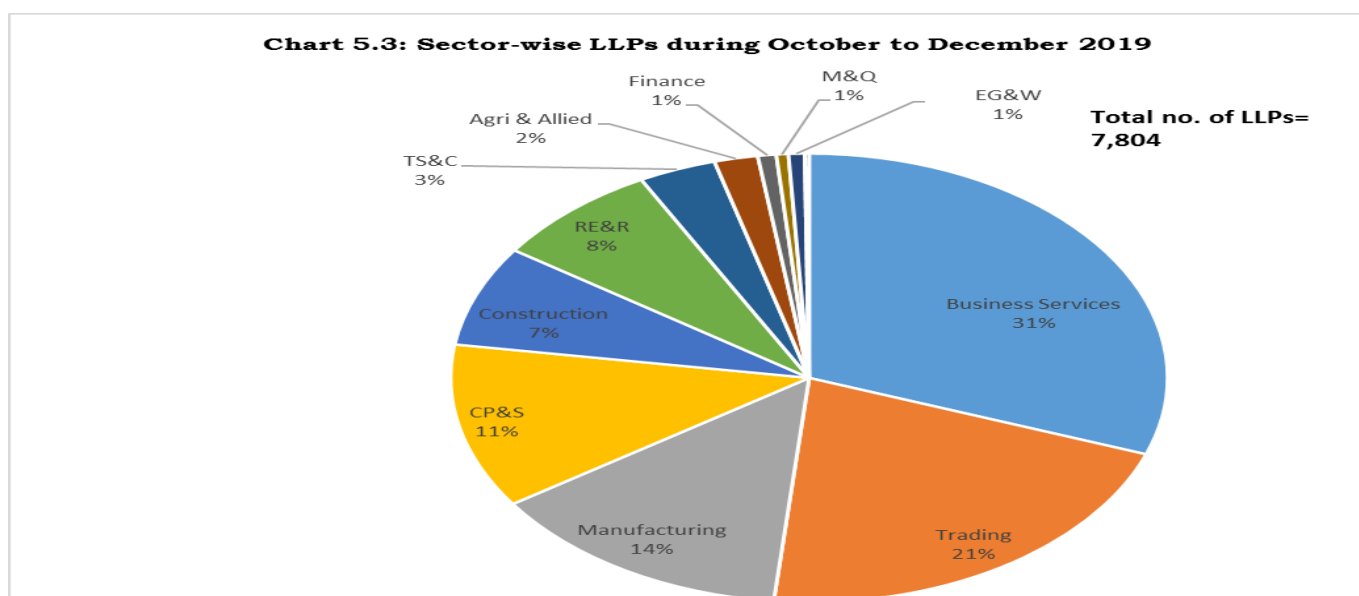
12. Broad economic sector wise classification of active LLPs as on 31st December, 2019 reveals that Service sector account for 118,849 LLPs, followed by Industry and Agriculture sectors accounting for 33,595 and 2,869 LLPs respectively. Economic-activity

wise classification of active LLPs as on 31st December, 2019 further reveals that a large number of LLPs are in Business Services (60,634) followed by Trading (22,341), Manufacturing (18,428) and Real Estate & Renting (15,151) (**Table-5.2 & Chart 5.2**).

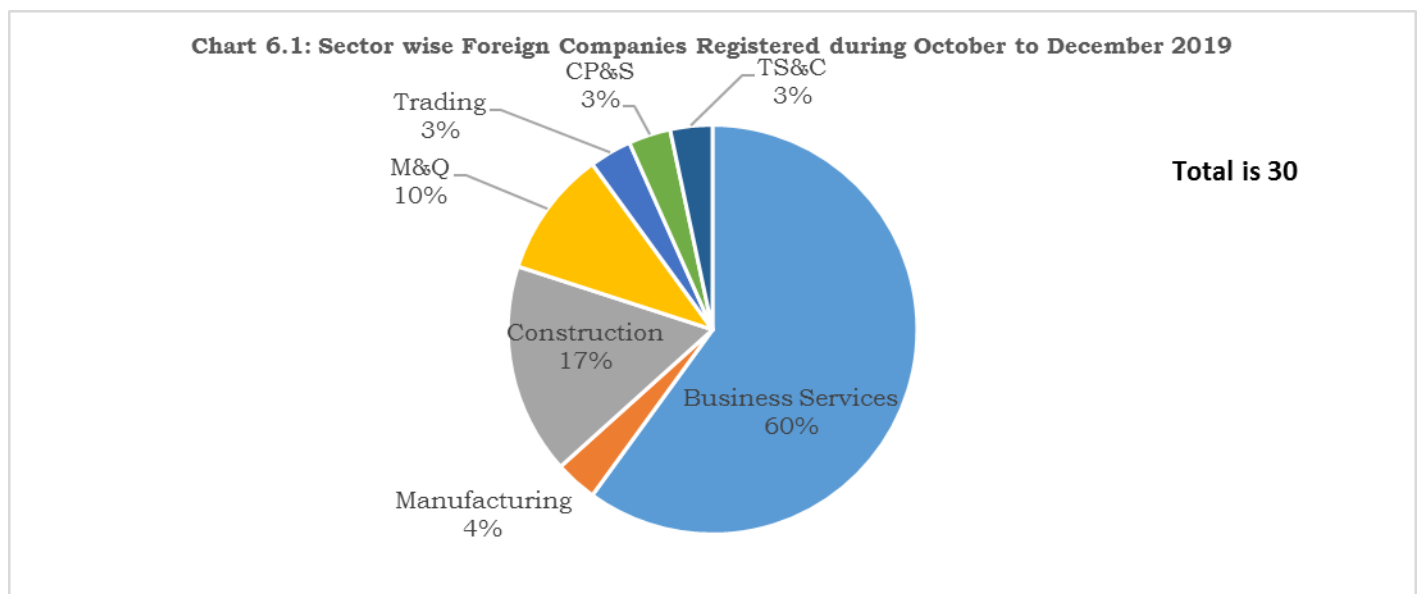
13. During October to December 2019, a total of 7,804 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 954.66 crore. Economic activity wise classification of LLPs during October to December 2019 indicates that highest number of 2,383 LLPs were registered in Business Services followed by 1,642 in Trading, 1,086 in Manufacturing and 928 in Community, Personal and Social Services. (**Table 5.3 and Chart 5.3**).

## VI. FOREIGN COMPANIES

14. As on 31st December 2019, a total of 4,866 foreign companies were registered in India, of which 3,376 were active. During October 2019 to December 2019, a total of 30 foreign companies were registered in India out of them 9 foreign companies have registered offices in Delhi (30%), followed by 7 (23.33%) in Maharashtra and 3 (10%) in Karnataka and Uttar Pradesh each. Economic activity wise classification of foreign companies reveals that 18 were registered in Business Services followed by 5 in Construction, 3 in Mining & Quarrying and 1 in Community, personal & Social Services, in Manufacturing, in Trading and in Transport, storage and Communications each. **(Table 6.1 and chart 6.1).**
