HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st OCTOBER, 2019

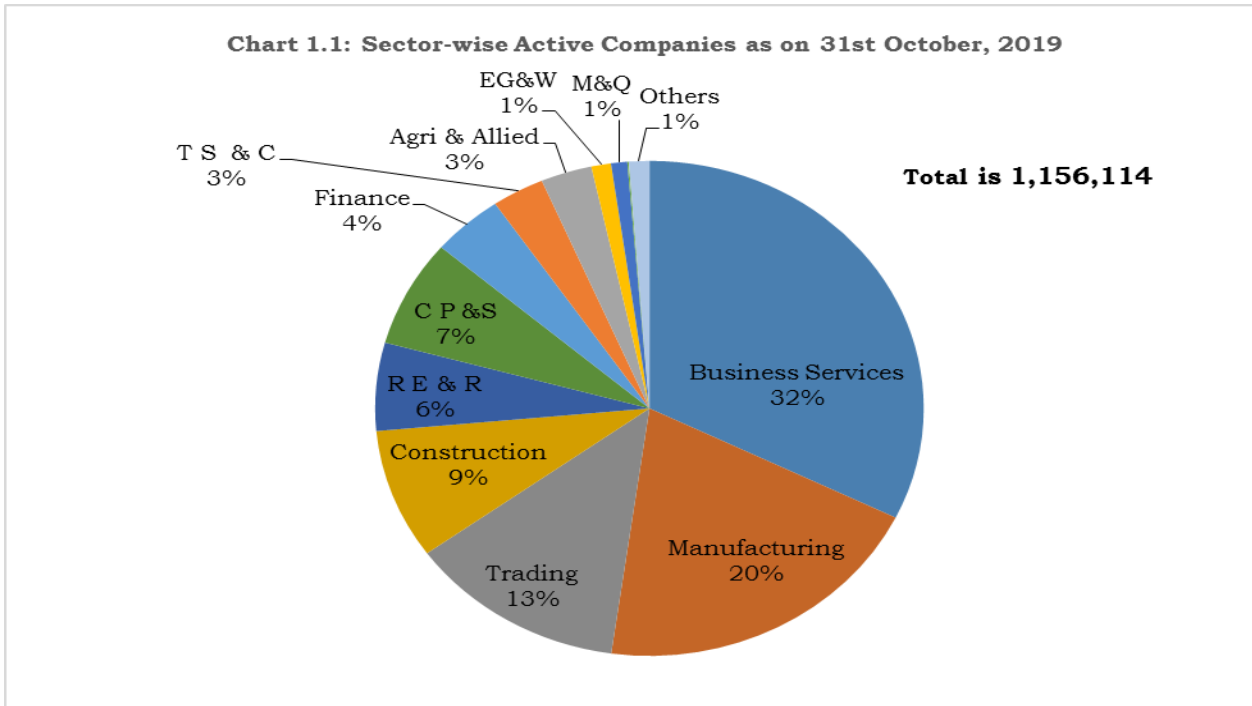
The total number of companies registered in the country as on 31st October, 2019 stood at 1,944,336. Of them 711,366 companies were closed. 2,100 companies were assigned dormant status as per the Companies Act, 2013; 6,453 were under liquidation; 68,232 companies were in the process of being struck-off. After being struck off previously, 71 Companies were in the process of being re-activated. Taking the above into account, there were 1,156,114 active companies as on 31st October, 2019.

1. Out of the 711,366 closed companies, 10,869 companies were liquidated/dissolved; 658,888 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 24,077 companies were amalgamated/ merged with other companies; 12,658 companies were converted to Limited Liability Partnership (LLP) and 4,874 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st October, 2019.

2. Out of the 1,156,114 active companies, 1,148,611 were limited by shares; 7,196 were limited by guarantee and 307 were unlimited companies. Out of the companies limited by shares, 63,081 were public, 1,085,530 were private including 25,125 one person companies. Among the public limited companies, 6,857 were listed (**Table 1.2**).

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (384,130), followed by Delhi (341,579) and West Bengal (204,757). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (225,422), followed by Delhi (199,500) and West Bengal (125,234) as on 31st October, 2019. (**Table-1.3**).

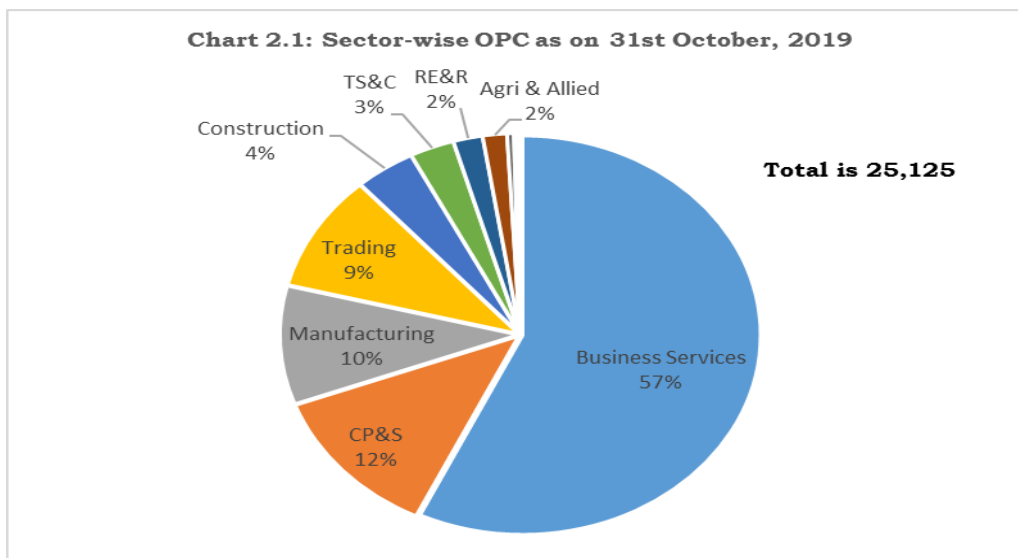
4. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (373,128) followed by Manufacturing (230,718), Trading (148,237) and Construction (98,134). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).



'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, and 'CP&S' is Community, Personal & Social Services, 'RE&R' is Real Estate and Renting, 'EG&W', is Electricity Gas & Water. 13,967 active companies (Others) are having invalid Economic Activity (NIC-2004) Code.

II. ONE PERSON COMPANY

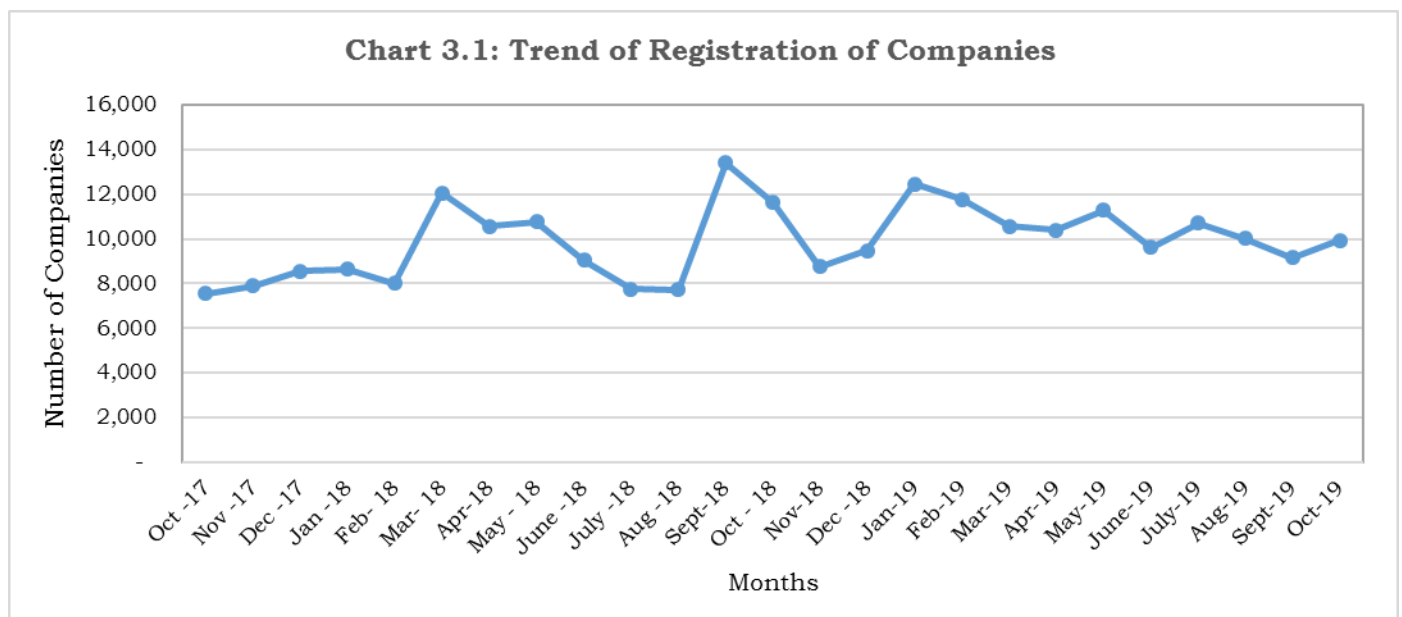
5. Up to 31st October, 2019, a total number of 25,125 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 728.98 crore. Economic activity wise classification of OPCs up to 31st October reveals that the highest number of OPCs were in Business Services (14,343) followed by Community, Personal & Social Services (3,084), Manufacturing (2,410) and Trading (2,375) (**Chart 2.1**). During the month of October 2019, a total of 636 OPC were registered with authorized capital of Rs. 20.99 crore. Economic activity wise classification of OPC during the month reveals that highest number of 237 OPCs were registered in Business Services, followed by 121 in Manufacturing, 95 in Community, personal & Social Services and 90 in Trading. (**Table 2.1**).



'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, personal & Social Services', 'RE&R' is Real Estate and Renting.

III. TREND OF REGISTRATION OF NEW COMPANIES

6. An analysis of registration of new companies during October 2017 to October 2019 indicates that monthly registration of companies has increased after hitting lowest of 7,556 Companies in October 2017 (**Chart 3.1**). A total of 9,933 companies were registered in October 2019 as compared to 11,625 in October 2018. A increase (8.31%) in registration of companies has been witnessed in October 2019 over the previous month (**Table 3.1**).

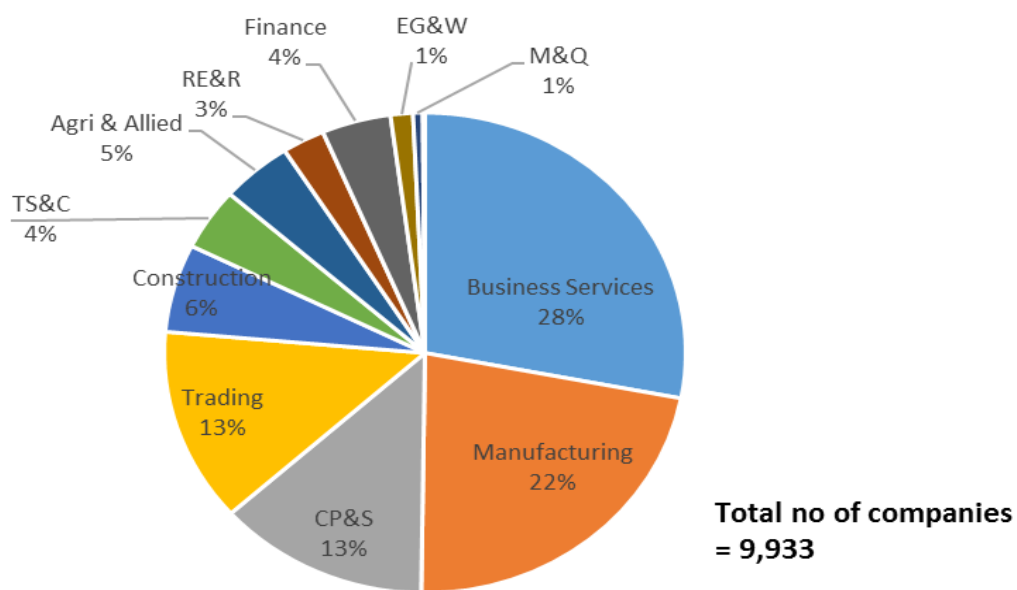


IV. REGISTRATION OF NEW COMPANIES DURING OCTOBER, 2019

7. During the month of October 2019, a total of 9,933 companies were registered with collective authorized capital of Rs. 3106.12 crore. Of them 9,855 companies were registered as Companies Limited by Shares with authorized capital of Rs. 3106.11 crore; (**Table-4.1**).

8. Economic-activity wise classification of companies registered during October 2019 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (2,784) followed by Manufacturing (2,206), Community, personal & Social Services (1,304), Trading (1,296) and Construction (589).

9. During October 2019, 1,834 (18.46%) companies were registered in Maharashtra, followed by 1,193 (12.01%) in Delhi, and 1,031 (10.38%) in Uttar Pradesh **(Table-4.3)**.
