HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th September, 2020

The total number of companies registered in the country as on 30th September, 2020 stood at 2063938. Of them 750929 companies were closed. 2239 companies were assigned dormant status as per the Companies Act, 2013; 6786 were under liquidation; 40160 companies were in the process of being struck-off. Active in progress status is now invalid and companies under this category, lies under Active Status. Taking the above into account, there were 1263824 active companies as on 30th September, 2020.

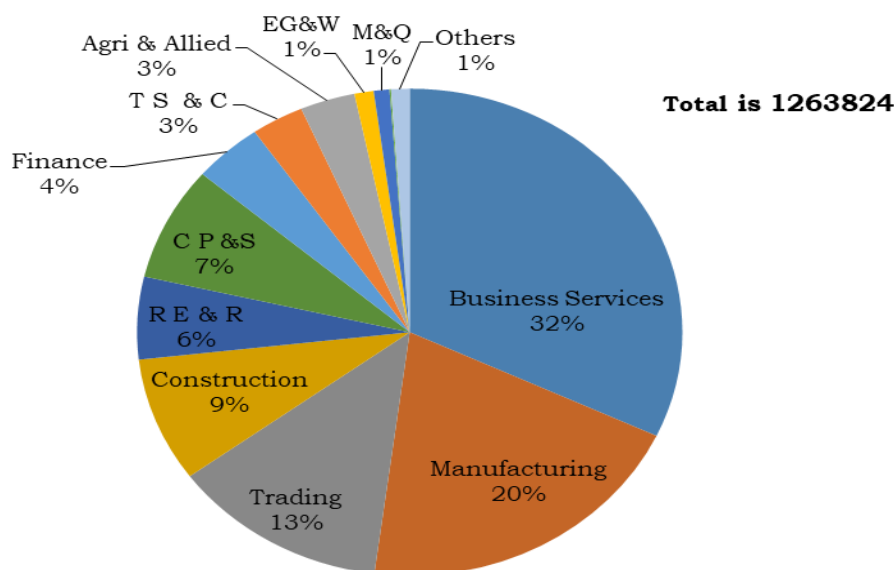
1. Out of the 750929 closed companies, 11002 companies were liquidated/dissolved; 694509 companies were declared defunct (and hence struck-off after issuance of notice u/s 248). 26294 companies were amalgamated/ merged with other companies; 14249 companies were converted to Limited Liability Partnership (LLP) and 4875 were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 30th September, 2020.

2. Out of the 1263824 active companies, 1255725 were limited by shares; 7792 were limited by guarantee and 307 were unlimited companies. Out of the companies limited by shares, 64804 were public, 1159037 were private including 31884 one person companies. Among the public limited companies, 6776 were listed (**Table 1.2**).

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (405273), followed by Delhi (354466) and West Bengal (209957). Amongst 'Active Companies', Maharashtra has the maximum number of active companies (246108), followed by Delhi (209702) and West Bengal (128424) as on 30th September, 2020. (**Table-1.3**).

4. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (404350) followed by Manufacturing (253801), Trading (162445) and Construction (104551). Business Services comprise of Information Technology, Research & Development and other business activities such as law, audit & accounts and consultancy, etc. (**Table-1.4 and Chart 1.1**).

Chart 1.1: Sector-wise Active Companies as on 30th September, 2020

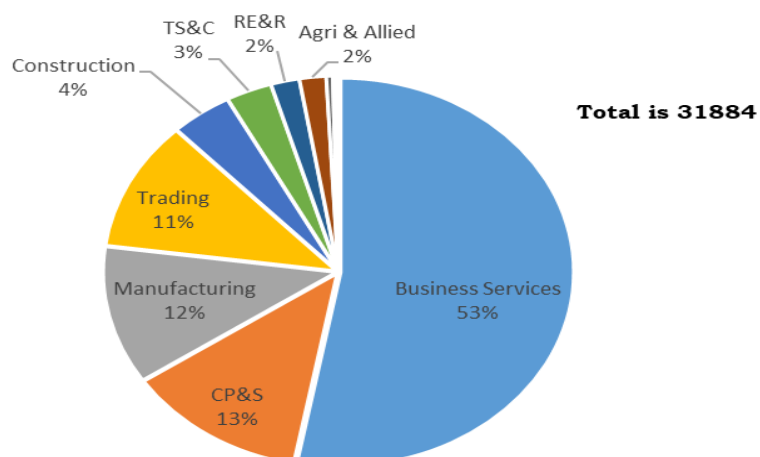

II. ONE PERSON COMPANY

5. Up to 30th September, 2020, a total number of 31884 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 990.12 crores. Economic activity wise classification of OPCs up to 30th September reveals that the highest number of OPCs were in Business Services (16900) followed by Community, Personal & Social Services (4018), Manufacturing (3669) and Trading (3443) (**Chart 2.1**). During the month of September, 2020, a total of 945 OPC were registered with authorized capital of Rs. 33.44 crores. Economic activity wise classification of OPC during the month reveals that highest number of 353 OPCs were registered in Business Services, followed by 198 in Manufacturing, 163 in Trading and 100 in Community, personal & Social Services. 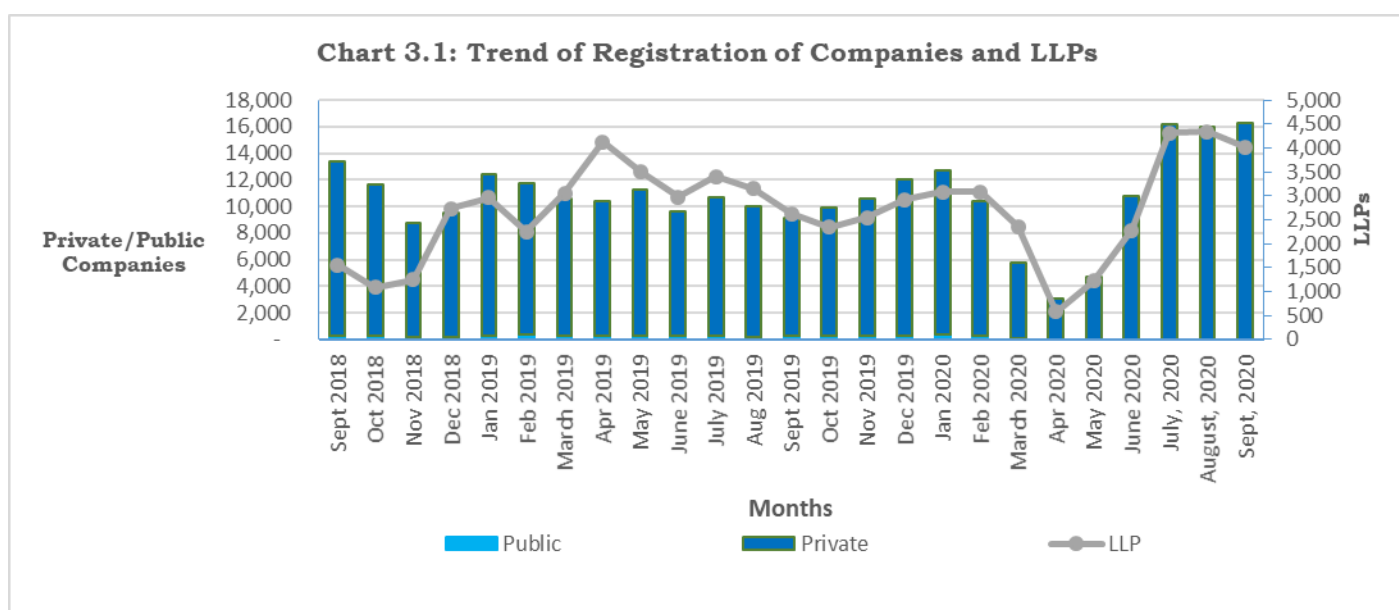
Chart 2.1: Sector-wise OPC as on 30th September, 2020

III. TREND OF REGISTRATION OF NEW COMPANIES

6. An analysis of registration of new companies during September 2018 to September 2020 indicates that monthly registration of companies has increased after hitting lowest of 3,209 Companies in April 2020 (**Chart 3.1**). A total of 16641 companies were registered in September, 2020 as compared to 9171 in September 2019. An increase (2.3%) in registration of companies has been witnessed in September 2020 over the previous month (**Table 3.1**). A total of 4016 LLPs were registered in September 2020 as compared to 2627 LLPs in September 2019 (**Table 3.1**).

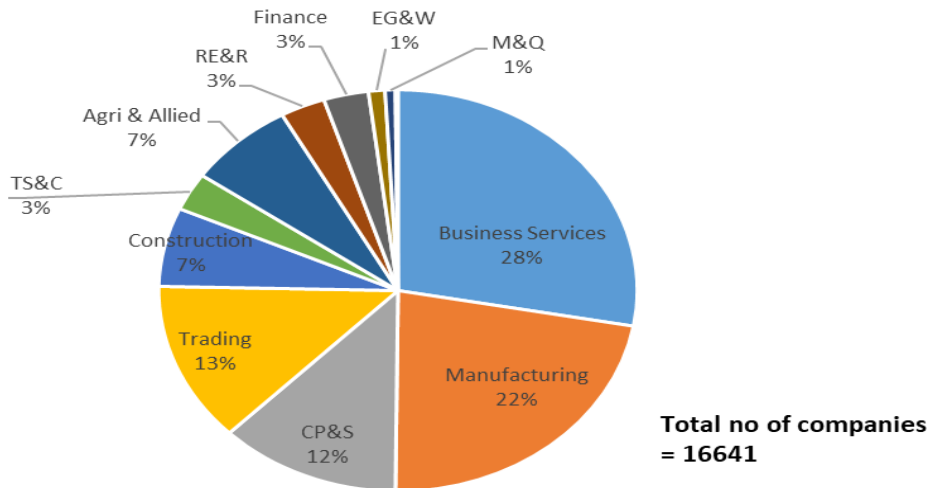


IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER, 2020

7. During the month of September 2020, a total of 16641 companies were registered with collective authorized capital of Rs. 1,680.82 crores. Of them 16545 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,680.55 crores; (**Table-4.1**).

8. Economic-activity wise classification of companies registered during September 2020 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies is in Business Services (4632) followed by Manufacturing (3717), Trading (2145), Community, personal & Social Services (2043) and Construction (1057).

Chart 4.1: Distribution of Companies Registered in September, 2020



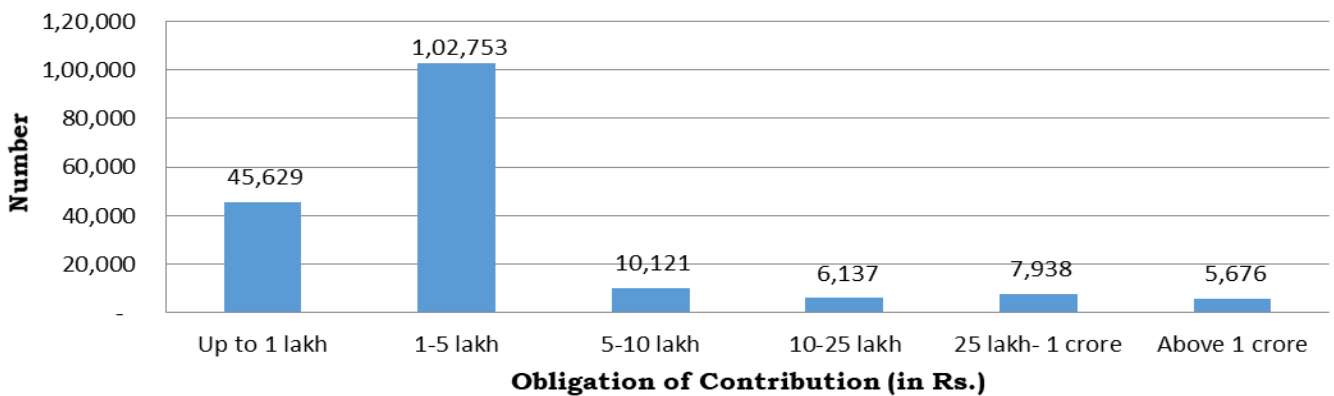

9. During September, 2020, 2992 (17.98%) companies were registered in Maharashtra, followed by 1746 (10.49%) in Uttar Pradesh and 1725 (10.37%) in Delhi. **(Table-4.3).**

V. Limited Liability Partnerships (LLPs)

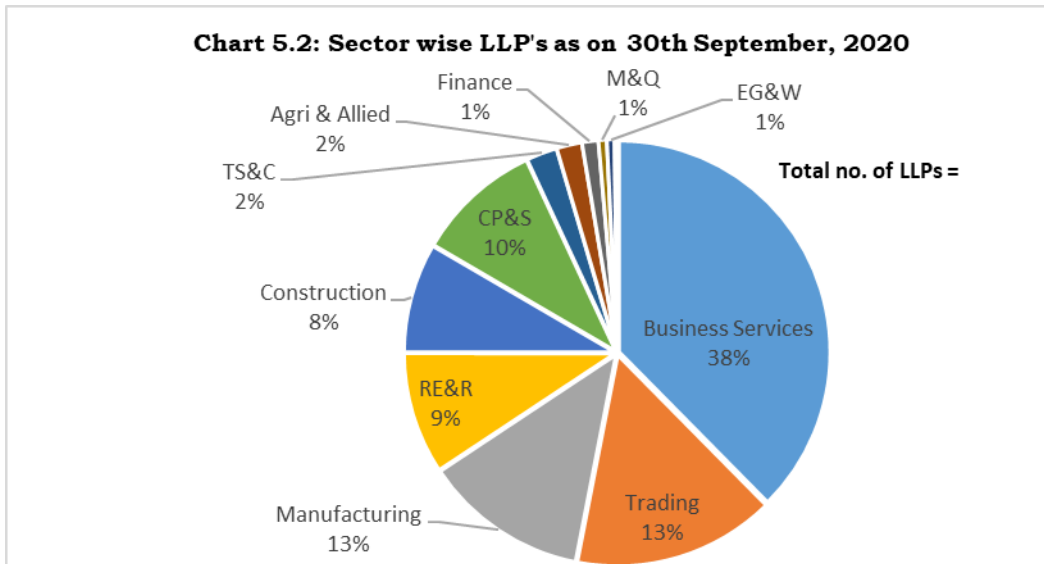
10. As on 30th September 2020, a total number of 178254 LLPs were active in the country. About 83.24% active LLPs (148382 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each; and only about 3.18% (5676 in number) of LLPs have obligation of contribution above Rs.1 crore each **(Table-5.1 and Chart 5.1)**

Chart 5.1: Obligation of Contribution wise distribution of LLPs



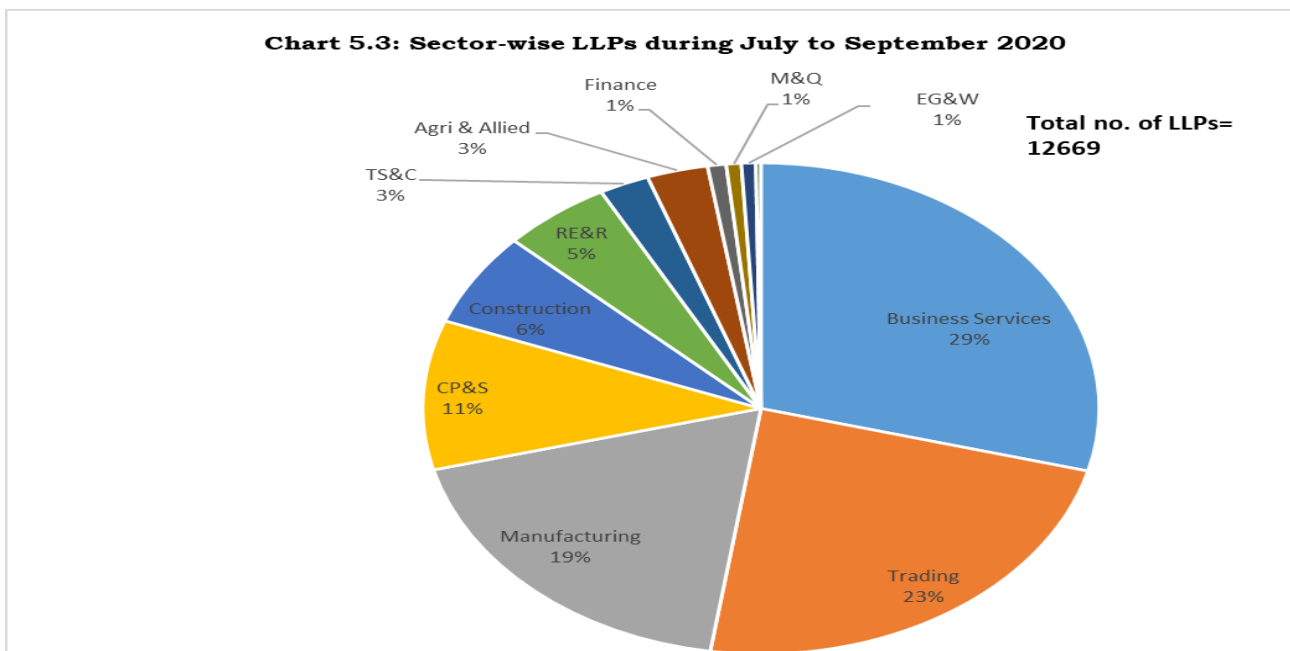
11. Broad economic sector wise classification of active LLPs as on 30th September, 2020 reveals that Service sector account for 135201 LLPs, followed by Industry and

Agriculture sectors accounting for 39601 and 3451 respectively. Economic-activity wise classification of active LLPs as on 30th September, 2020 further reveals that a large number of LLPs are in Business Services (67008) followed by Trading (27605), Manufacturing (22485) and Real Estate & Renting (16618) (**Table-5.2 & Chart 5.2**).



'EG&W' is Electricity, Gas and Water, 'M&Q' is Mining & Quarrying, 'TS&C' is Transport, Storage and Communication, 'CP&S' is 'Community, Personal & Social Services', 'RE&R' is Real Estate and Renting.

12. During July to September 2020, a total of 12669 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 2870.99 crore. Economic activity wise classification of LLPs during July to September 2020 indicates that highest number of 3687 LLPs were registered in Business Services followed by 2951 in Trading, 2354 in Manufacturing and 1246 in Community, Personal and Social Services. (**Table 5.3 and Chart 5.3**).



VI. FOREIGN COMPANIES

13. As on 30th September 2020, a total of 4940 foreign companies were registered in India, of which 3378 were active. During July 2020 to September 2020, a total of 31 foreign companies were registered in India, including 13 in Maharashtra, followed by 5 in Delhi, 3 each in Gujarat and Tamil Nadu and 1 each in Andhra Pradesh, Haryana, Rajasthan and Uttar Pradesh. Economic activity wise classification of foreign companies reveals that highest number of 16 were registered in Business Services followed by 4 in Construction, 3 in Manufacturing, and 2 in Mining and Quarrying. **(Table 6.1 and chart 6.1).**

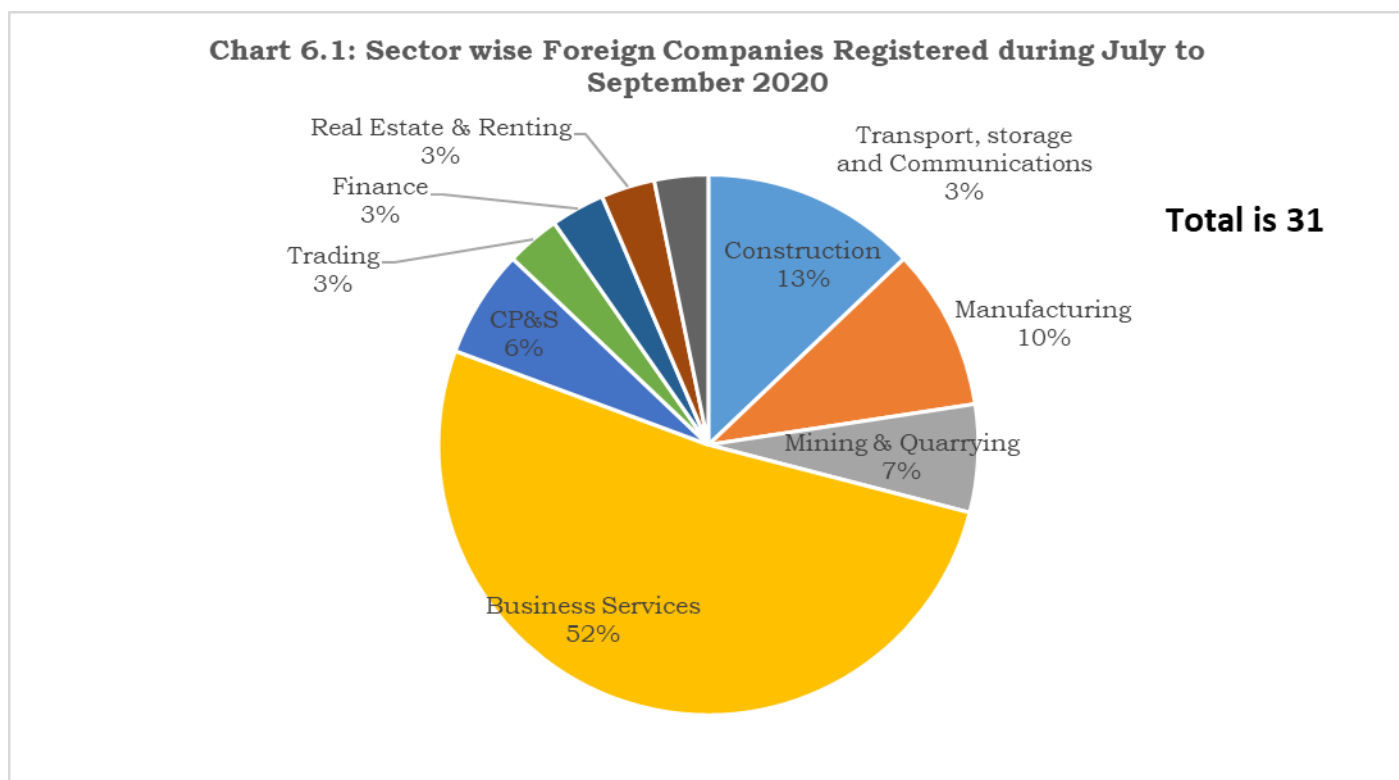
