HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st MARCH 2018

1. The total number of companies registered in the country as on 31st March 2018 stood at 1,749,359. Of them, 540,487 companies were closed; 1,253 companies were assigned dormant status as per the Companies Act, 2013; 2 companies have not filed their annual statutory filings for 2 years consecutively; 6,014 companies were under liquidation; 33,637 companies were in the process of being struck-off and 108 companies were in the process of being re-activated. Taking the above into account, there were 1,167,858 active companies as on 31st March 2018.

2. Out of the 540,487 closed companies, about 10,516 companies were liquidated/dissolved; 496,319 companies were defunct (and hence struck-off); 20,783 companies were amalgamated/merged with other companies; 8,075 companies were converted to LLP; 4,794 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31st March 2018.

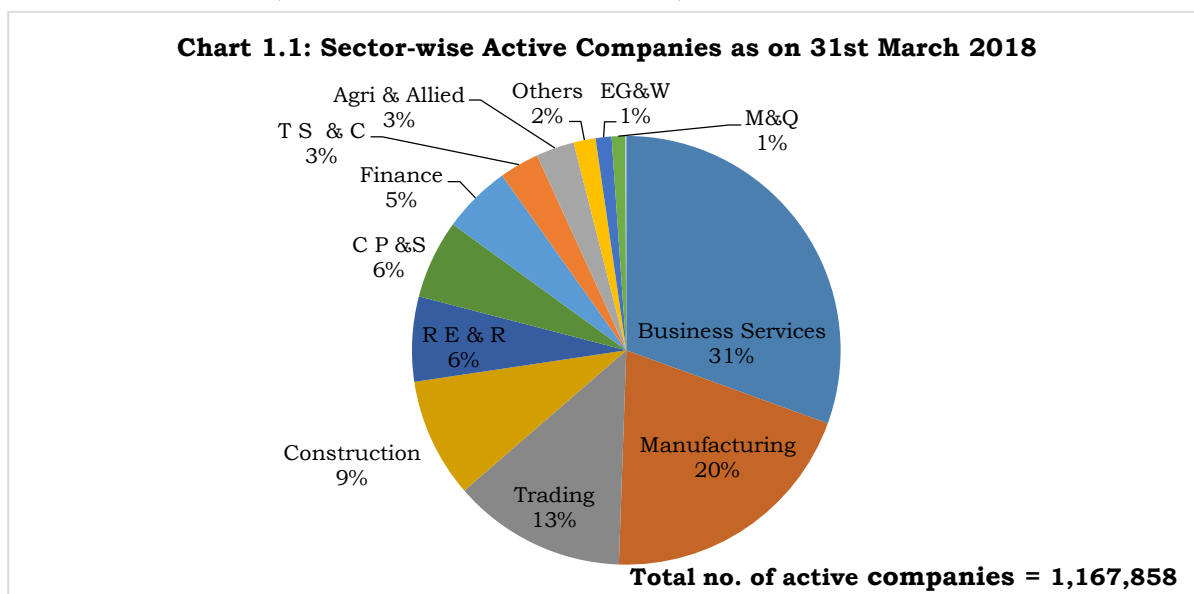
3. Out of the 1,159,945 active companies limited by shares; 1,088,657 were Private and 71,288 were Public companies, segregated into 7,239 Listed and 64,049 Unlisted Companies and 16,713 were One Person Companies. (**Table 1.2**).

4. Authorized Capital wise distribution of active companies as on 31st March 2018 (**Table-1.3**) indicates that about 67.06% of companies (783,108 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.26% of companies (26,431 in number) have authorized capital of above Rs.10 crore each.

5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (347,857), followed by Delhi (317,998) and West Bengal (196,724). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (230,134), followed by Delhi (212,867) and West Bengal (134,638) as on 31st March 2018 (**Table-1.4**).

6. Economic-activity wise classification of active companies reveals that highest number of companies were in Business Services (356,654), followed by Manufacturing (233,736), Trading (152,840) and Construction (105,162).

Business Services comprise of Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.5 and Chart 1.1**).



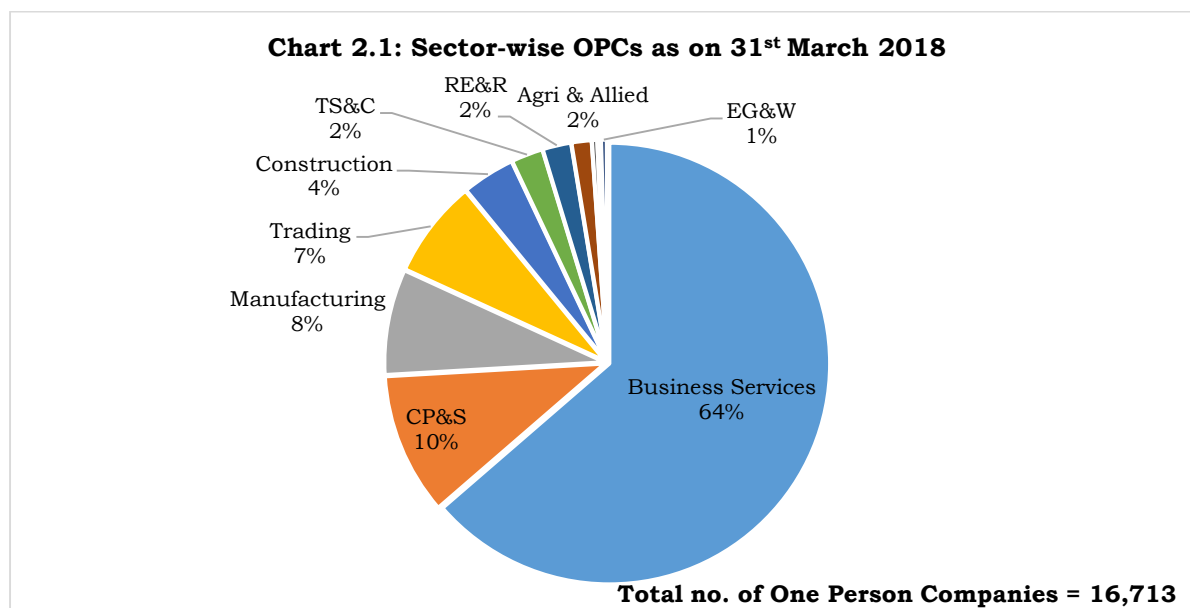

II. ONE PERSON COMPANY

7. Up to 31st March 2018, a total number of 16,713 One Person Companies (OPCs) were registered with collective authorized capital of Rs. 401.30 crore. Economic activity wise classification of OPCs up to 31st March 2018 reveals that highest number of OPCs were in Business Services (10,638), followed by Community, Personal & Social Services (1,742), Manufacturing (1,298) and Trading (1,206) (**Chart 2.1**). During the financial year 2017-18 (i.e from 1st April 2017 to 31st March 2018), a total of 5,926 OPCs were registered in India. Maharashtra has registered 1,032 (17.41%) OPCs, followed by Delhi with 789 (13.31%) (**Table 7.2**). Economic activity wise classification of OPCs reveals that highest number of 4,043 were registered in Business Services, followed by 543 in Community, Personal & Social Services and 425 in Manufacturing (**Table 2.1**).

8. During the month of March 2018, a total of 609 OPCs were registered with authorized capital of Rs. 16.89 crore. Economic activity wise classification of OPCs during the month reveals that highest number of 432 OPCs were registered in Business Services, followed by 49 in Community, Personal & Social Services and 41 in Trading (**Table 2.1**). Highest number of 101 OPCs were registered in Maharashtra (16.58%), followed by 78 in Karnataka (12.81%) and 71 in Delhi (11.66%) during the month of March 2018 (**Table-**

7.2).

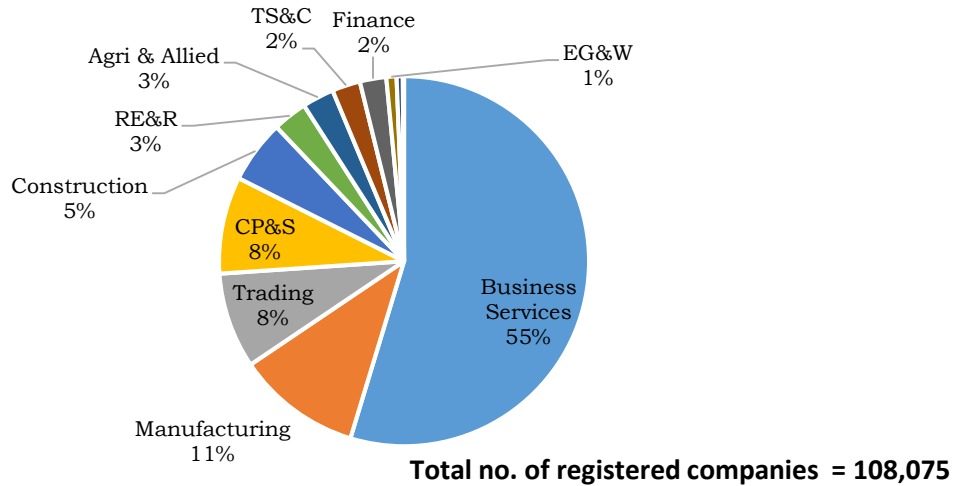
III. REGISTRATION OF COMPANIES DURING FY 2017-18

9. During the financial year 2017-18 (i.e., from 1st April 2017 to 31st March 2018), a total of 108,075 companies were registered with collective authorized capital of Rs. 39,091.46 crore. Of them, 107,697 Companies were registered as Companies Limited by Shares with authorized capital of Rs. 39,087.85 crore; 378 Companies Limited by Guarantees with authorized capital of Rs. 3.61 crore. (**Table 3.1**).

10. During the financial year 2017-18, Maharashtra has 19,467 (18.01%) newly registered companies, followed by Delhi with 15,861(14.68%) and Uttar Pradesh with 10,486 (9.70 %) companies (**Table 3.2**).

11. Economic-activity wise classification of companies registered during the financial year 2017-18(**Table 3.3 and Chart 3.1**) reveals that the predominant share of companies were in Business Services (59,099), followed by Manufacturing (11,758), Community, Personal & Social Services (9,165), and Trading (9,040).

Chart 3.1: Sector-wise distribution of Companies registered in FY 2017-2018



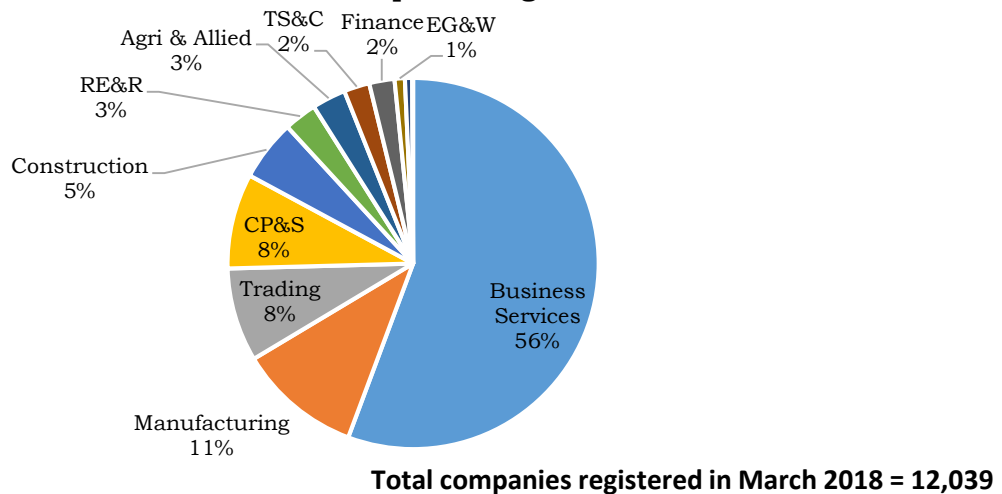

IV. REGISTRATION OF NEW COMPANIES DURING MARCH 2018

12. During the month of March 2018, a total of 12,039 companies were registered with collective authorized capital of Rs. 3,277.98 crore. Of them, 11,995 companies were registered as Companies Limited by Shares with authorized capital of Rs. 3,277.98 crore and 44 companies were registered as Limited by Guarantees with zero authorized capital (**Table-4.1**).

13. Economic-activity wise classification of companies registered during March, 2018 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies were in Business Services (6,704), followed by Manufacturing (1,292), Community, Personal & Social Services (998), Trading (982) and Construction (638).

Chart 4.1: Distribution of Companies Registered in March 2018

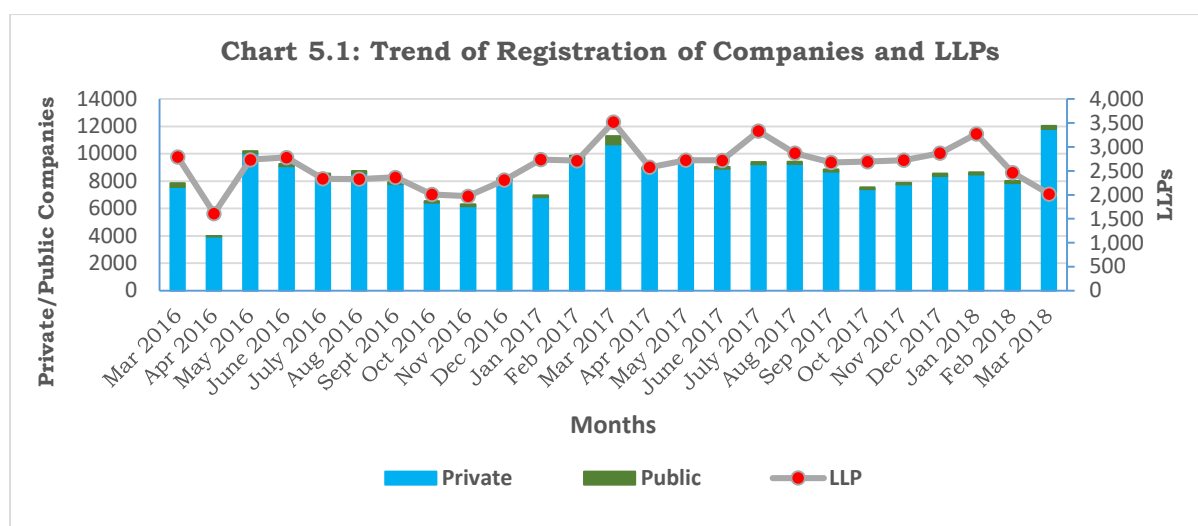

14. During March 2018, 2,177 (18.08%) companies were registered in Maharashtra, followed by 1,551 (12.88%) in Delhi, and 1,136 (9.44%) in Karnataka (**Table-4.3**).

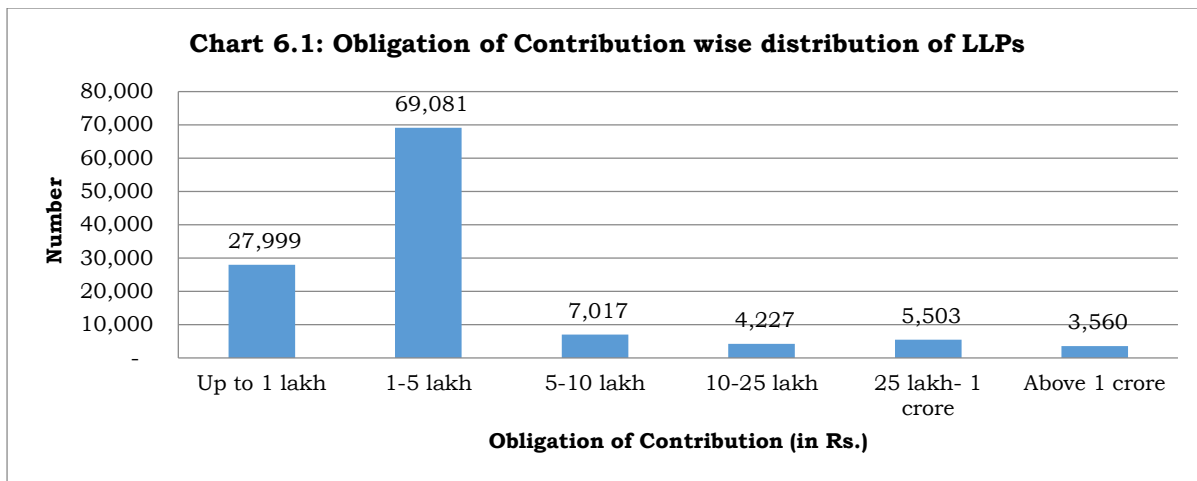
V. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

15. An analysis of registration of new companies during March 2016 to March 2018 indicates that monthly registration of companies has increased after hitting its lowest of 3,994 in April 2016 (**Chart 5.1**). A total of 12,039 companies were registered in March 2018 as compared to 11,293 in March 2017. A significant increase (50.28%) in registration of companies has been witnessed in March 2018 over the previous month. A total of 2,019 LLPs were registered in March 2018 as compared to 3,518 in March 2017 (**Table 5.1**).

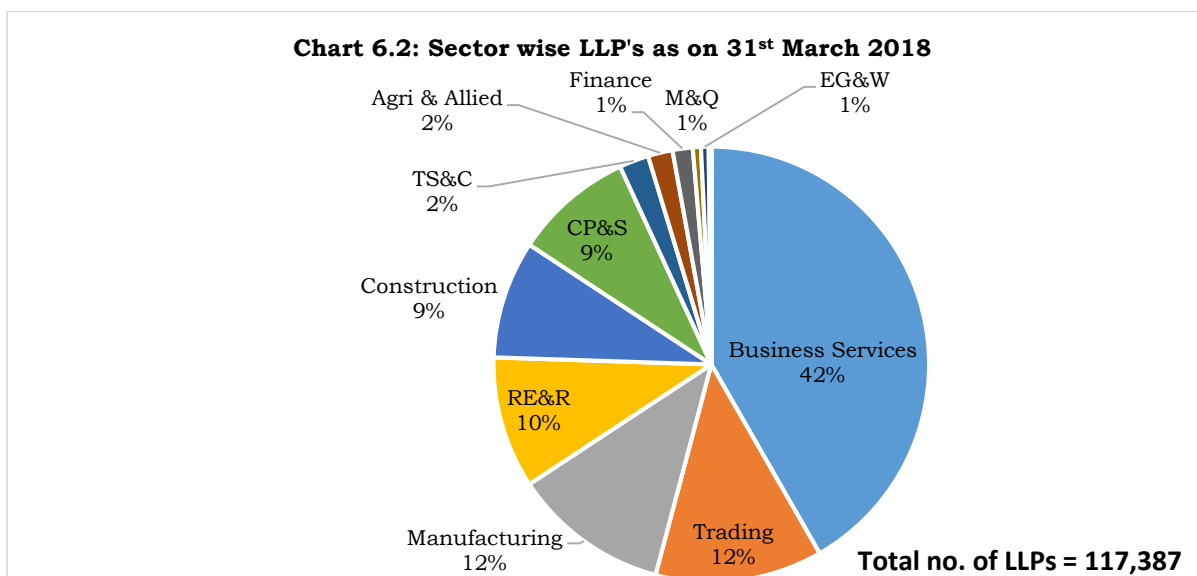


VI. Limited Liability Partnerships (LLP)

16. As on 31st March 2018, a total number of 121,481 LLPs were registered in the country, of which 117,387 were active. About 82.70% active LLPs (97,080 in number) have obligation of contribution less than or equal to Rs. 5 lakhs each and only about 3.03% (3,560 in number) of LLPs have obligation of contribution above Rs.1crore each (**Table-6.1 and Chart 6.1**)



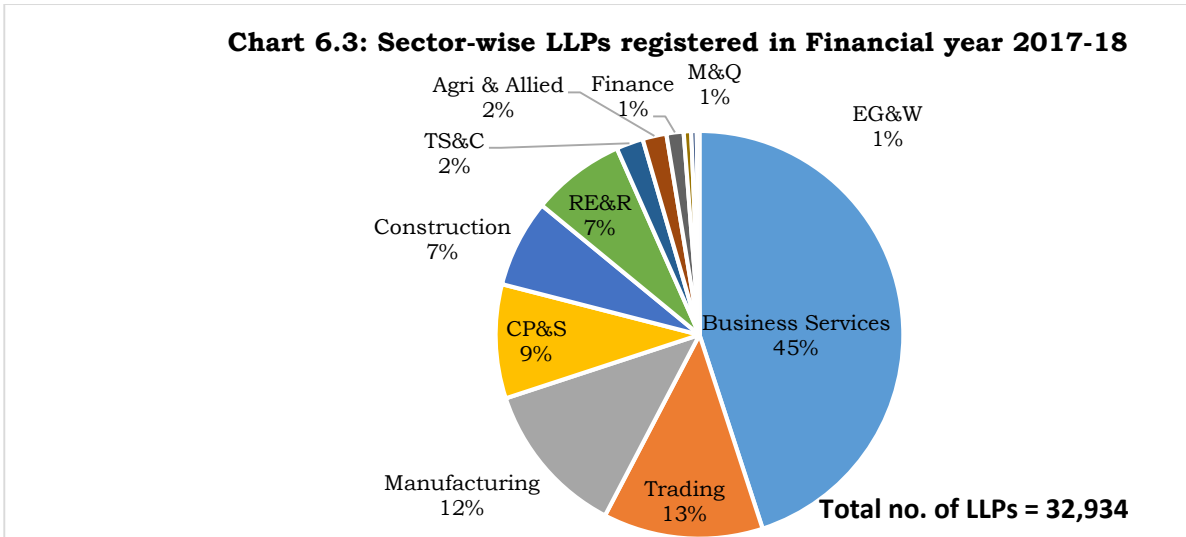
17. Broad economic sector wise classification of active LLPs as on 31st March 2018 reveals that Service sector account for 89,969 LLPs, followed by Industry and Agriculture sectors accounting for 25,267 and 2,149 respectively. Economic-activity wise classification of active LLPs as on 31st March 2018 reveals that a large number of LLPs were in Business Services (48,964), followed by Trading (14,570), Manufacturing (13,629) and Real Estate & Renting (11,485)(**Table-6.2 & Chart 6.2**).

VII. Registration of LLPs during FY 2017-18:

18. During the financial year 2017-18 (i.e., from 1st April 2017 to 31st March 2018), a total of 32,934 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 5,545.15 crore. Economic activity wise classification of LLPs during the financial year 2017-18 indicates that highest number of 14,816 LLPs were registered in Business Services, followed by 4,176 in Trading and 4,048 in Manufacturing (**Table 6.3 & Chart 6.3**).

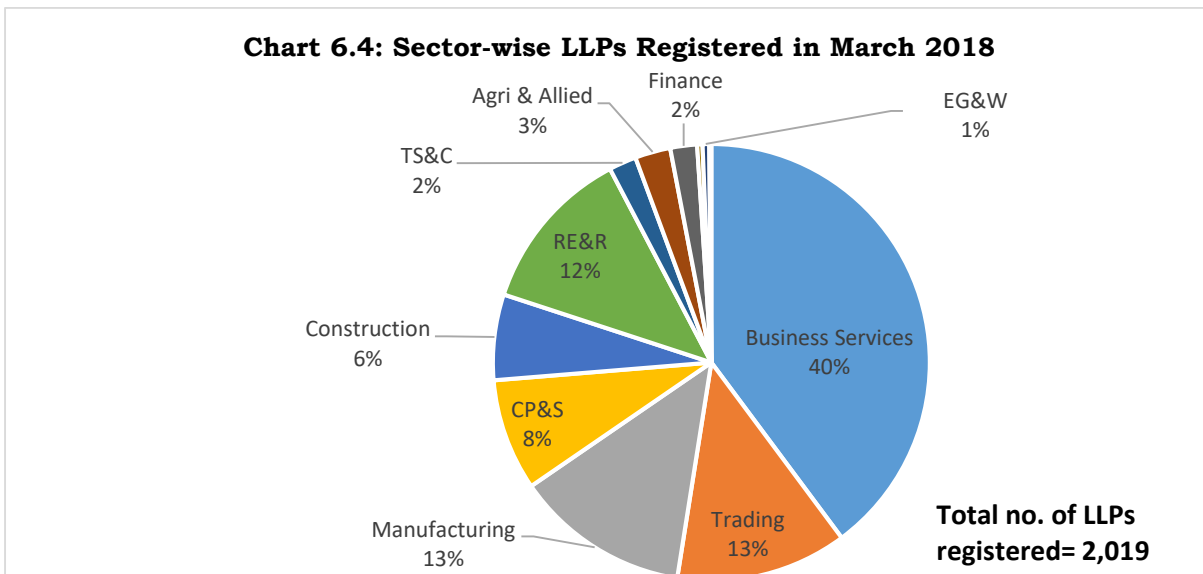

19. Maharashtra has 10,294 (31.26 %) newly LLPs registered, followed by Delhi with 4,170 (12.66 %), and Gujarat with 3,132 (9.51 %) during the financial year 2017-18 (**Table 7.2**).

VIII. Registration of LLPs during March 2018:

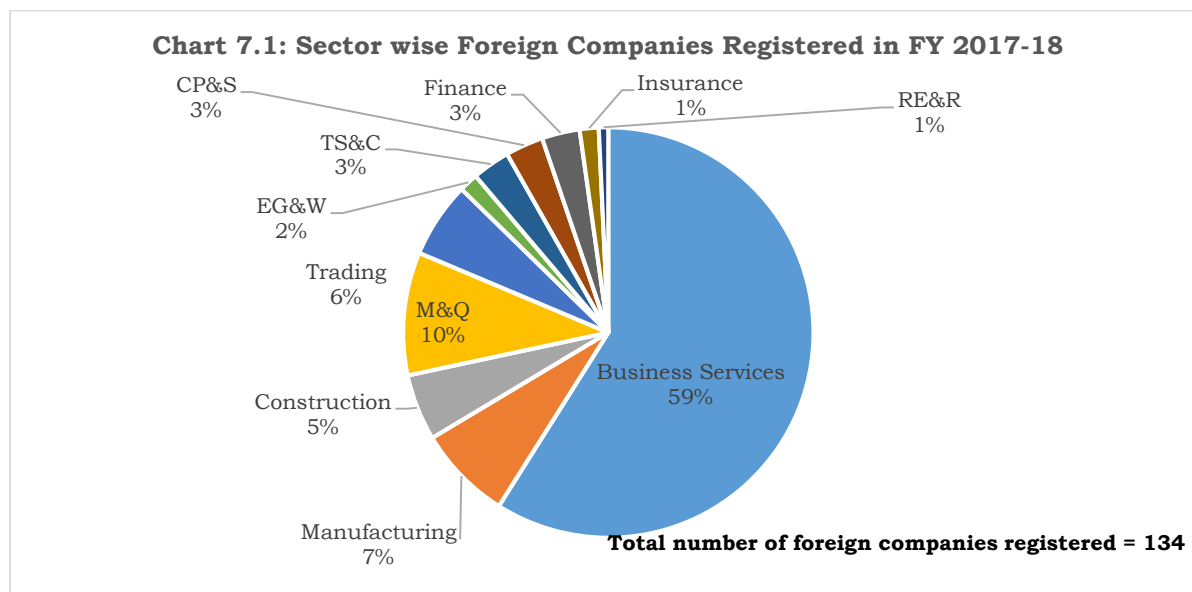
20. A total of 2,019 Limited Liability Partnerships (LLPs) were registered during March 2018 with collective obligation of contribution of Rs. 887.98 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 804 LLPs were registered in Business Services, followed by 261 in Manufacturing and 256 in Trading (**Table-6.4 and Chart 6.4**). Highest number of 578 LLPs were registered in Maharashtra (28.63%), followed by 297 in West Bengal (14.71%) during the month of March 2018 (**Table-7.2**).

IX. Foreign Companies

21. As on 31st March 2018, a total of 4,653 foreign companies were doing business in India, of which 3,372 were active. During the financial year 2017-18, a total of 134 foreign companies were registered in India including 37 (27.61 %) in Maharashtra, followed by 29 (21.64 %) in Delhi and 19 (14.18%) in Haryana (**Table 7.2**). Economic activity wise classification of foreign companies reveals that highest number of 79 were registered in Business Services, followed by 13 in Mining & Quarrying and 10 in Manufacturing (**Table 7.1 and Chart 7.1**).

22. During the month of March 2018, 7 foreign companies were registered in India with 2 in Delhi, and 1 each in Andhra Pradesh, Haryana, Punjab, Tamil Nadu and Uttar Pradesh. Of these 7 foreign companies, 4 were registered under Business Services and 1 each under Mining & Quarrying, Electricity, Gas & Water and Construction. (**Table 7.2**).
