HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31ST DECEMBER, 2013

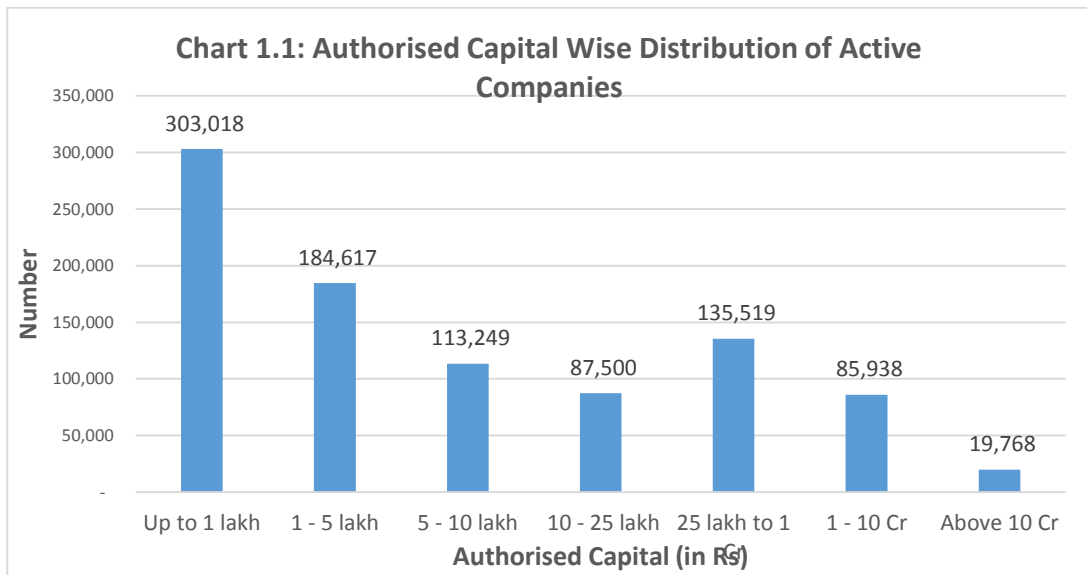
1. The total number of companies registered in the country as on 31st December, 2013, stood at 13,69,362. Of them, 2,67,639 companies were closed; 1,43,346 companies were lying dormant; 5,041 companies were under liquidation; 23,450 companies were in the process of being struck-off and 277 companies were in the process of being re-activated. Taking the above into account, there were 9,29,609 active companies (companies at work) as on 31st December, 2013. **Table-1.1** presents the summary picture of companies as on 31st December, 2013.

2. Out of 2,67,639 closed companies on 31.12.2013, about 10,189 companies were liquidated/dissolved; 2,42,627 companies were defunct (and hence struck-off); 13,412 companies were amalgamated/merged with other companies; 1,411 companies were converted to LLP. **Table-1.2** presents a summary of closed companies as on 31st December, 2013.

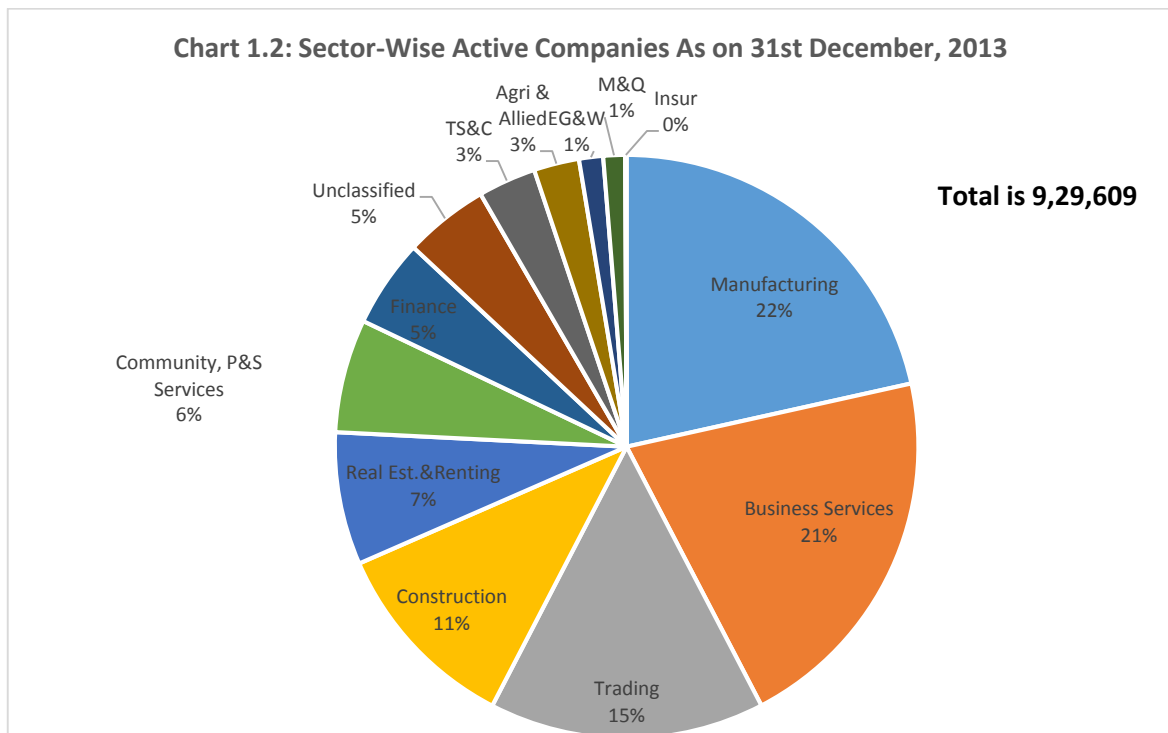
3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,78,837), followed by Delhi (2,57,134) and West Bengal (1,78,906). **Table-1.3** presents State/UT-wise distribution of registered companies as on 31st December, 2013. Maharashtra, Delhi and West Bengal together account for more than 50% of companies in the country. Amongst 'Active Companies', Delhi has the maximum number of active companies (1,85,543), followed by Maharashtra (1,84,827) and West Bengal (1,31,388).

4. About 32% of the active companies have authorized capital of less than or equal to Rs. 1 Lakh each; about 52% active companies have authorised capital less than or equal Rs. 5 Lakh each; 64.6% of companies have authorised capital less than or equal to Rs. 10 lakh each; and about 88.6% of the active companies have authorized capital less than or equal to Rs. 1

Crore each. Only about 2.1% (19,768 in number) of companies have authorized capital of above Rs.10 crore each. **(Table-1.4 and Chart 1.1)**

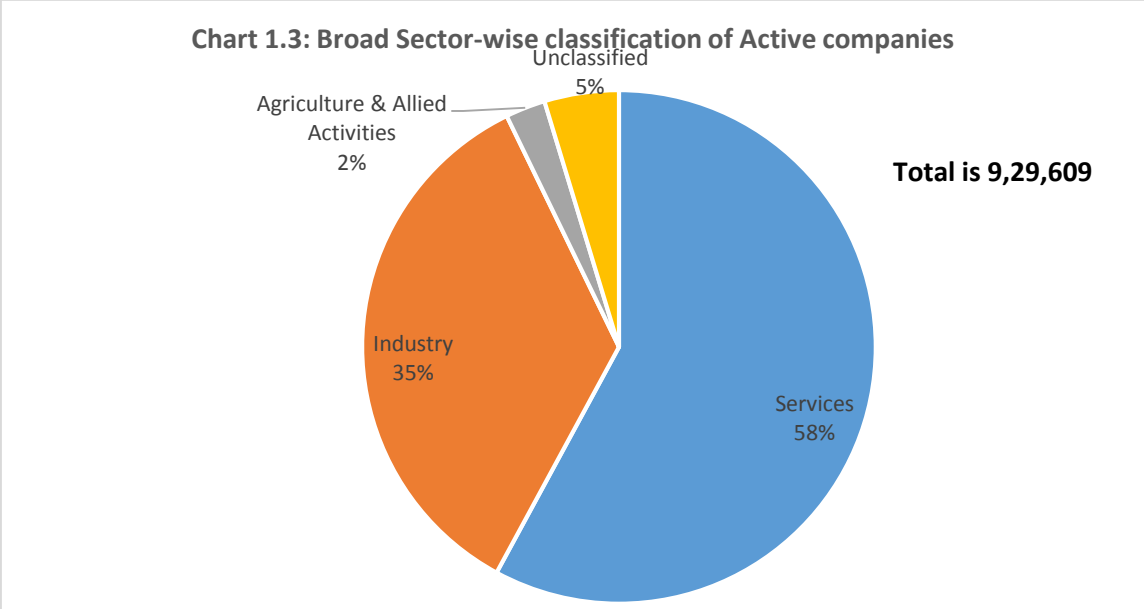


5. Economic-activity wise classification of total active companies as on 31st December, 2013 **(Table-1.5 and Chart 1.2)** reveals that the large number of companies are in manufacturing (2,00,048) followed by Business Services (1,93,700), Trading (1,41,865) and Construction (1,00,680).



'MQ' is Mining & Quarrying, EG&W is Electricity, Gas and Water, 'TS&C' is Transport, Storage and Communication. About 43,604 active companies (unclassified category) are having invalid Economic Activity (NIC-2004) Code.

6. Broad economic sector wise classification of total active companies as on 31st December, 2013 reveals that Service Sector account for 5,38,337 companies followed by Industry and Agriculture accounting for 3,24,316 and 23,352 respectively (**Chart 1.3**).

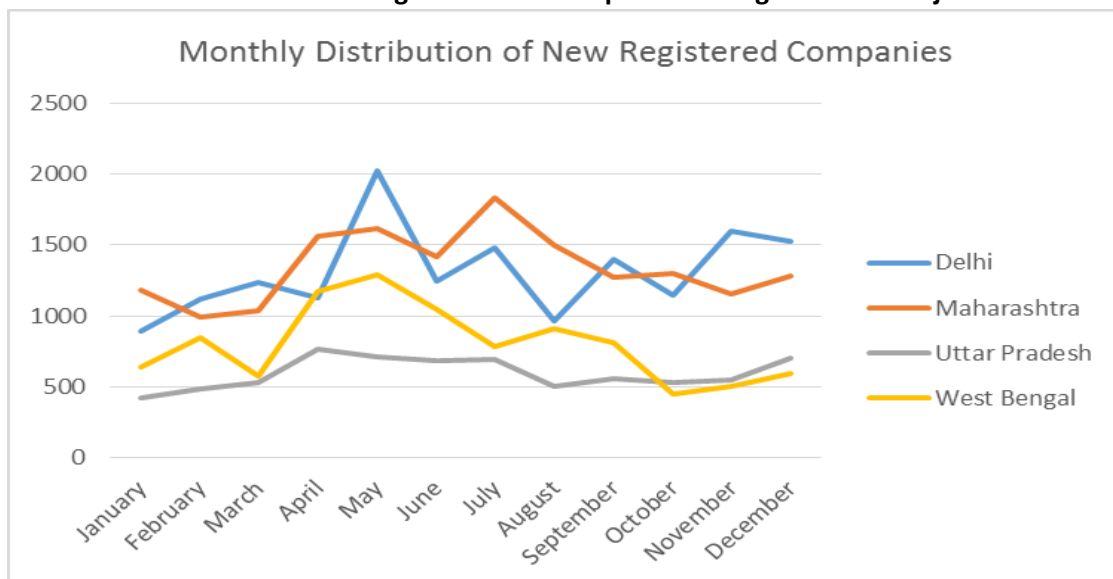


II. REGISTRATION OF COMPANIES DURING THE CALENDAR YEAR 2013

7. During January-December 2013, a total of **91,853** companies were registered with total authorized capital of Rs. **39,551** crore. Maharashtra had 16,132 (17.6%) registered companies, followed by Delhi with 15,773 (17.2%), and West Bengal with 9,641 (10.5%) companies registered during the calendar year 2013. Top five States/UTs, viz., Maharashtra, Delhi, West Bengal, Uttar Pradesh and Andhra Pradesh together account for 60% of total number companies registered during 2013 (**Table-2.1**).

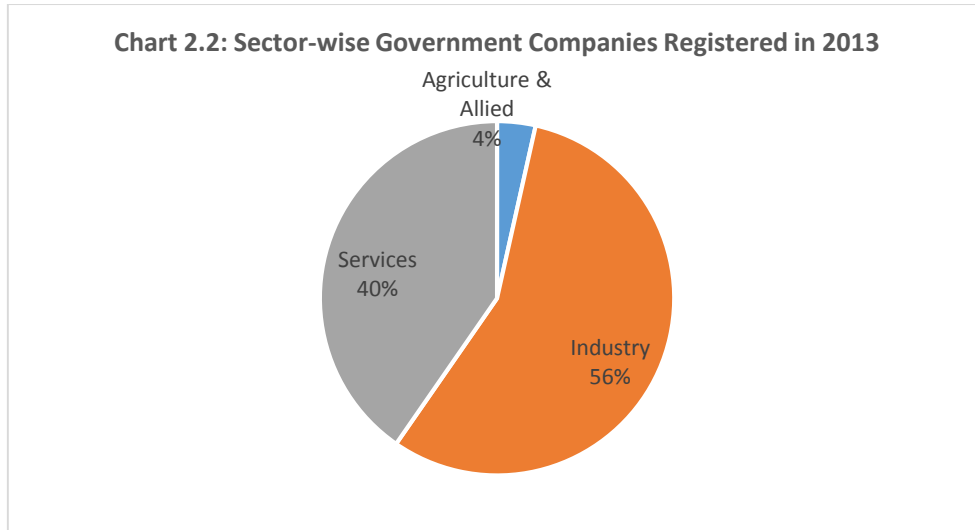
8. Month-wise registration of companies during the calendar year 2013 (**Table2.2**) reveals that highest number of 5,634 companies (11.6%) were registered in the month of May, followed by 4798 (9.9%) companies in July and 4625 (9.5%) companies in April. The monthly registration trend of companies in 4 major States/UT (Delhi, Maharashtra, West Bengal and Uttar Pradesh) is presented in **Chart 2.1**.

Government Companies Registered During the Calendar Year 2013

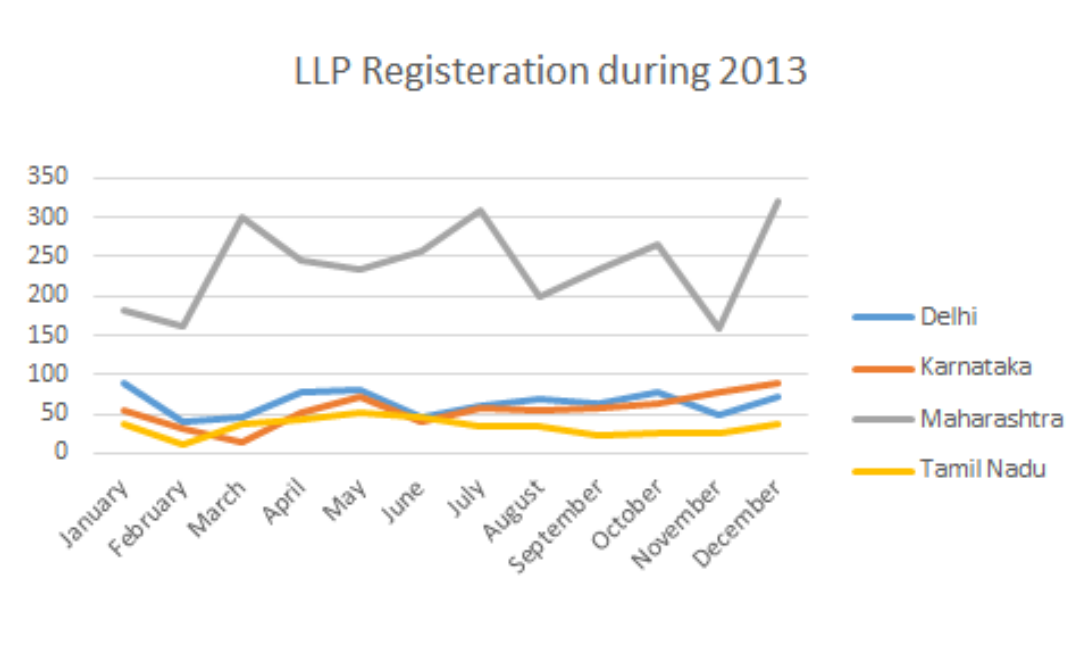
9. During the calendar year 2013, 57 government (16 Union Government and 41 State Government) companies were registered. Amongst Union government owned companies, *Bharatiya Mahila Bank Limited* and *HPCL Rajasthan Refinery Limited* had highest authorized capital of Rs. 4000 Crore each. Amongst State government owned companies, *Lucknow Metro Rail Corporation Limited* had the highest authorized capital of Rs. 2000 Crore. Economic-activity wise classification of Government companies registered during the year 2013 (**Table-2.3 and Chart 2.2**) reveals that 32 companies were registered in Industrial sector, followed by 23 companies in Service sector and 2 companies in Agriculture sector.



LLPs Registered during the Calendar Year 2013

10. A total of 6,783 Limited Liability Partnerships (LLPs) were registered during the calendar year 2013. Highest number of 2870 LLPs were registered in Maharashtra (42.3%) followed by 772 in Delhi (11.4%) and 664 in Karnataka (9.8%) (**Table 2.4 and Chart 2.3**).

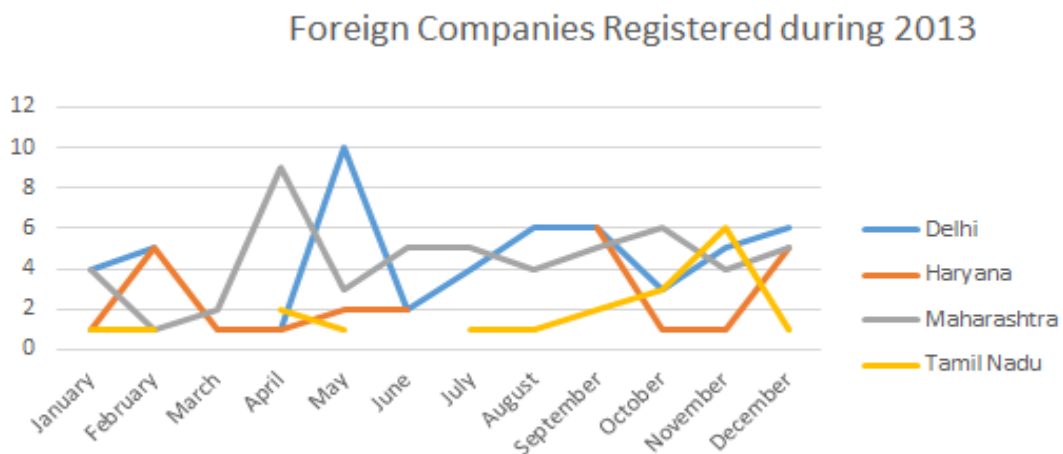
Chart 2.3: Month-wise Registration of LLP in 4 Major States in year 2013



Foreign Companies Registered during the Year 2013

11. A total of 188 foreign companies were registered during the calendar year 2013 with place of business at different states of India with maximum of 53 companies in Maharashtra followed by Delhi with 52 foreign companies. **(Table-2.5 and Chart 2.4).**

Chart 2.4: Month-wise Registration of Foreign Companies in 4 Major States in year 2013



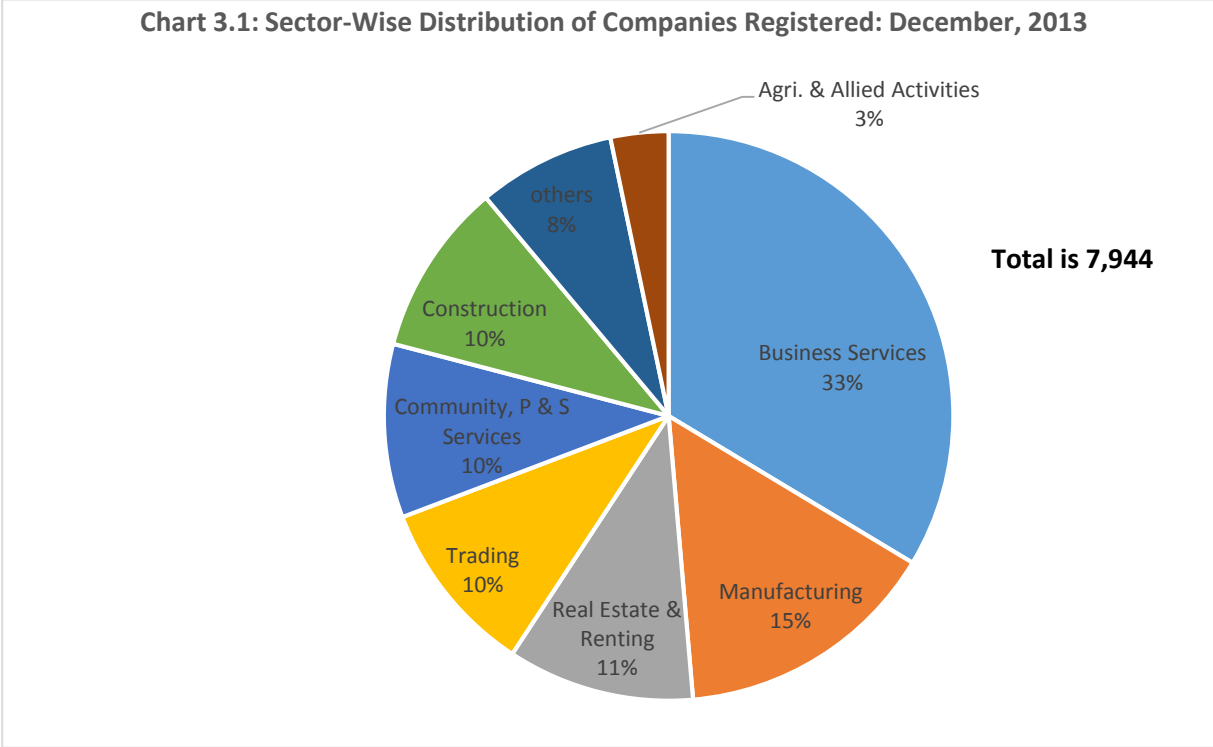
III. REGISTRATION OF NEW COMPANIES DURING DECEMBER, 2013

12. During the month of December, 2013 a total of 7,944 companies were registered with authorized capital of Rs. 1528.50 crore. Of them 7,911 Companies were registered as Companies Limited by Shares with an authorized capital of Rs. 1528.43 crore; 31 Companies Limited by Guarantees with authorised capital of Rs. 4 lakh; and 2 Unlimited Liability Company with authorised capital of Rs. 3 lakh **(Table-3.1).**

13. During December, 2013 Delhi has 1,530 (19.3%) newly registered companies, followed by Maharashtra with 1,280 (16.1%), and Uttar Pradesh with 707 (8.9%) companies registered during the month **(Table-3.2).**

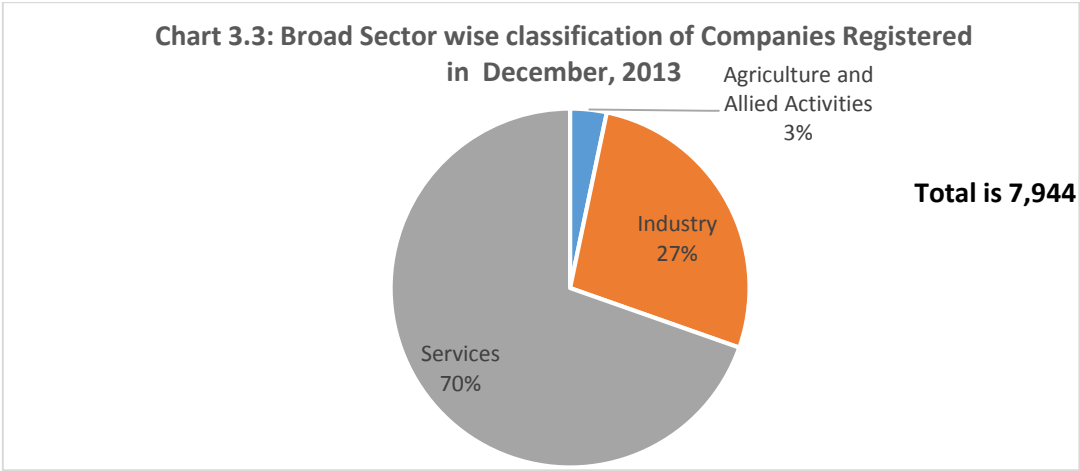
14. Economic-activity wise classification of newly registered companies during December, 2013 **(Table-3.3 and Chart 3.1)** reveals that the

predominant share of companies are in Business Services (2,671) followed by manufacturing (1,192) and Real Estate & Renting (844). Business Services comprise IT (Information Technology), Research & Development and other business activities (law, audit & accounts and consultancy, etc.)

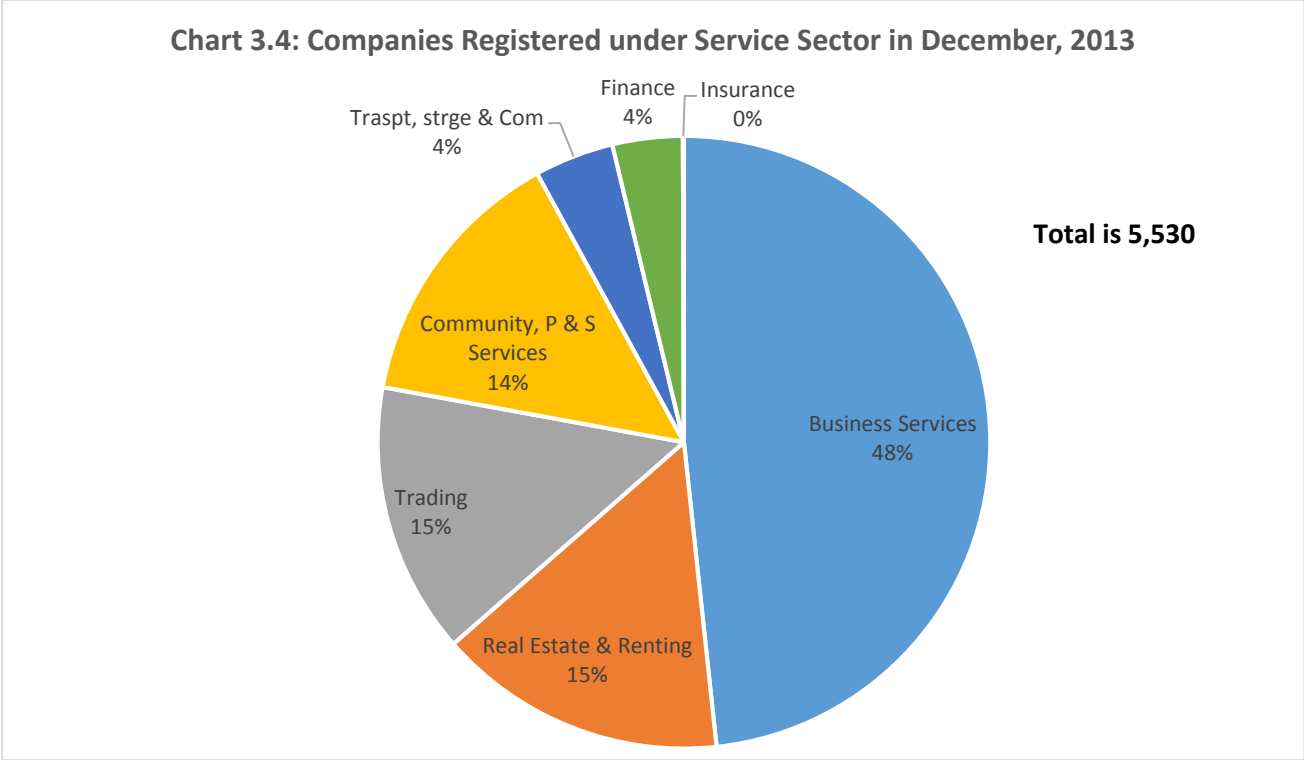


Note: 'others' category includes Mining & Quarrying, finance, insurances, Electricity, Gas & Water, Transport, storage and Communications.

15. In other words, 5530 companies were registered in Service Sector, followed by 2153 companies in Industry and 261 companies in Agriculture Sector during December, 2013 (**Chart 3.3**).



16. Within the Service Sector, 2,671 newly registered companies were in Business Services; 844 companies in real estate & renting; 792 companies in trading and 783 companies in community, personal, and social services (Chart 3.4).



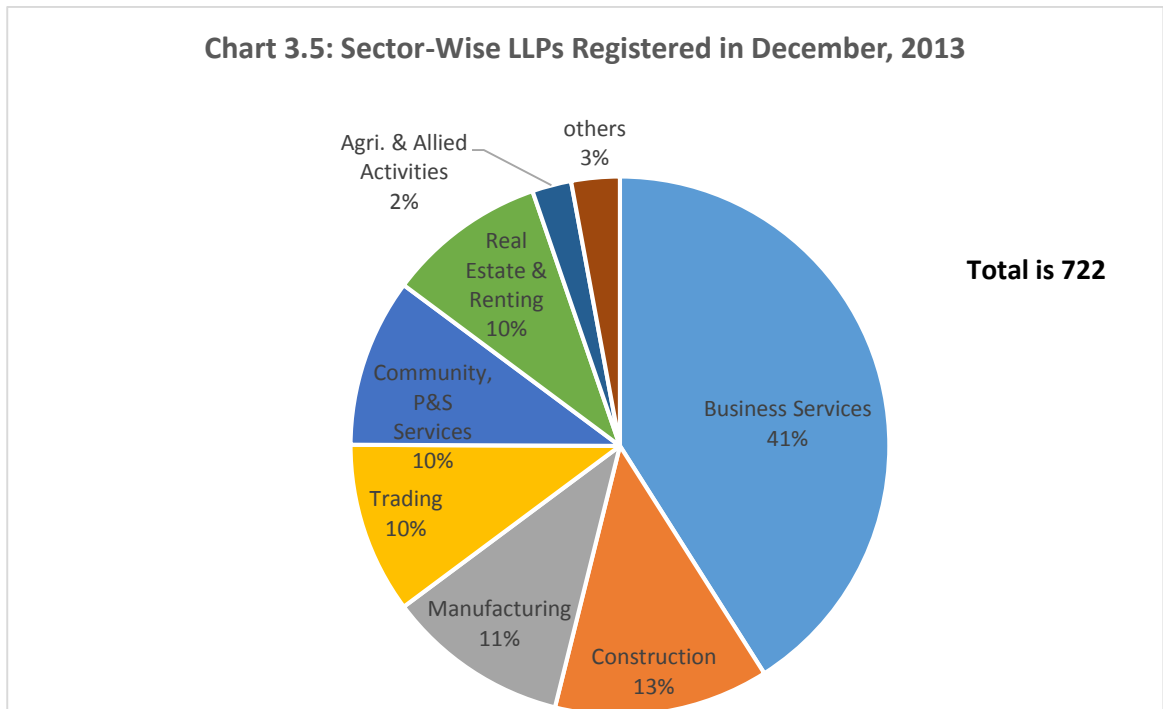
17. Five Government Companies (Table 3.4) have been registered during December, 2013 with an authorized capital of Rs. 522.05 crore. *National Waqf Development Corporation Limited* alone has an authorized capital of Rs. 500 crore followed by *Clean Kerala Company Limited* and *Rajonline Limited* with an authorized capital of Rs. 10 crore and *Punjab Logistics Infrastructure Limited* with an authorized capital of Rs. 2 crore and *Manipur IT SEZ Project Development Company Limited* with an authorized capital of Rs. 5 lakh.

18. During the month of December, 2013 a total of 1,684 companies were closed and 401 companies have fallen in dormant status, 50 companies went for liquidation; 1,133 companies applied for struck-off (Table 3.5). Economic-activity wise classification of companies closed during December, 2013 is given in Table 3.6.

Limited Liability Partnerships (LLP)

19. Number of Limited Liability Partnerships (LLPs) registered during December, 2013 was 722 with Obligation of Contribution of Rs. 75.68 Crore. Highest number of 322 LLPs were registered in Maharashtra (44.6%) followed by 89 in Karnataka (12.3%) (**Table 3.7**).

20. Economic activity wise classification of newly registered LLPs during the month of December, 2013 (**Table-3.8**) reveals that highest numbers of 296 LLPs were registered in Business Services (41%), followed by 93 in construction (12.9%), and 79 in manufacturing (10.9%).



Foreign Companies

21. Eighteen foreign companies were registered during December, 2013 with place of business at different states of India with maximum of 6 companies in Delhi (**Table-3.9**). Highest number of foreign companies (8 in number) were registered under Business Services category (**Table-3.10**).

Dormant status is assigned to Companies who have not filed their statutory annual filings (form 20B, 23AC/23ACA) consecutively for three years or more. AIPG (Active in Progress) status is assigned to a dormant company to do its pending annual filings within 21 days. During this period the status of a company remains Active in Progress. Under Section 560 of the Companies Act, 1956 RoCs are empowered to strike off the names of defunct companies. This is different from liquidation of Companies (either by Tribunal or Voluntary).
