## **HIGHLIGHTS**

### **I. REGISTERED COMPANIES AS ON 31<sup>st</sup> MARCH, 2014**

1. The total number of companies registered in the country as on 31<sup>st</sup> March, 2014, stood at 13,94,819. Of them, 2,70,915 companies were closed; 1,42,373 companies were lying dormant; 5,090 companies were under liquidation; 23,696 companies were in the process of being struck-off and 312 companies were in the process of being re-activated. Taking the above into account, there were 9,52,433 active companies as on 31<sup>st</sup> March, 2014.

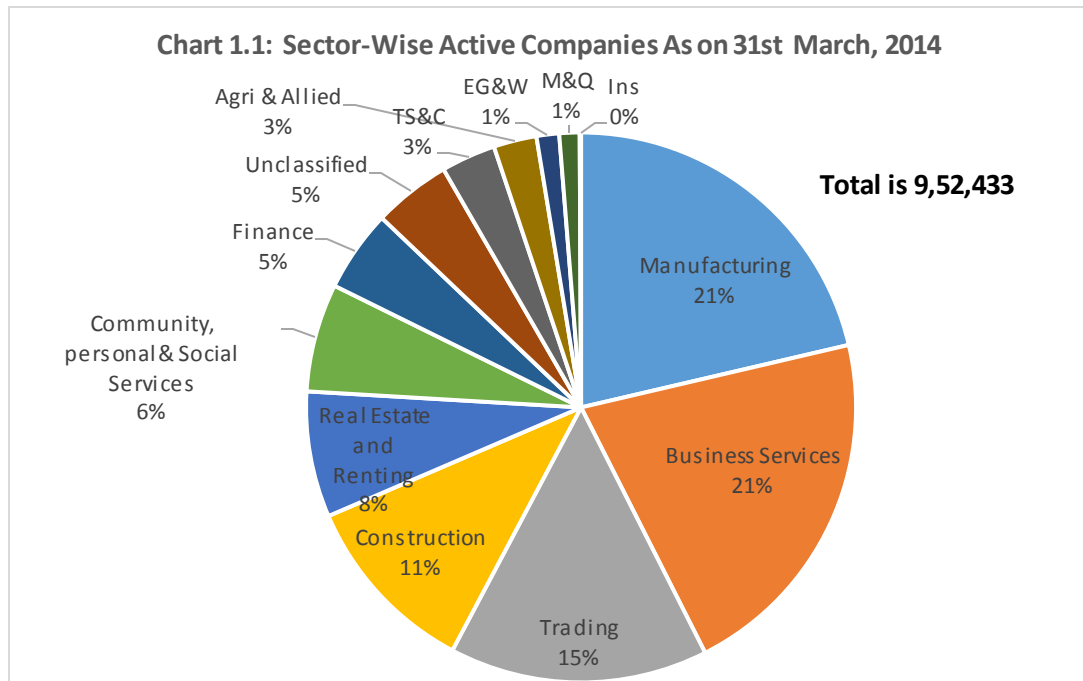
2. Out of the 2,70,915 closed companies, about 10,198 companies were liquidated/dissolved; 2,45,205 companies were defunct (and hence struck-off); 13,769 companies were amalgamated/ merged with other companies; 1,743 companies were converted to LLP and dissolved. **Table-1.1** presents the summary picture of companies count as on 31<sup>st</sup> March, 2014.

3. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,83,588), followed by Delhi (2,61,456) and West Bengal (1,81,182). Amongst 'Active Companies', Delhi has the maximum number of active companies (1,89,441), followed by Maharashtra (1,88,768) and West Bengal (1,34,292) as on 31<sup>st</sup> March, 2014 (**Table-1.2**).

4. Authorised Capital wise distribution of active companies as on 31<sup>st</sup> March, 2014 (**Table-1.3**) indicates that about 64.92% of companies (618364 in number) have authorized capital less than or equal to Rs. 10 lakh each and about 2.1% of companies (35134 in number) have authorized capital of above Rs.10 crore each.

5. Economic-activity wise classification of active companies reveals that a large number of companies are in manufacturing (2.03 lakh) followed by Business Services (2.01 lakh), Trading (1.44 lakh) and Construction (1.02 lakh). Business Services comprise Information Technology, Research & Development and other business activities

(such as law, audit & accounts and consultancy, etc.) (**Table-1.4 and Chart 1.1**).

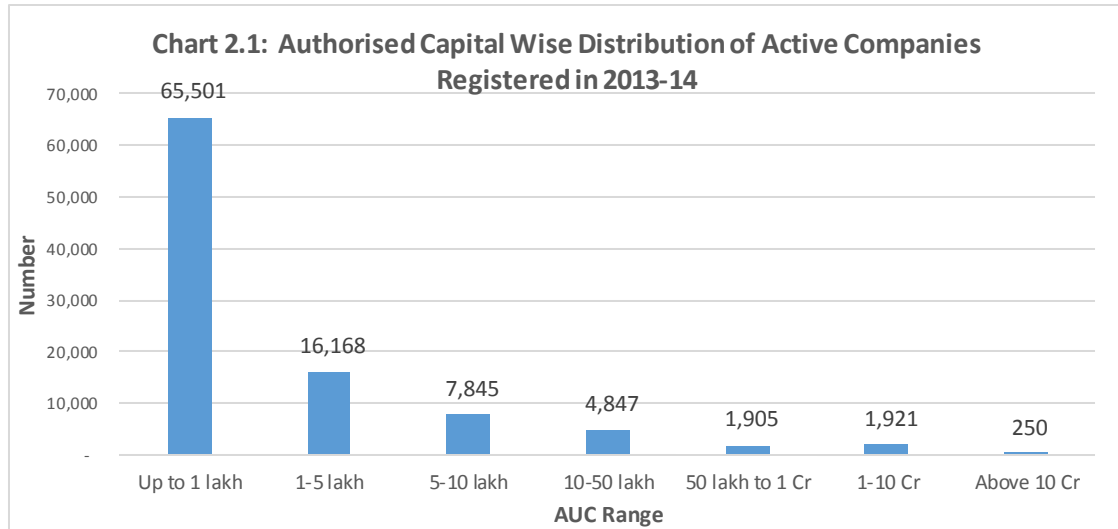
## **II. REGISTRATION OF COMPANIES DURING FY 2013-14**

6. During the financial year 2013-14 (i.e., from 1<sup>st</sup> April, 2013 to 31<sup>st</sup> March, 2014), a total of 98,437 companies were registered with collective authorized capital of Rs. 38,873.83 crore. Of them 98,029 Companies were registered as Companies Limited by Shares with authorized capital of Rs. 38,872.12 crore; 395 Companies Limited by Guarantees with authorized capital of Rs. 1.46 crore; and 13 Unlimited companies were registered with authorized capital of Rs. 25 lakh during the Financial Year 2013-14 (**Table-2.1**).

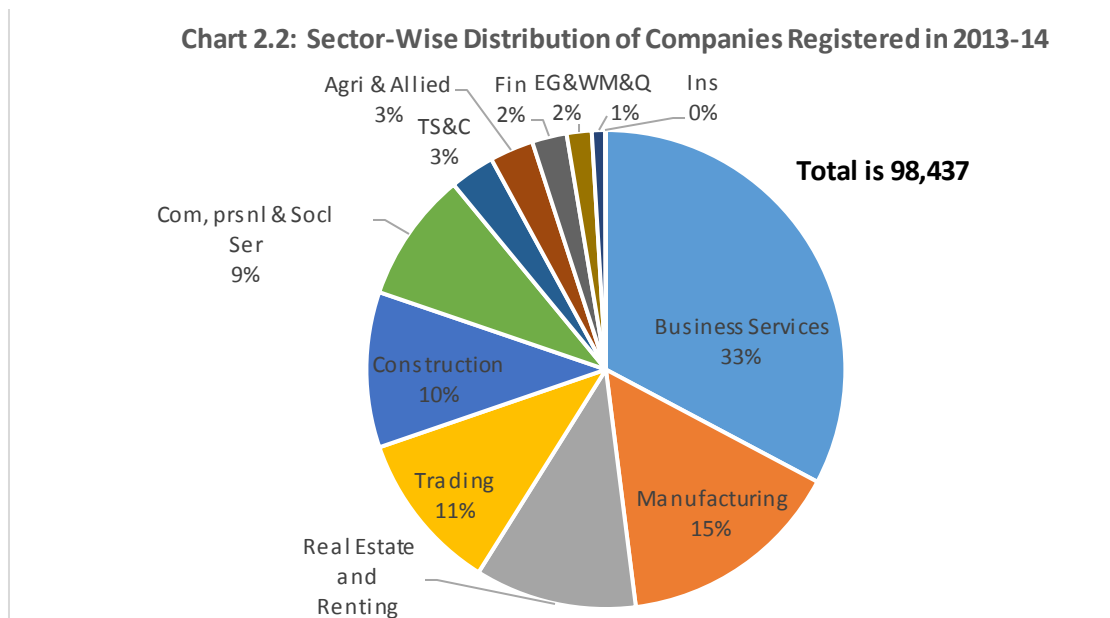
7. During the financial year 2013-14, Maharashtra had 17,686 (17.97%) newly registered companies, followed by Delhi with 16,818 (17.09%), and West Bengal with 9,937 (10.09%) companies (**Table-2.2**).

8. Authorized Capital wise distribution of new companies registered during the financial year 2013-14 (**Table-2.3**) indicates that about 83% of companies (81669 in number) have authorized capital less than or

equal to Rs. 5 lakhs and about 2.2% of companies (2171 in number) have authorized capital of above Rs.1 crore each.



9. Economic-activity wise classification of companies registered during financial year 2013-14, (**Table-2.4 and Chart 2.2**) reveals that the predominant share of companies are in Business Services (32,254) followed by manufacturing (14,996), real estate and renting (10,752), Trading (10,646), and construction (10,335).

10. During the financial year 2013-14, 16 central government companies with authorized capital of Rs. 9187.35 Crore and 44 state

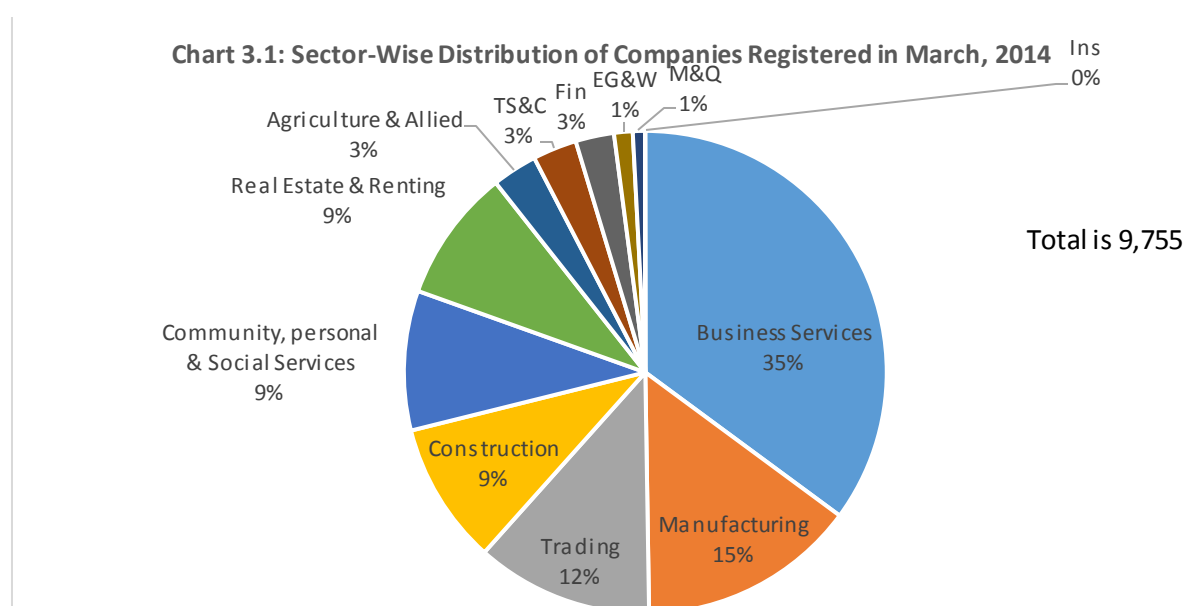
government companies with authorized capital of Rs. 6,042.07 Crore were registered.

### III. REGISTRATION OF NEW COMPANIES DURING MARCH, 2014

11. During the month of March, 2014, a total of 9,755 companies were registered with collective authorized capital of Rs. 2,808.97 Crore. Of them 9,696 companies were registered as Companies Limited by Shares with authorized capital of Rs. 2,808.82 Crore; 57 companies were registered as Limited by Guarantees with authorized capital of Rs. 5 lakh; and 2 Unlimited companies were registered with authorized capital of Rs. 10 lakh during the month (**Table-3.1**).

12. During March, 2014 Maharashtra has 1,809 (18.5%) newly registered companies, followed by Delhi with 1,603 (16.4%), and West Bengal with 1,110 (11.4%) companies registered (**Table-3.2**).

13. Economic-activity wise classification of companies registered during March, 2014 (**Table-3.3 and Chart 3.1**) reveals that the predominant share of companies are in Business Services (3,425) followed by Manufacturing (1,428), Trading (1,157), Construction (928), and community, personal & social services (912).

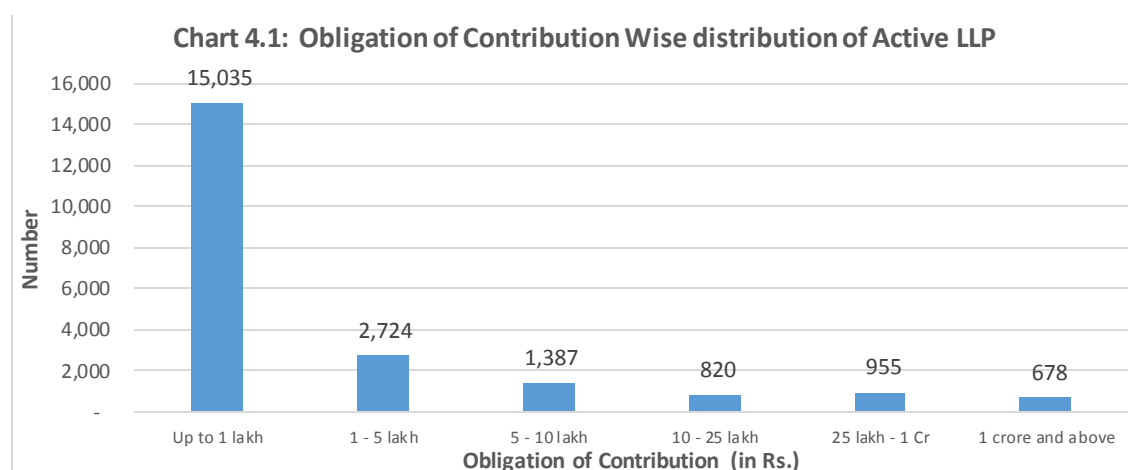

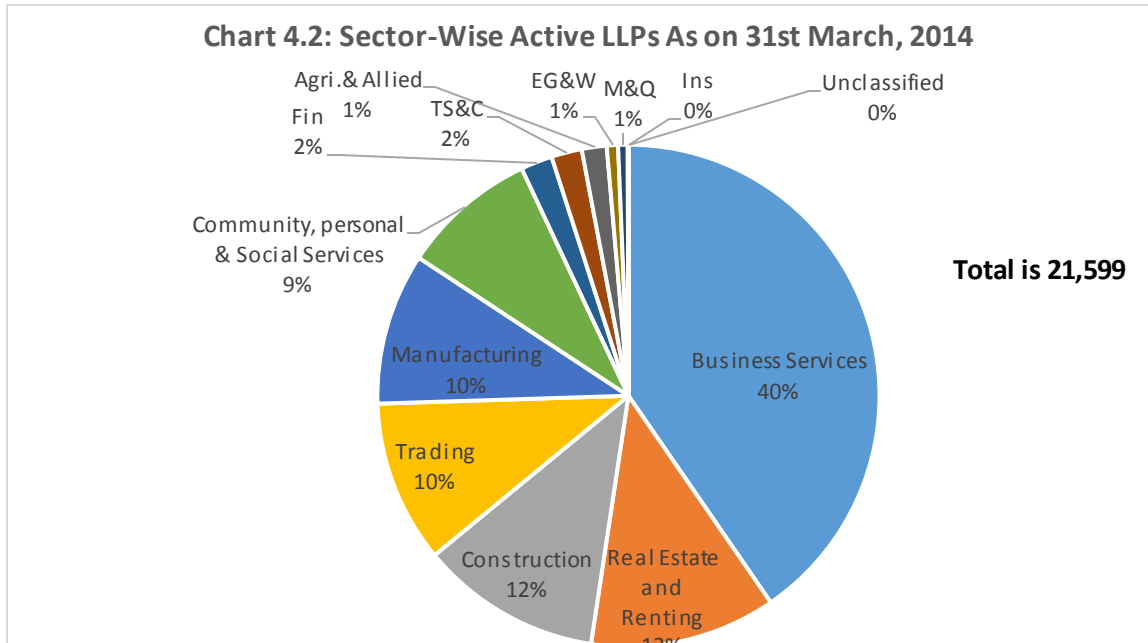
14. Eight Government Companies (**Table 3.4**) were registered during March, 2014 with a collective authorized capital of Rs. 75.15 Crore. Amongst them, *Pithampur Jal Prabandhan Company Limited* has the highest authorized capital of Rs. 35 Crore.

#### **IV. Limited Liability Partnerships (LLP)**

15. As on 31<sup>st</sup> March, 2014, a total number of 21,784 LLPs were registered in the country and out of them 21,599 LLPs were active. About 82.2% active LLPs (17759 in number) have obligation of contribution less than or equal Rs. 5 Lakh each; and only about 3% (678 in number) of LLPs have obligation of contribution of above Rs.1 crore each. (**Table 4.1 and Chart 4.1**)



16. Broad economic sector wise classification of active LLPs as on 31<sup>st</sup> March, 2014 reveals that Service Sector account for 16,335 LLPs, followed by Industry and Agriculture sector accounting for 4,916 and 346 respectively. Economic-activity wise classification of total active LLPs as on 31<sup>st</sup> March, 2014 reveals that the large number of LLPs are in Business Services (8,727) followed by Real Estate & Renting (2,588), Construction (2,518) and Trading (2,258) (**Table 4.2 and Chart 4.2**).

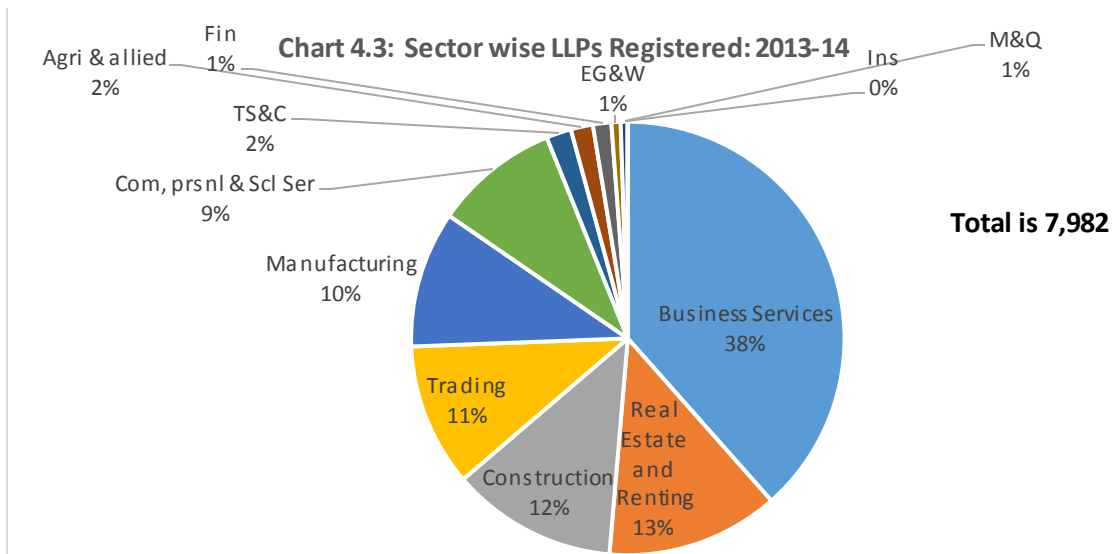

### Registration of LLPs during FY 2013-14

During the financial year 2013-14 (i.e., from 1<sup>st</sup> April, 2013 to 31<sup>st</sup> March, 2014) a total of 7,982 Limited Liability Partnerships (LLPs) were registered with collective obligation of contribution of Rs. 2,029.56 Crore.

17. Economic activity wise classification of LLPs during the financial year 2013-14 indicates that highest numbers of 3,071 LLPs were registered in Business Services, followed by 1,028 in Real Estate & Renting and 988 in Construction (**Table 4.3 and Chart 4.3**).

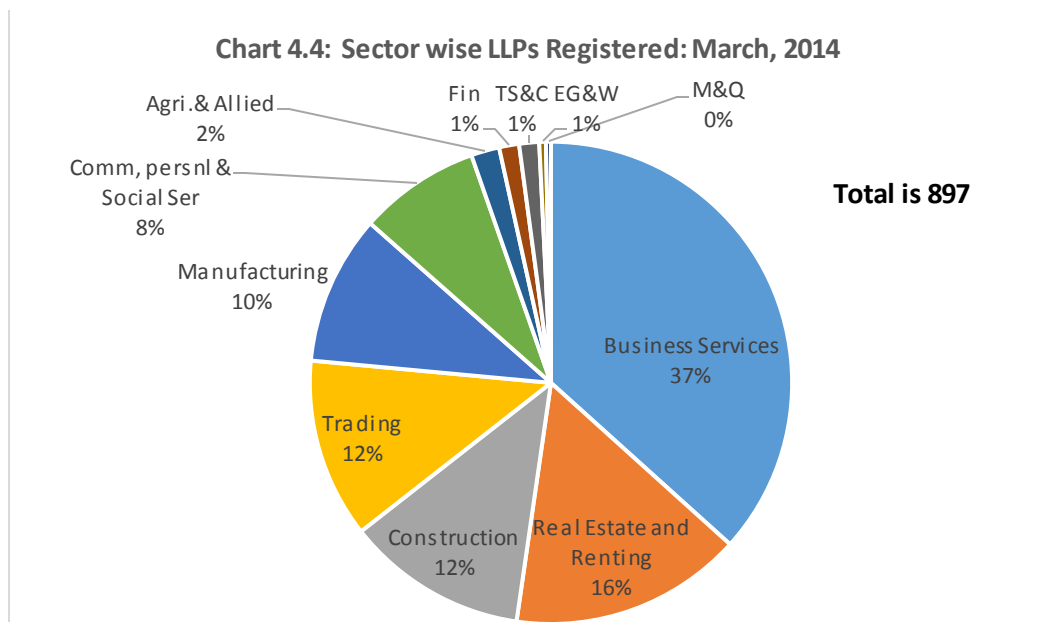

18. Maharashtra has 3,231 (40.48%) newly LLPs registered, followed by Delhi with 949 (11.89%), and Karnataka with 816 (10.22%) during 2013-14 (**Table-4.4**).

**Registration of LLPs during March, 2014**

19. A total of 897 Limited Liability Partnerships (LLPs) were registered during March, 2014 with collective obligation of contribution of Rs. 306.51 crore. Economic activity wise classification of LLPs during the month reveals that highest numbers of 329 LLPs were registered in Business Services, followed by 140 in Real Estate & Renting and 109 in Construction (**Table 4.5 and Chart 4.4**). Highest number of 291 LLPs were registered in Maharashtra (32.44%) followed by 130 in Delhi (14.49%) (**Table 4.6**).



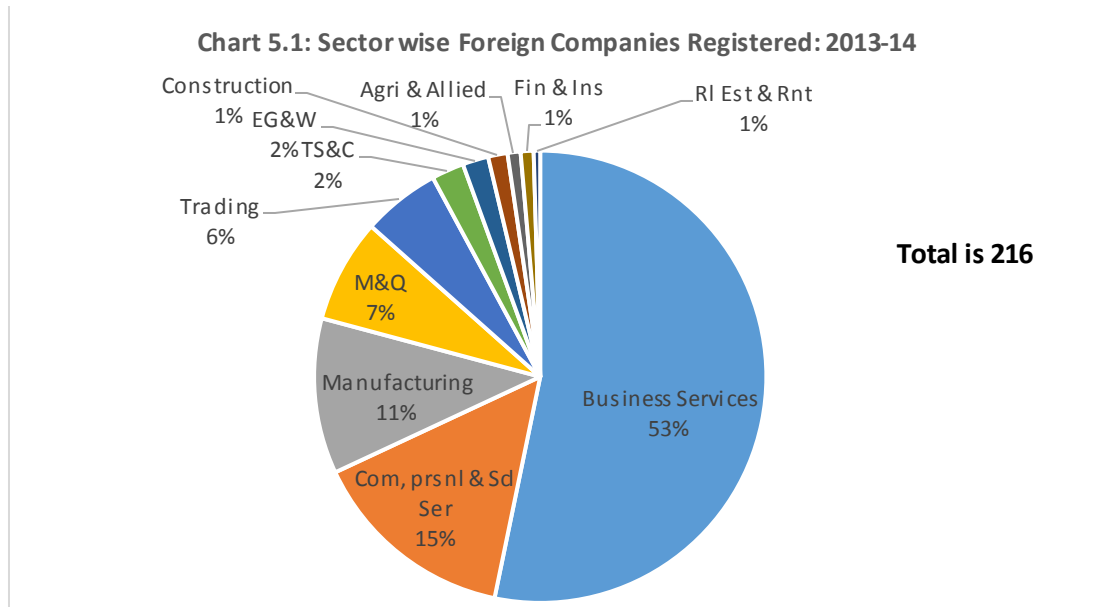

**V. Foreign Companies**

20. As on 31<sup>st</sup> March, 2014, a total of 3,240 Foreign companies were active in India. During the financial year 2013-14 (i.e., from 1<sup>st</sup> April, 2013 to 31<sup>st</sup> March, 2014) a total of 216 Foreign companies were registered. Maharashtra has registered 63 (29.2%) foreign companies, followed by Delhi with 62 (28.7%) (**Table-5.1**). Economic activity wise classification of Foreign companies reveals that highest numbers of 115



were registered in Business Services, followed by 32 in community, personal and social service and 24 in manufacturing (**Table 5.2 and Chart 5.1**).

21. During the month of March, 2014, 28 Foreign companies were registered. Highest number of Foreign companies (13 in number) were registered under Business Services category and highest number of Foreign companies (9 in number) were registered in Delhi during the month of March 2014.

2. AIPG (Active in Progress): A dormant company is allowed 21 days by the Ministry to do its pending annual filings. During this period the status of company remains Active in Progress.
3. Under Section 560 of the Companies Act, 1956 Registrar of Companies is empowered to strike off the names of defunct companies. This is different from liquidation of Companies (either by Tribunal or Voluntary).
