HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 31st JULY, 2015

1. The total number of companies registered in the country as on 31st July, 2015, stood at 1,486,371. Of them, 275,285 companies were closed; 347 companies were assigned dormant status as per the Companies Act, 2013; 139,096 companies have not filed their statutory annual filings for 3 years consecutively; 5,356 companies were under liquidation; 23,976 companies were in the process of being struck-off and 174 companies were in the process of being re-activated. Taking the above into account, there were 1,042,137 active companies as on 31st July, 2015.

2. Out of the 275,285 closed companies, about 10,339 companies were liquidated/dissolved; 243,689 companies were defunct (and hence struck-off); 15,961 companies were amalgamated/ merged with other companies; 5,296 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 31st July, 2015.

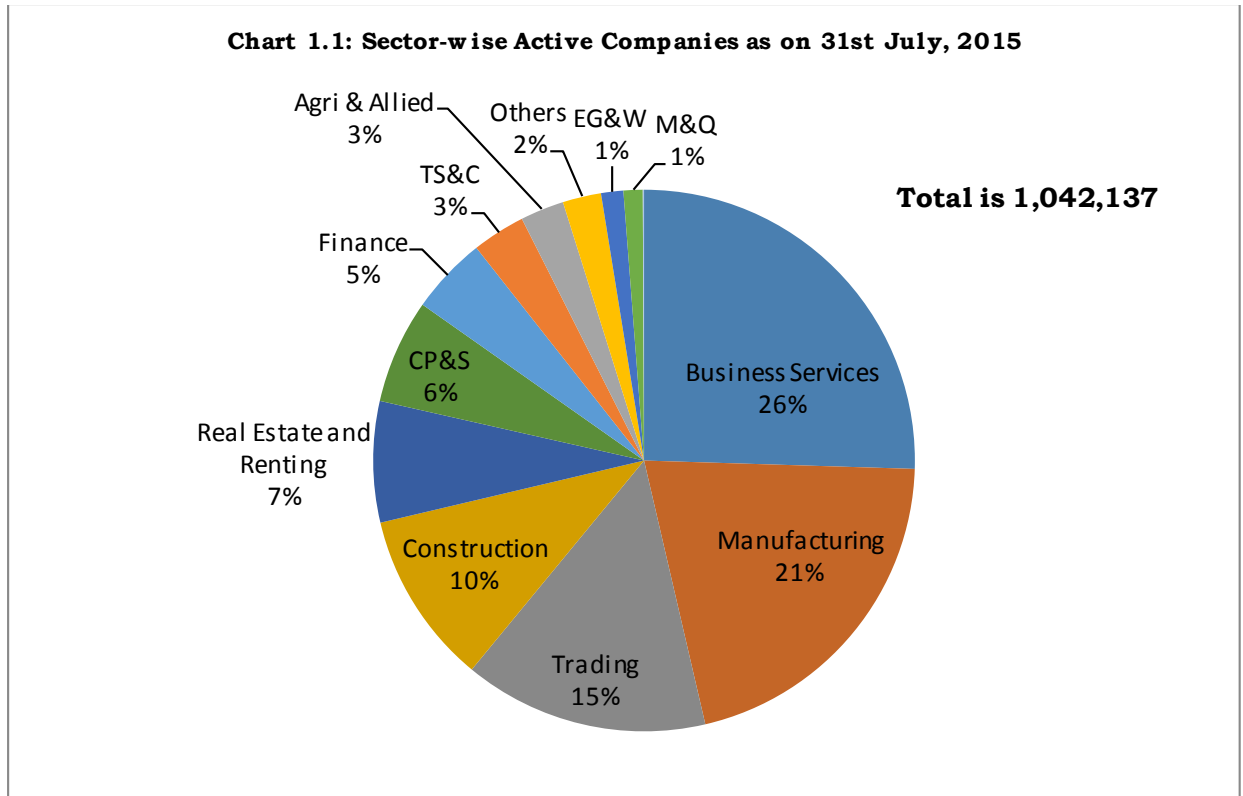
3. Out of the 1,03,5614 active companies limited by shares; 972,419 were Private companies limited by shares; and 63,194 were Public companies limited by shares, of which 7,055 were Listed and 56,139 were Unlisted Companies (**Table 1.2**).

4. Authorized Capital wise distribution of active companies as on 31st July, 2015 (**Table-1.3**) indicates that about 65.92% of companies (678,034 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.14% of companies (22,330 in number) have authorized capital of above Rs.10 crore each.

5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (299,875), followed by Delhi (277,068) and West Bengal (186,289). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (219,626), followed by Delhi (199,515) and West Bengal (137,703) as on 31st July, 2015 (**Table-1.4**).

6. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.66 lakh) followed by Manufacturing (2.18 lakh), Trading (1.52 lakh) and Construction (1.08 lakh). Business Services comprise Information Technology, Research & Development

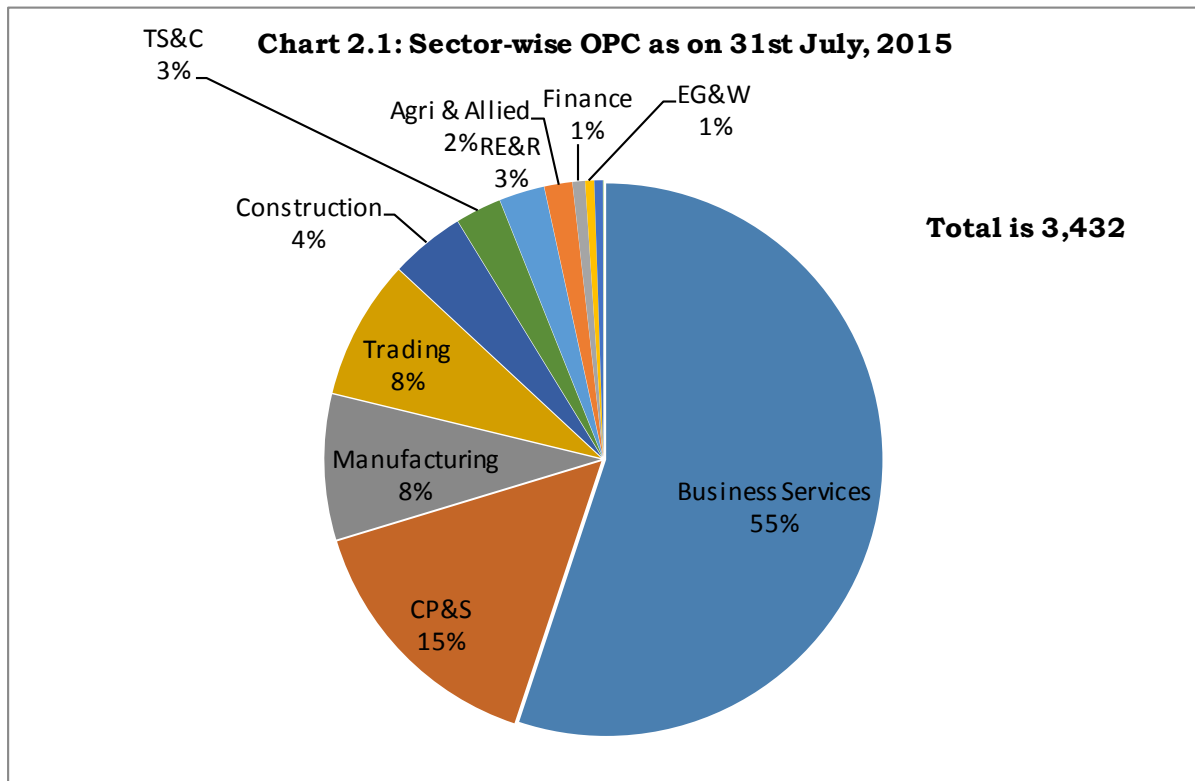
and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.5 and Chart 1.1**).

II. ONE PERSON COMPANY

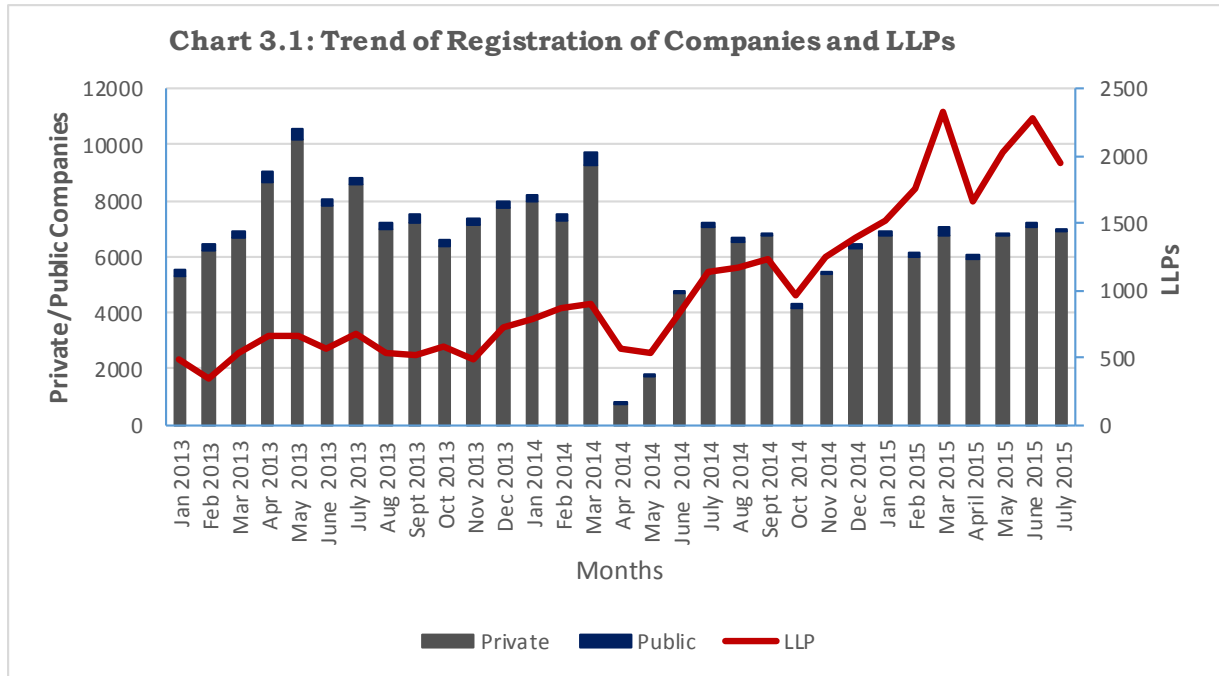
7. Up to 31st July, 2015, a total number of 3,432 One Person Company (OPC) were registered with collective authorized capital of Rs. 83.02 crore. Economic activity wise classification of OPC up to 31st July, 2015 reveals that highest number of OPC are in Business Services (1,891) followed by Community, personal & Social Services (522), Manufacturing (291) and Trading (279) (**Chart 2.1**). During the month of July, 2015, a total of 299 OPC were registered with authorized capital of Rs. 7.73 crore. Economic activity wise classification of OPC during the month reveals that highest number of 165 OPC were registered in Business Services, followed by 44 in Community, personal & Social Services and 23 in Manufacturing (**Table 2.1**). Highest number of 57 OPC each were registered in Maharashtra (19.06 %), 41 in Delhi (13.71%) and 26 in Uttar Pradesh (8.70 %) during the month of July, 2015 (**Table-6.1**).

III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

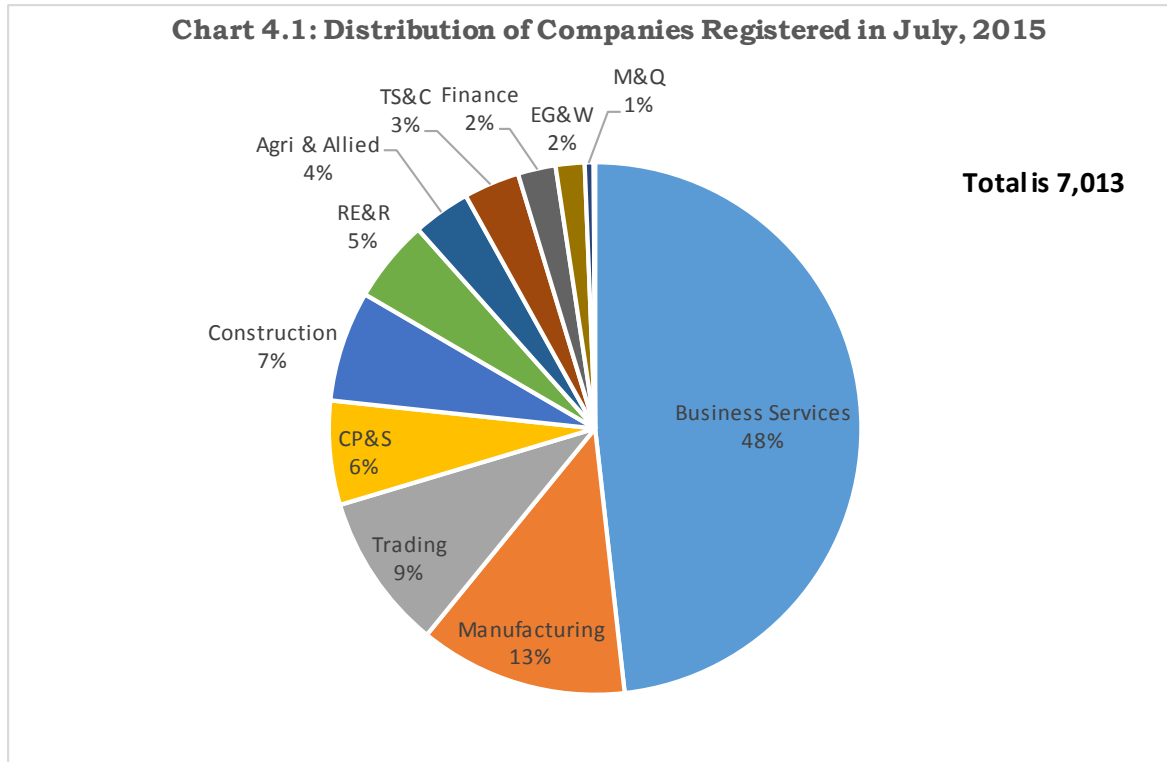
8. An analysis of registration of new companies during January 2013 to July 2015 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (**Chart 3.1**). A total of 7,013 companies were registered in July 2015 as compared to 7,229 in July, 2014. A slight decrease in registration of companies has been witnessed in July, 2015 over the previous month. An increasing trend is observed in monthly registration of LLPs in last few months with maximum registration of 2,334 LLPs in March, 2015. (**Table 3.1**). Registration of new companies as well as LLPs has picked-up since April 2014, although a dip was witnessed in October 2014 and April 2015.



IV. REGISTRATION OF NEW COMPANIES DURING JULY, 2015

9. During the month of July, 2015, a total of 7,013 companies were registered with collective authorized capital of Rs. 1,727.30 crore. Of them 6,972 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,727.06 crore; 39 companies were registered as Limited by Guarantees with authorized capital of Rs. 22.00 lakh; 2 companies were registered as Unlimited Company with authorized capital of Rs. 2.00 lakh. (**Table-4.1**).

10. Economic-activity wise classification of companies registered during July, 2015 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (3,382) followed by Manufacturing (888), Trading (665), Construction (472) and Community, personal & Social Services (443).

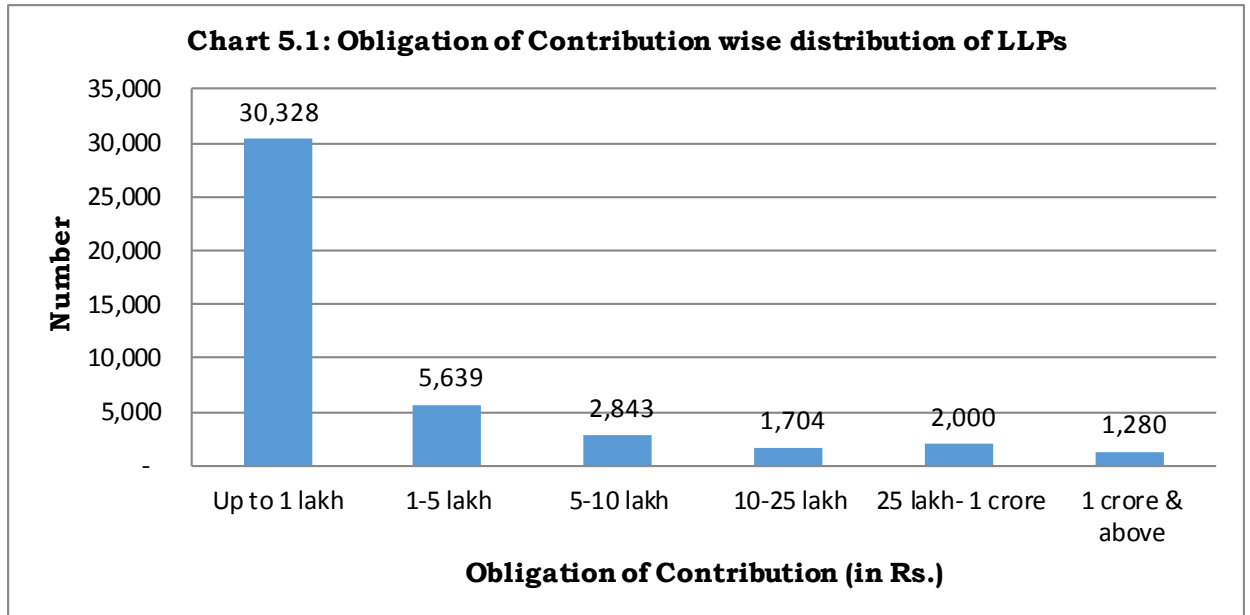

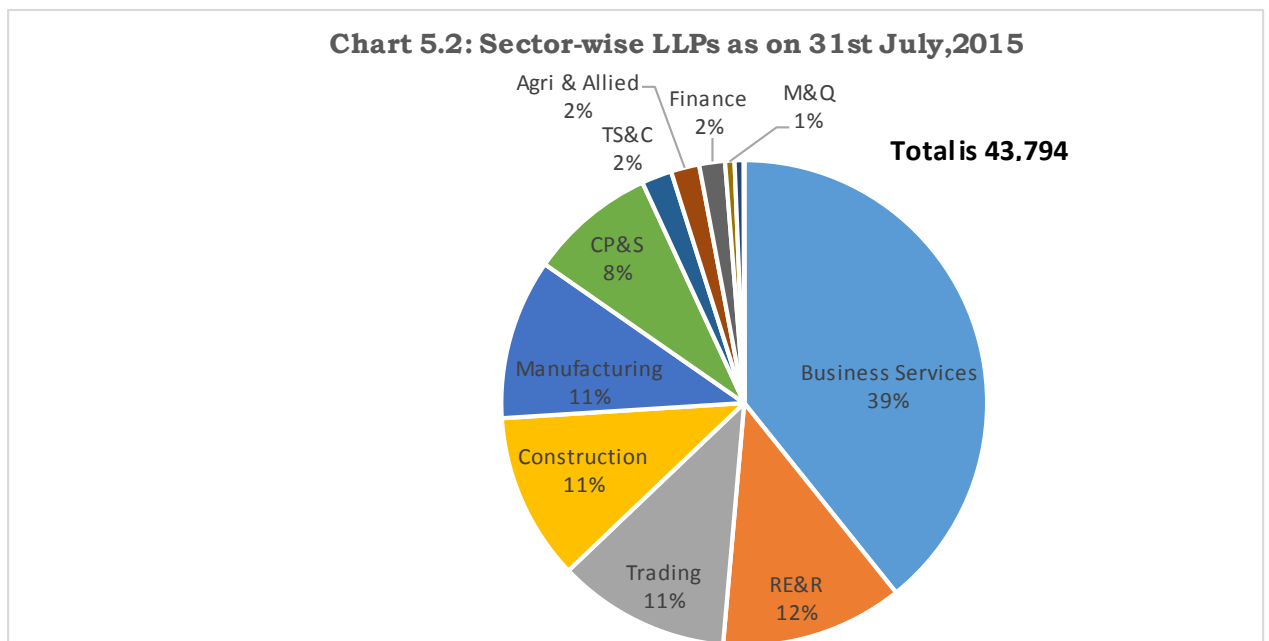
11. During July, 2015, 1,283 (18.29 %) companies were registered in Maharashtra, followed by 1,205 (17.18 %) in Delhi, and 638(9.10 %) in Uttar Pradesh (**Table-4.3**).

V. Limited Liability Partnerships (LLP) and Foreign Companies

12. As on 31st July, 2015, a total number of 44,383 LLPs were registered in the country and 43,794 of them were active. About 82.13 % active LLPs (35,967 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 2.92% (1,280 in number) of LLPs have obligation of contribution of above Rs.1 crore each (**Table-5.1 and Chart 5.1**).



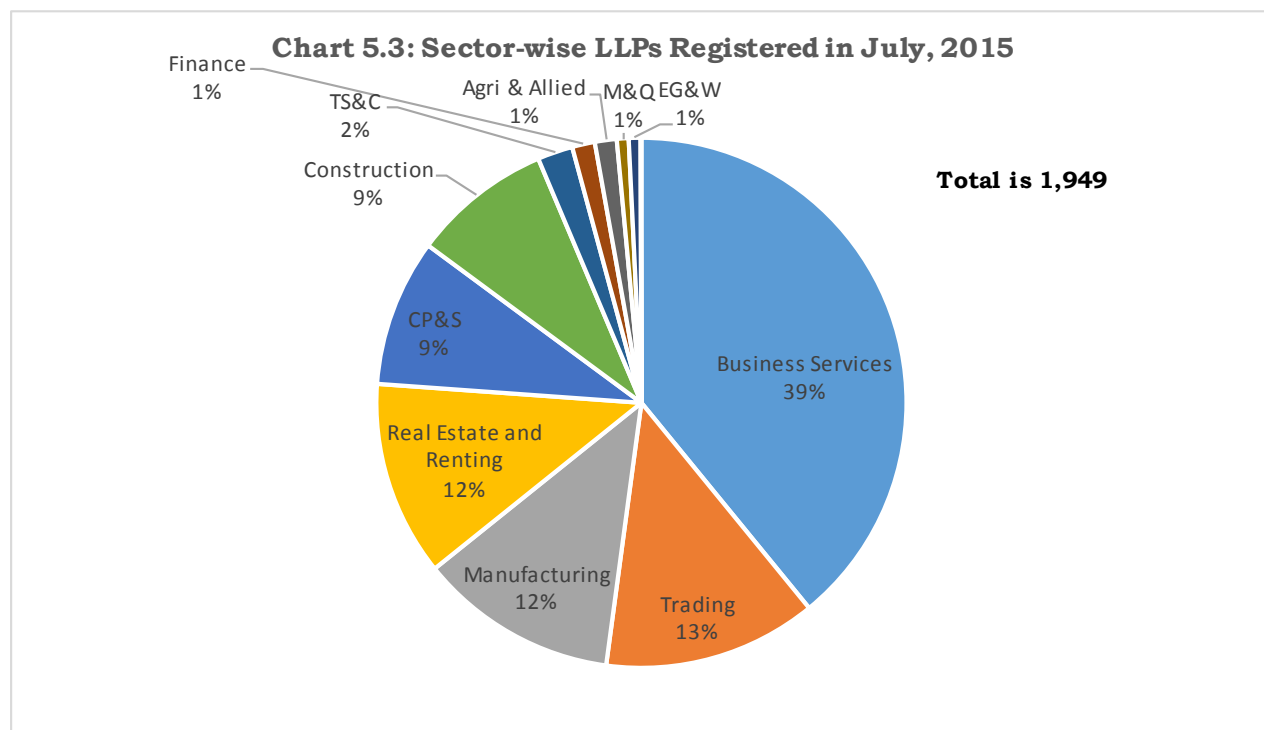
13. Broad economic sector wise classification of active LLPs as on 31st July, 2015 reveals that Service sector account for 32,874 LLPs, followed by Industry and Agriculture sectors accounting for 10,090 and 828 respectively. Economic-activity wise classification of active LLPs as on 31st July, 2015 reveals that a large number of LLPs are in Business Services (17,188) followed by Real Estate & Renting (5,318), Trading (5,030) and Construction (4,876) (**Table-5.2 and Chart 5.2**).

14. A total of 1,949 Limited Liability Partnerships (LLPs) were registered during July, 2015 with collective obligation of contribution of Rs. 203.56 crore.

Economic activity wise classification of LLPs during the month reveals that highest number of 762 LLPs were registered in Business Services, followed by 254 in Trading and 236 in Manufacturing (**Table-5.3 and Chart 5.3**). Highest number of 601 LLPs were registered in Maharashtra (30.84 %) followed by 300 in Delhi (15.39 %) during the month of July, 2015 (**Table-6.1**).

Foreign Companies

15. As on 31st July, 2015, a total of 3,310 foreign companies were doing business in India. During the month of July, 2015, 11 foreign companies were registered in India including 5 in Maharashtra, 3 in Haryana, 2 in Delhi and 1 in West Bengal. Out of these 11 foreign companies, 7 were registered under Business Services, 1 each in Manufacturing, Construction, Finance, Electricity, Gas & Water companies.
