HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th JUNE, 2015

1. The total number of companies registered in the country as on 30th June, 2015, stood at 1,479,374. Of them, 273,725 companies were closed; 301 companies were assigned dormant status as per the Companies Act, 2013; 139,153 companies have not filed their statutory annual filings for 3 years consecutively; 5,330 companies were under liquidation; 24,068 companies were in the process of being struck-off and 180 companies were in the process of being re-activated. Taking the above into account, there were 1,036,617 active companies as on 30th June, 2015.

2. Out of the 273,725 closed companies, about 10,339 companies were liquidated/dissolved; 242,424 companies were defunct (and hence struck-off); 15,863 companies were amalgamated/ merged with other companies; 5,099 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 30th June, 2015.

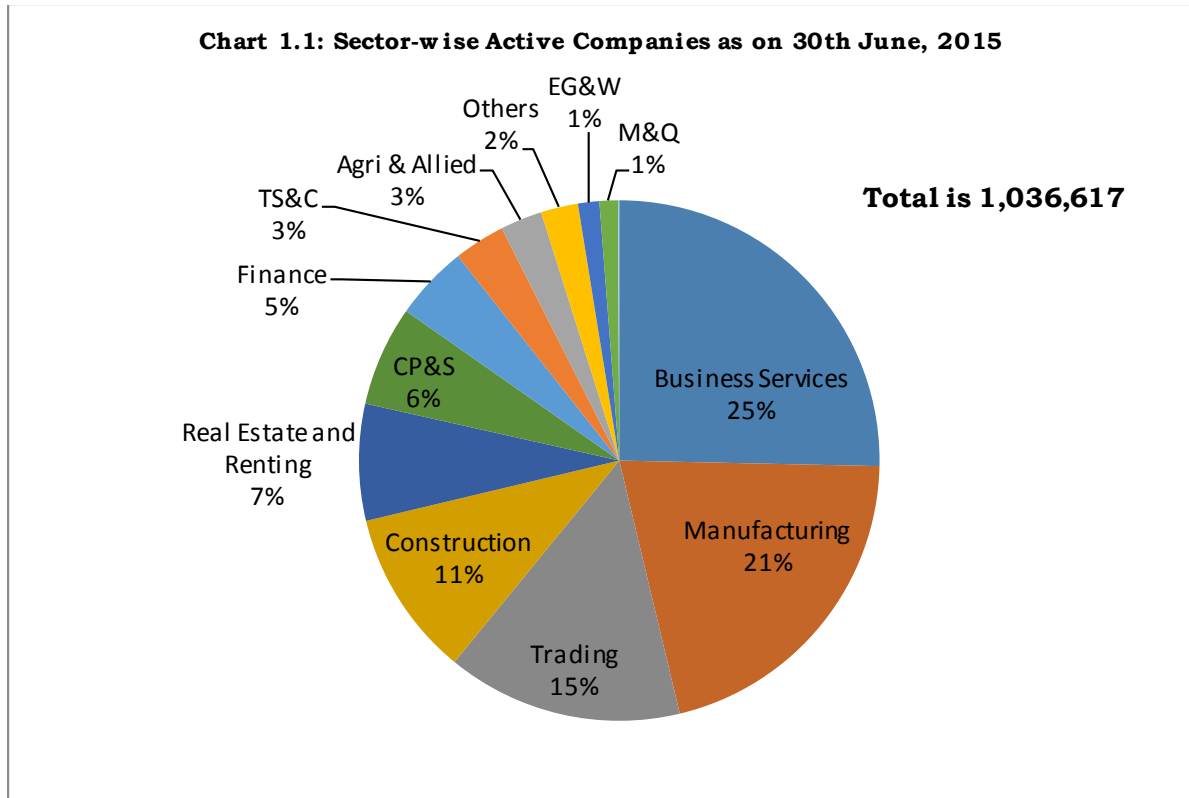
3. Out of the 1,030,122 active companies limited by shares; 966,936 were Private companies limited by shares; and 63,186 were Public companies limited by shares, of which 7,067 were Listed and 56,119 were Unlisted Companies (**Table 1.2**).

4. Authorized Capital wise distribution of active companies as on 30th June, 2015 (**Table-1.3**) indicates that about 65.85% of companies (682,584 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.14% of companies (22,224 in number) have authorized capital of above Rs.10 crore each.

5. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (298,611), followed by Delhi (275,895) and West Bengal (185,954). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (218,520), followed by Delhi (198,810) and West Bengal (137,612) as on 30th June, 2015 (**Table-1.4**).

6. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.63 lakh) followed by Manufacturing (2.17 lakh), Trading (1.52 lakh) and Construction (1.07 lakh). Business Services comprise Information Technology, Research & Development

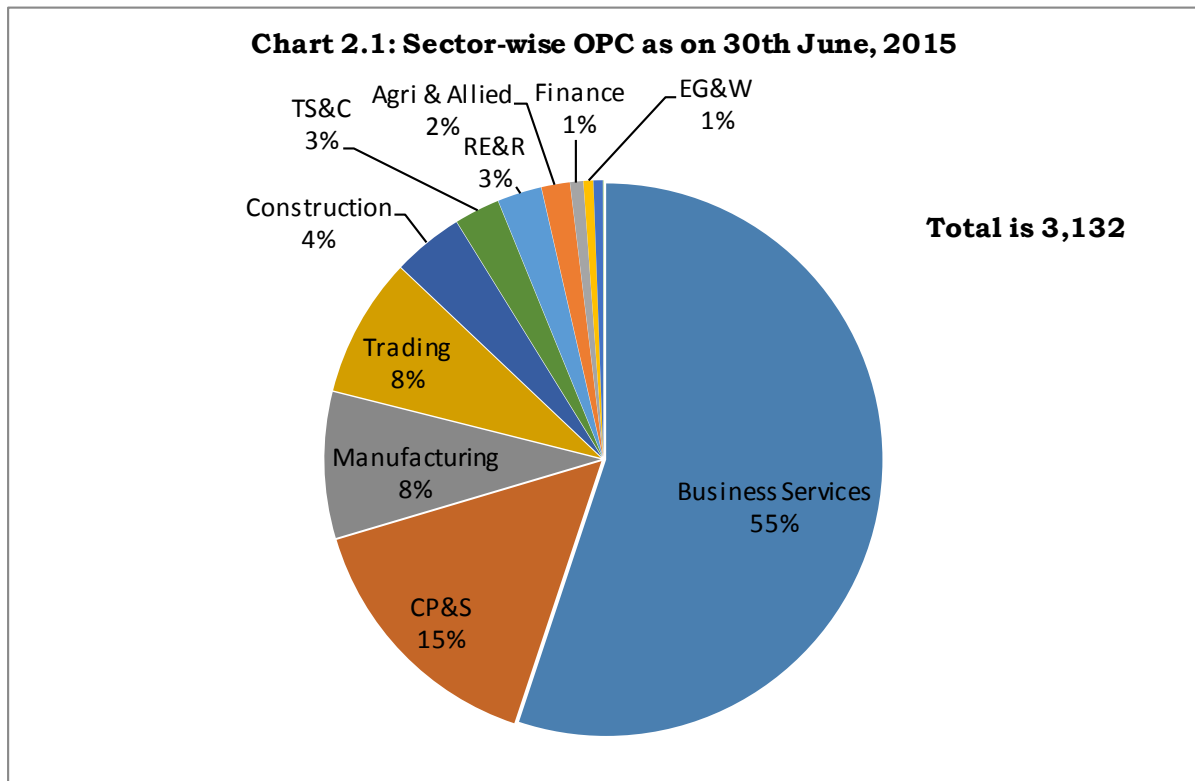
and other business activities (such as law, audit & accounts and consultancy, etc. (**Table-1.5 and Chart 1.1**).

II. ONE PERSON COMPANY

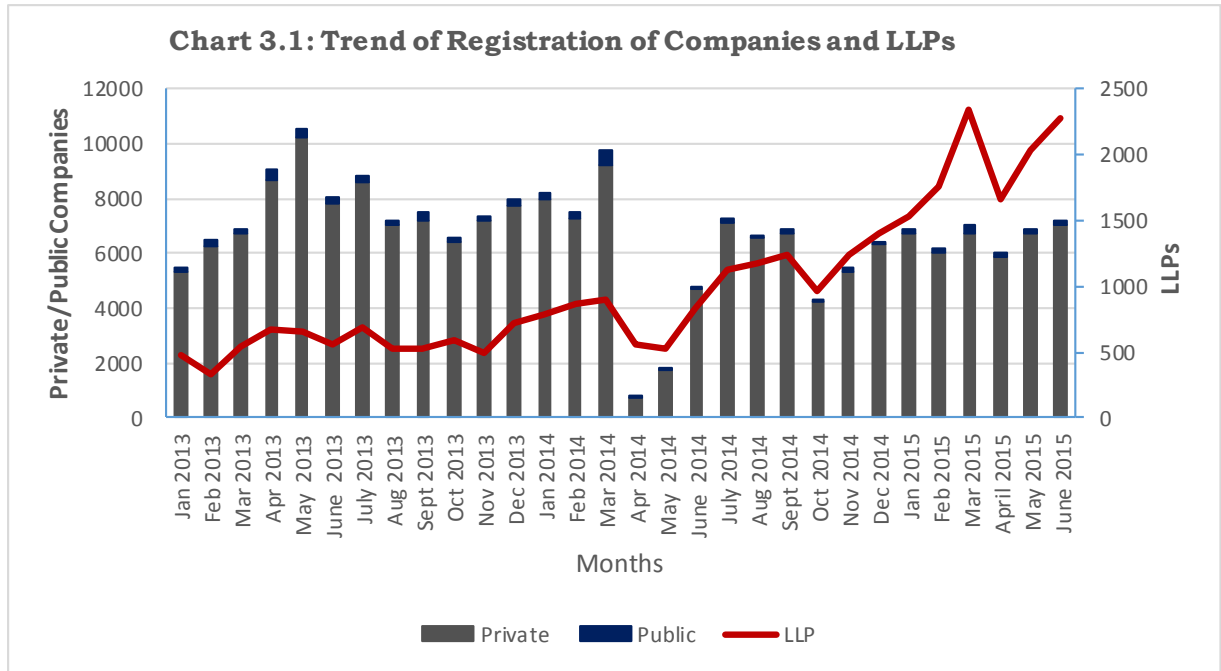
6. Up to 30th June, 2015, a total number of 3,132 One Person Company (OPC) were registered with collective authorized capital of Rs. 74.96 crore. Economic activity wise classification of OPC up to 30th June, 2015 reveals that highest number of OPC are in Business Services (1,726) followed by Community, personal & Social Services (479), Manufacturing (267) and Trading (255)(**Chart 2.1**). During the month of June, 2015, a total of 356 OPC were registered with authorized capital of Rs. 8.05 crore. Economic activity wise classification of OPC during the month reveals that highest number of 210 OPC were registered in Business Services, followed by 46 in Community, personal & Social Services and 32 in Manufacturing(**Table 2.1**). Highest number of 65 OPC each were registered in Delhi (18.26%) and Maharashtra (18.26%) and 41 in Uttar Pradesh (11.52%) during the month of June, 2015 (**Table-6.1**).

III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

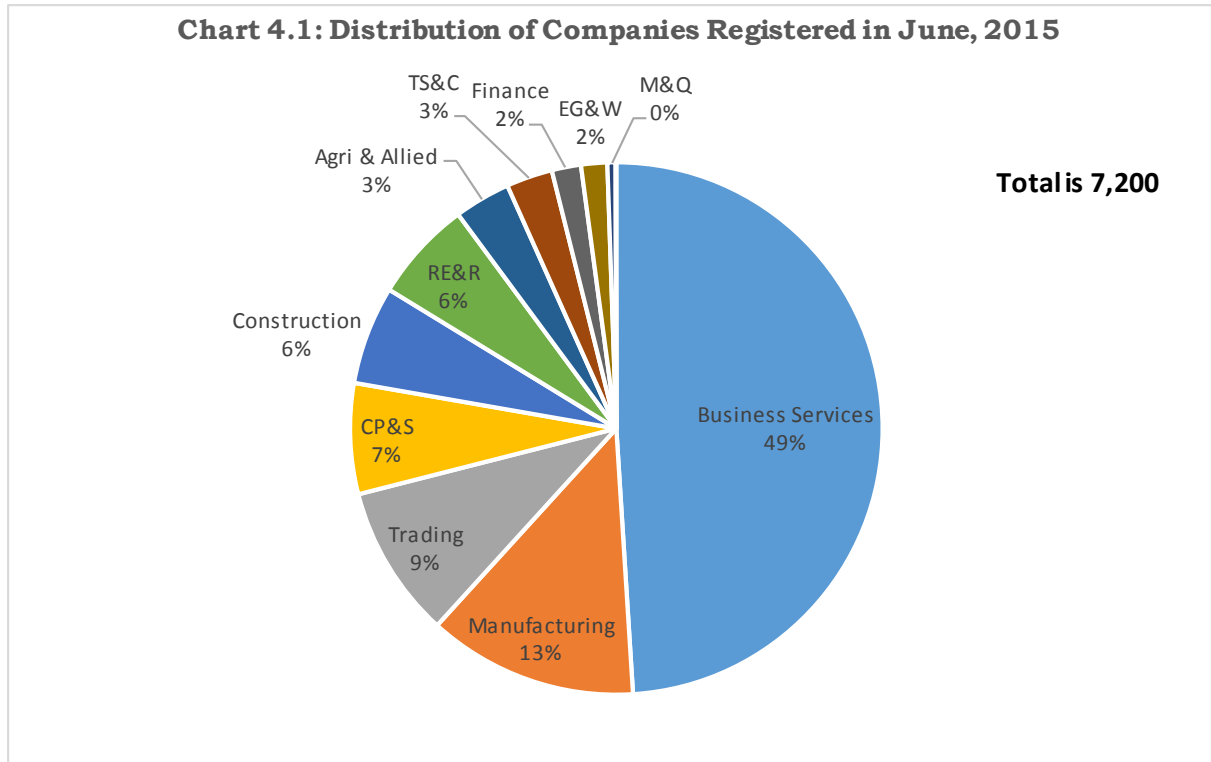
7. An analysis of registration of new companies during January 2013 to June 2015 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (**Chart 3.1**). A total of 7,200 companies were registered in June 2015 as compared to 4,801 in June, 2014. A slight increase in registration of companies has been witnessed in June, 2015 over the previous month. An increasing trend is observed in monthly registration of LLPs in last few months with maximum registration of 2,334 LLPs in March, 2015. (**Table 3.1**). Registration of new companies as well as LLPs has picked-up since April 2014, although a dip was witnessed in October 2014 and April 2015.



IV. REGISTRATION OF NEW COMPANIES DURING JUNE, 2015

8. During the month of June, 2015, a total of 7,200 companies were registered with collective authorized capital of Rs. 1,186.04 crore. Of them 7,168 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,185.92 crore; 32 companies were registered as Limited by Guarantees with authorized capital of Rs. 12.00 lakh. (**Table-4.1**).

9. Economic-activity wise classification of companies registered during June, 2015 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (3,487) followed by Manufacturing (916), Trading (665), Community, personal & Social Services (486) and Real Estate & Renting (442).

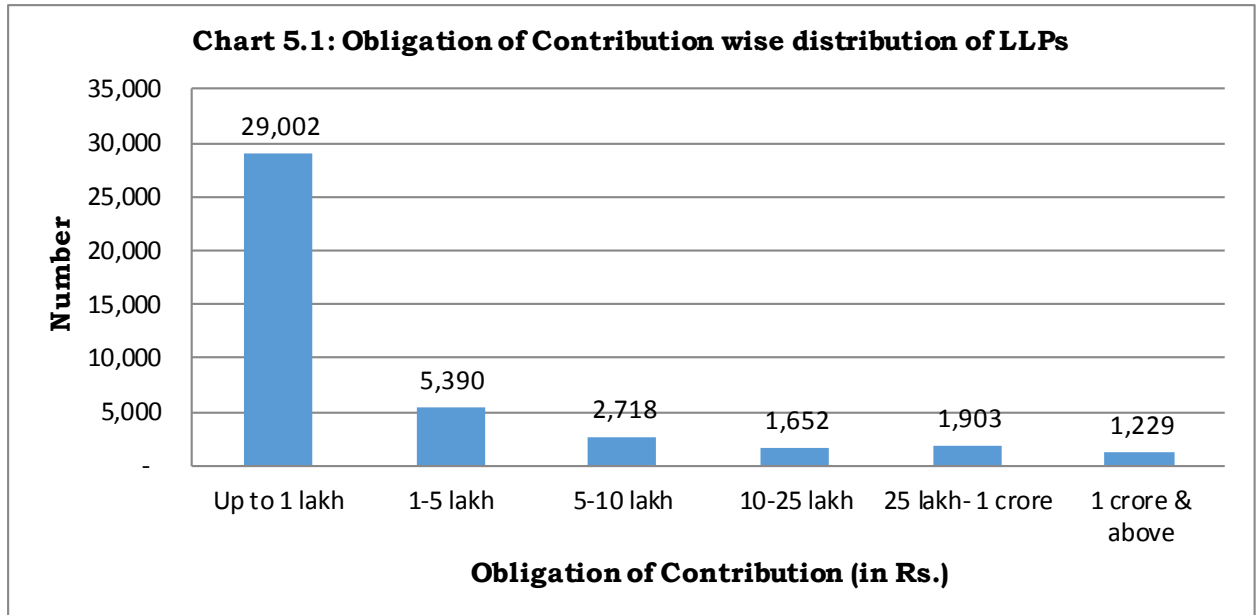

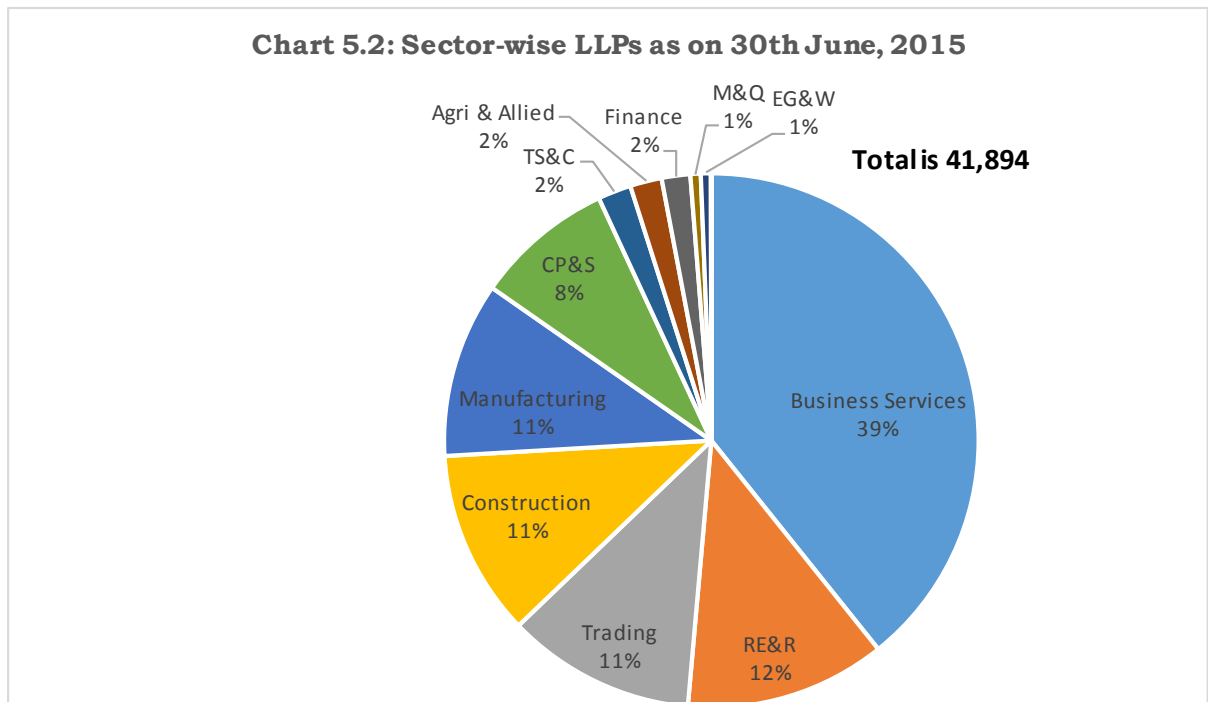
10. During June, 2015, 1,385 (19.24%) companies were registered in Maharashtra, followed by 1,244 (17.28%) in Delhi, and 655(9.10%) in Uttar Pradesh (**Table-4.3**).

V. Limited Liability Partnerships (LLP) and Foreign Companies

11. As on 30th June, 2015, a total number of 42,434 LLPs were registered in the country and 41,894 of them were active. About 82.09 % active LLPs (34,392 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 2.93% (1,229 in number) of LLPs have obligation of contribution of above Rs.1 crore each (**Table-5.1 and Chart 5.1**).

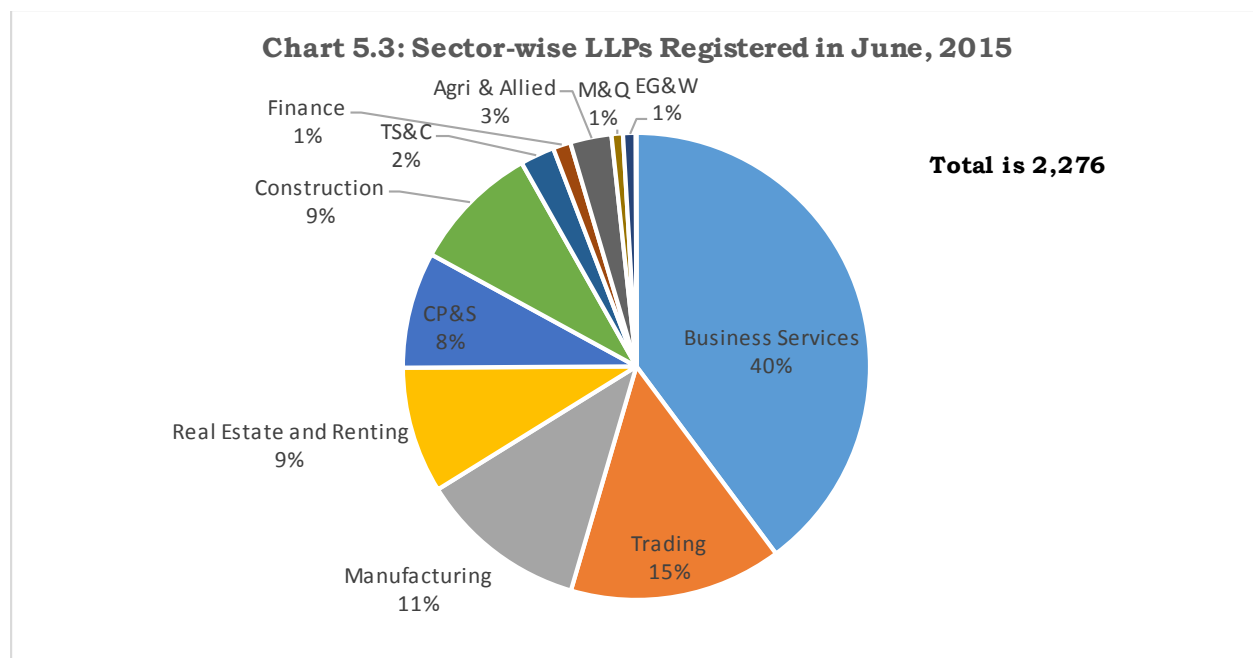


12. Broad economic sector wise classification of active LLPs as on 30th June, 2015 reveals that Service sector account for 31,417 LLPs, followed by Industry and Agriculture sectors accounting for 9,673 and 802 respectively. Economic-activity wise classification of active LLPs as on 30th June, 2015 reveals that a large number of LLPs are in Business Services (16,447) followed by Real Estate & Renting (5,089), Trading (4,784) and Construction (4,714) (**Table-5.2 and Chart 5.2**).

13. A total of 2,276 Limited Liability Partnerships (LLPs) were registered during June, 2015 with collective obligation of contribution of Rs. 251.19 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 906 LLPs were registered in Business Services, followed by 335 in Trading and 265 in Manufacturing (**Table-5.3 and Chart 5.3**). Highest number of 767 LLPs were registered in Maharashtra (33.70 %) followed by 433 in Delhi (19.02 %) during the month of June, 2015 (**Table-6.1**).

Foreign Companies

14. As on 30th June, 2015, a total of 3,312 foreign companies were doing business in India. During the month of June, 2015, 14 foreign companies were registered in India including 5 in Maharashtra, 3 in Delhi, 2 each Haryana and Uttar Pradesh and 1 each in Karnataka and Rajasthan. Out of these 14 foreign companies, 9 were registered under Business Services, 2 in Manufacturing, 1 each in Trading, Mining & Quarrying, and Transport, Storage & Communications.
