HIGHLIGHTS

I. REGISTERED COMPANIES AS ON 30th SEPTEMBER, 2014

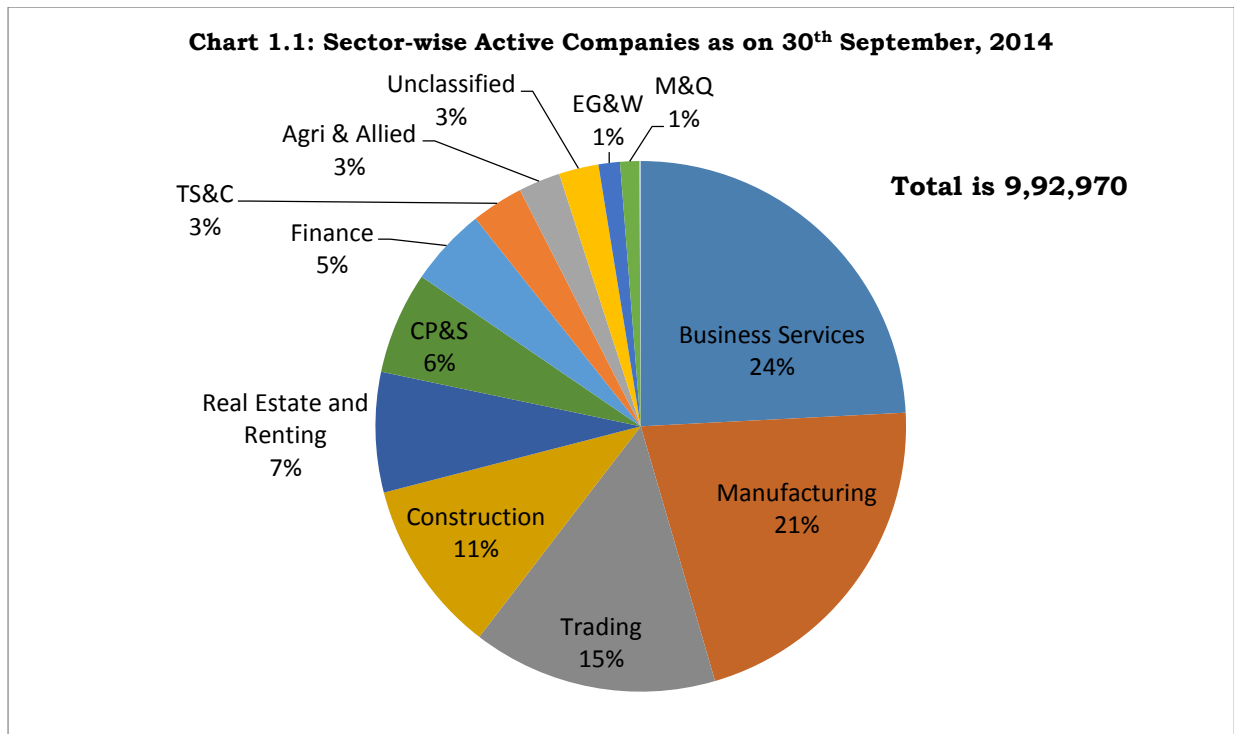
1. The total number of companies registered in the country as on 30th September, 2014, stood at 14,23,000. Of them, 2,60,573 companies were closed; 1,41,714 companies have not filed their statutory annual filings for 3 years consecutively, 30 companies were assigned dormant status as per the Companies Act, 2013; 5,144 companies were under liquidation; 22,234 companies were in the process of being struck-off and 335 companies were in the process of being re-activated. Taking the above into account, there were 9,92,970 active companies as on 30th September, 2014.

2. Out of the 2,60,573 closed companies, about 10,238 companies were liquidated/dissolved; 2,33,647 companies were defunct (and hence struck-off); 14,494 companies were amalgamated/ merged with other companies; 2,194 companies were dissolved and converted to LLP. **Table-1.1** presents the summary picture of companies count as on 30th September, 2014.

3. Authorized Capital wise distribution of active companies as on 30th September, 2014 (**Table-1.2**) indicates that about 65.44% of companies (6,49,829 in number) have authorized capital less than or equal to Rs.10 lakh each and about 2.12% of companies (21,080 in number) have authorized capital of above Rs.10 crore each.

4. State/UT-wise distribution of registered companies indicates that Maharashtra has the highest number of companies (2,88,216), followed by Delhi (2,66,187) and West Bengal (1,83,210). Similarly, amongst 'Active Companies', Maharashtra has the maximum number of active companies (2,10,021), followed by Delhi (1,92,721) and West Bengal (1,35,997) as on 30th September, 2014 (**Table-1.3**).

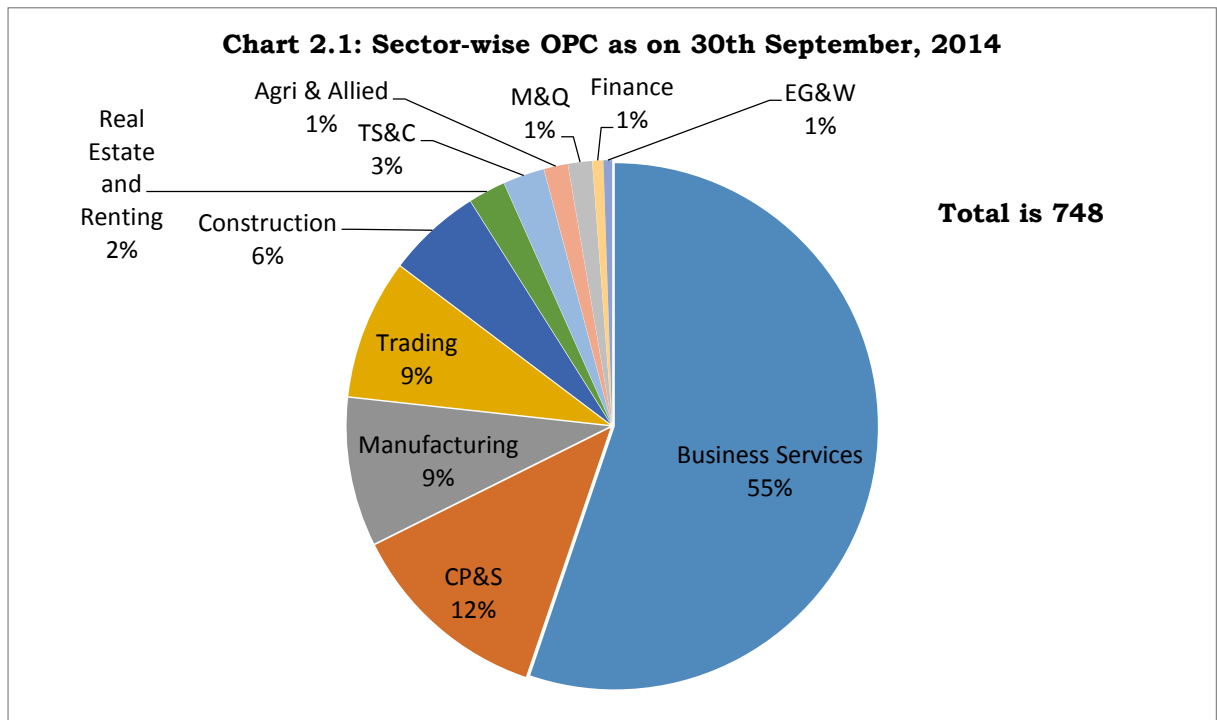
5. Economic-activity wise classification of active companies reveals that highest number of companies are in Business Services (2.40 lakh) followed by Manufacturing (2.11 lakh), Trading (1.48 lakh) and Construction (1.05 lakh). Business Services comprise Information Technology, Research & Development and other business activities (such as law, audit & accounts and consultancy, etc.) (**Table-1.4 and Chart 1.1**).

II. ONE PERSON COMPANY

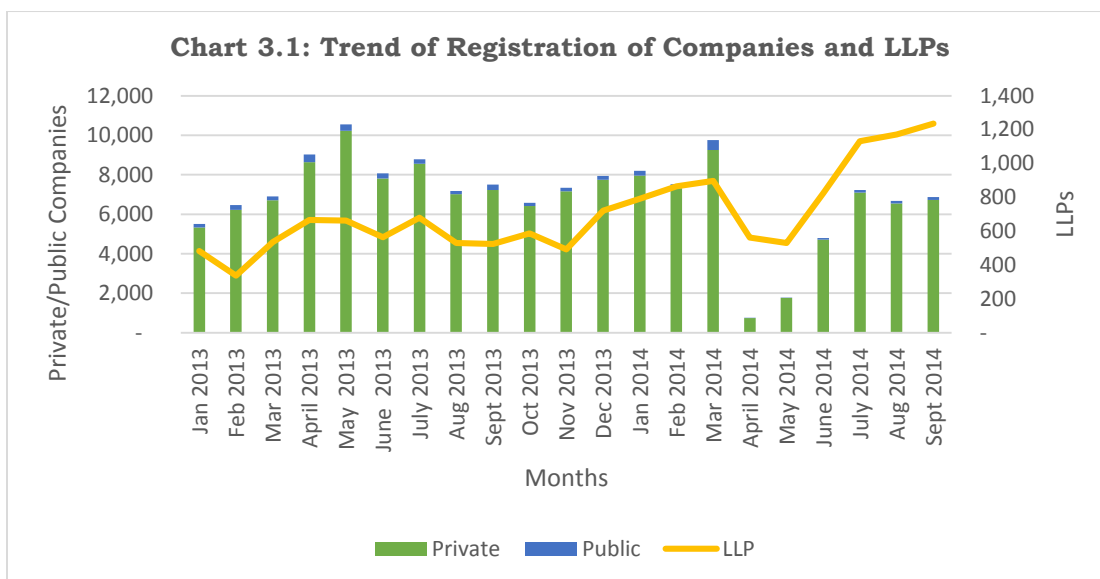
6. Up to 30th September, 2014, a total number of 748 One Person Companies (OPC) were registered with collective authorized capital of Rs. 17.11 crore. Economic activity wise classification of OPC up to 30th September, 2014 reveals that highest number of OPC are in Business Services (413) followed by Community, personal & Social Services (93), Manufacturing (68) and Trading (64) **(Chart 2.1)**. During the month of September, 2014, a total of 269 OPC were registered with authorized capital of Rs. 5.16 crore. Economic activity wise classification of OPC during the month reveals that highest number of 137 OPC were registered in Business Services, followed by 39 in Community, personal & Social Services, 29 in Manufacturing and 28 in Trading **(Table 2.1)**. Highest number of 46 OPC were registered in Maharashtra (17.10 %) followed by 44 in Delhi (16.36 %) and 29 in Uttar Pradesh (10.78%) during the month of September 2014.

III. TREND OF REGISTRATION OF NEW COMPANIES AND LLPs

7. An analysis of registration of new companies during January 2013 to September 2014 indicates that monthly registration of companies is showing an increasing trend after hitting its lowest of 765 in April 2014 (**Chart 3.1**). A total of 6864 companies were registered in September 2014 as compared to 7498 in September 2013. A steep increasing trend is also observed in monthly registration of LLPs in last few months with maximum registration of 1,235 LLPs in September 2014 (**Table 3.1**). Registration of new companies as well as LLPs has picked-up in last five months after a low in April 2014.

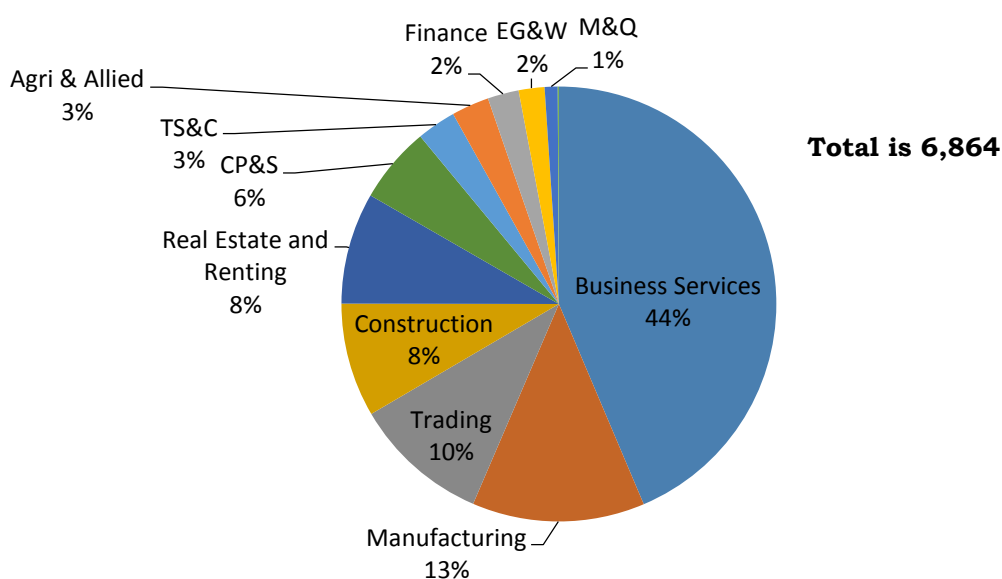


IV. REGISTRATION OF NEW COMPANIES DURING SEPTEMBER, 2014

8. During the month of September, 2014, a total of 6,864 companies were registered with collective authorized capital of Rs. 1831.32 crore. Of them 6,822 companies were registered as Companies Limited by Shares with authorized capital of Rs. 1,831.03 crore; 38 companies were registered as Limited by Guarantees with authorized capital of Rs. 12 lakh; 4 companies were registered as Unlimited Company with authorized capital of Rs. 17 lakh (**Table-4.1**).

9. Economic-activity wise classification of companies registered during September, 2014 (**Table-4.2 and Chart 4.1**) reveals that the predominant share of companies are in Business Services (2,994) followed by Manufacturing (881), Trading (694), Construction (581) and Real Estate & Renting (569).

Chart 4.1: Distribution of Companies Registered in September, 2014



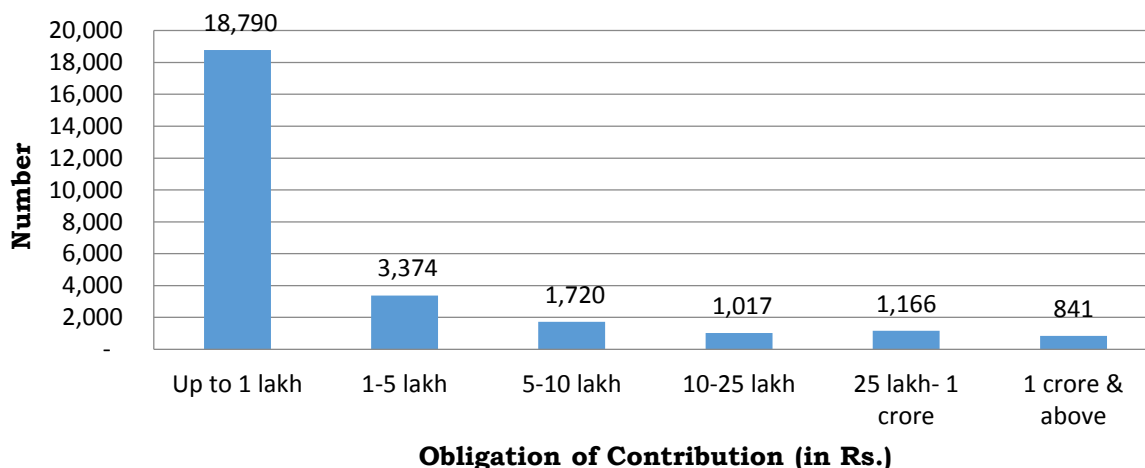

10. During September, 2014 1,181 (17.21%) companies were registered in Delhi, followed by 1,080 (15.73%) in Maharashtra, and 606 (8.83%) in Uttar Pradesh (**Table-4.3**).

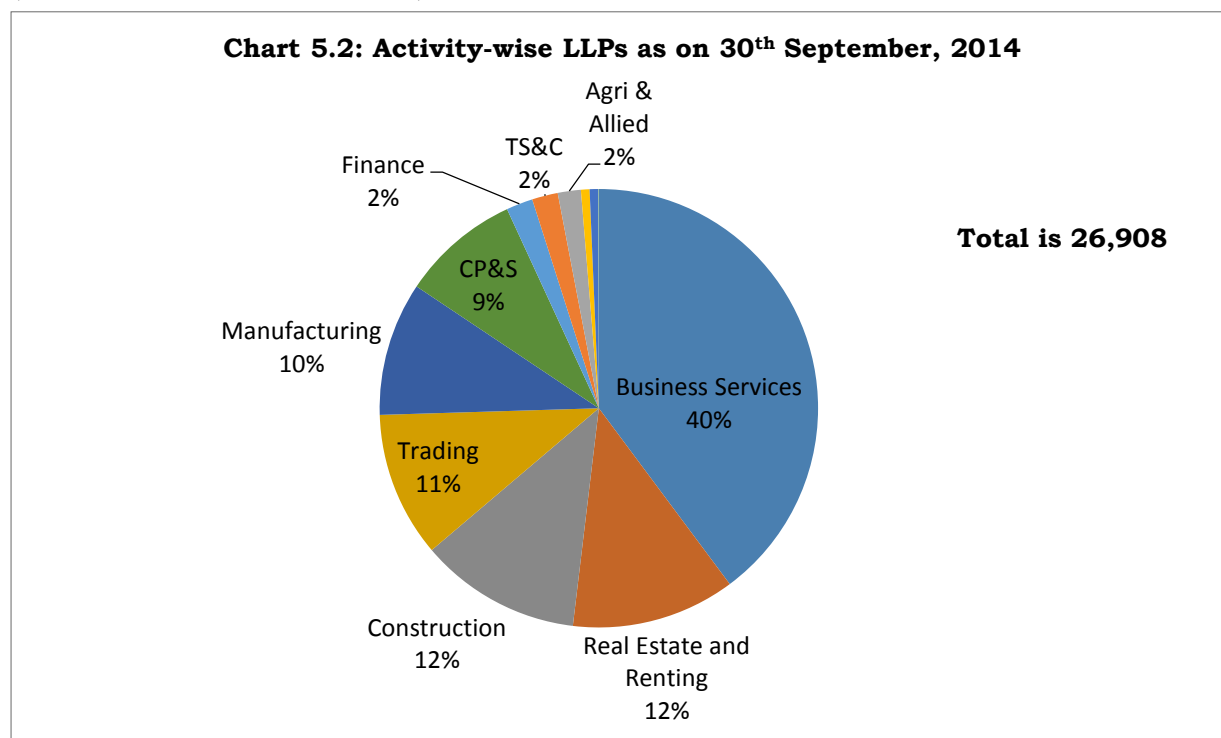
V. Limited Liability Partnerships (LLP) and Foreign Companies

11. As on 30th September, 2014, a total number of 27,239 LLPs were registered in the country and 26,908 of them were active. About 82.37% active LLPs (22,164 in number) have obligation of contribution less than or equal Rs. 5 lakh each; and only about 3.13% (841 in number) of LLPs have obligation of contribution of above Rs.1 crore each (**Table-5.1 and Chart 5.1**).

Chart 5.1: Obligation of Contribution wise distribution of LLPs



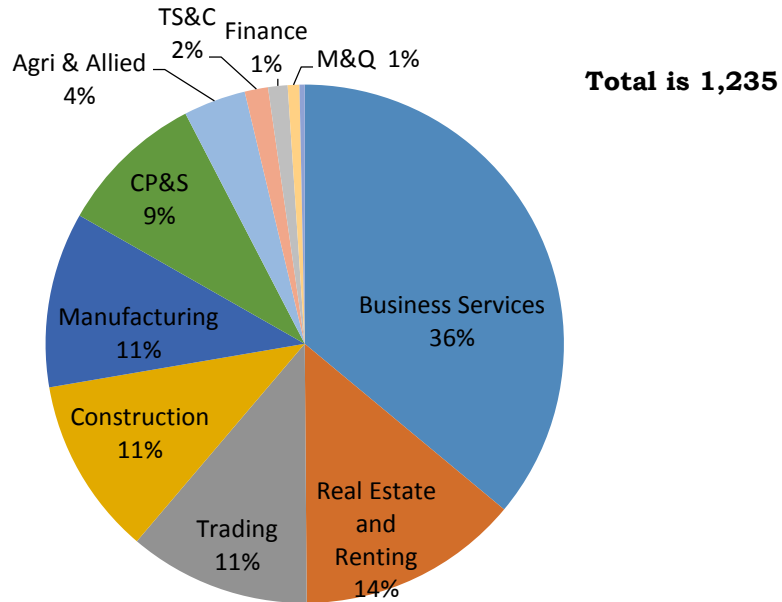
12. Broad economic sector wise classification of active LLPs as on 30th September, 2014 reveals that Service sector account for 20,251 LLPs, followed by Industry and Agriculture sectors accounting for 6,197 and 458 respectively. Economic-activity wise classification of active LLPs as on 30th September, 2014 reveals that a large number of LLPs are in Business Services (10,713) followed by Real Estate & Renting (3,251), Construction (3,203) and Trading (2,884) (**Table-5.2 and Chart 5.2**).



'TS&C' is Transport, Storage and Communication, CP&S is 'Community, personal & Social Services'.

13. A total of 1,235 Limited Liability Partnerships (LLPs) were registered during September, 2014 with collective obligation of contribution of Rs. 201.62 crore. Economic activity wise classification of LLPs during the month reveals that highest number of 445 LLPs were registered in Business Services, followed by 171 in Real Estate and Renting and 140 in Trading (**Table-5.3 and Chart 5.3**). Highest number of 422 LLPs were registered in Maharashtra (34.17%) followed by 137 in West Bengal (11.09%) during the month of September 2014.

Foreign Companies

14. As on 30th September, 2014, a total of 3,282 foreign companies were doing business in India. During the month of September, 2014, 15 foreign companies were registered in India, 5 in Delhi, 3 in Karnataka, 2 each in Tamil Nadu and Haryana and 1 each in the state of Gujarat, Maharashtra and Telangana. A total of 9 foreign companies were registered under Business Services during the month. One foreign LLP was registered in the state of Karnataka during the month of September 2014.
