Vij stirs anti-Pak heat with Kargil girl remark

Chandigarh, 1 March

Haryana's outspoken minister Anil Vij today said those who are supporting Delhi University student Gurmehar Kaur for her campaign against the ABVP, were pro-Pakistan and should be thrown out of the country.

"It is very wrong and condemnable that Gurmehar has tried to do politics over her father's martyrdom," Vij, a five-time MLA, told reporters here on the sidelines of the ongoing state Assembly session here.

He further said, "Pakistan ever since its inception has been fighting direct or proxy wars with India. And a martyr's daughter is giving clean chit to Pakistan,

it is not appropriate. Such people have no right to live here and should be thrown out of the country." Last month, Anil Vij had courted controversy with his remarks that Mahatma Gandhi's image did not help Khadi and caused devaluation of the currency, sparking widespread outrage with even his party condemning his statements, which he withdrew later.

गुजरात में दलित सरपंच की हत्या

राजकोट (भाषा) गुजरात के अमरेली जिले में एक गांव के दलित सरपंच की सर्वांग समुदाय के लोग लोगों ने क्रोधित तौर पर हत्या कर दी। वे लोग लोक पत्र के लिए चुनाव लड़ने के खिलाफ थे। अमरेली के पुलिस अधीक्षक एससी एसटी प्रवीण कुंजरम प्रसार ने बताया कि अमरेली में बसोदा गांव के सरपंच जयसुख भद्रदत्त 25 मरतीन लोगों ने कल रात क्रोधित तौर पर हत्या कर दिया। उन लोगों ने पिछले साल उन्हें चुनाव नहीं लड़ने तक प्रति भूमकी दी थी। प्रसार ने बताया कि कल रात भद्रदत्त को आरोपियों ने घर के निकट बलाया। जिन लोगों ने जोर की छड़ और नकली बंधियार से प्रहार किया पुलिस ने बताया कि मौजूद को अमरेली सरकारी अस्पताल पहुंचाया गया जहां इलाज के दौरान इनकी मौत हो गयी। अमरेली तालुका थाना में आज तीन लोगों के खिलाफ एक प्राथमिकी दर्ज की गयी। तीनों में दो आरोपी भाड़े हैं। तीनों आरोपियों पर आरोपों की धारा 302 (हत्या) और 34 (समाप्त मर्णा से कई लोगों अज्ञात किया गया भक्त) और एससी और एसटी (अत्याचार रोकथाम) कानून को धारा तीन (रोकथाम) के तहत मामला दर्ज किया गया है।
