- 1 Short fitte and commencement > (1) These rules may be called the Department of Company Afrairs Offices of the Regional Directors, Registrars of Companies and Official Liquidator (Junior Technical Assistant Recommenta Roles, 2000).
 - (2) They shall come into force on the date of their publication in the Official Gazette
- 2. Number of post, classification and scale of pay :—The number of post its classification and the S: ife of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recrumment Age, limit and other qualification:—The method of recrumment to the said post, egalimit, qualifications and other matters relating thereto shall be as specified in commune 5 to 14 of the said Schodule.
 - 4 Disqualification No person:--
 - (a) Who has entered into or contracted as marriage with a person having spouse living o
 - (b) Who having a spouse living, has entered into or contracted a marriage with any ocusor, shall be eligible for appointment to the said post

Provided that the Central Government may, if satisfied that such marriage is permissable under the personal los applicable to such person and other party to the marriage and that there are other grounds for so doing example any person from the operation of this rule.

- 5. Powers to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

सा. का. नि. 59 (अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और कंपनी विधि प्रणासन विभाग (संमूह क, ख और ग पद) भर्ती नियम, 1962 को, जहां तक उनका संबंध अभिलेखपाल के पद से हैं उन बातों के सिवाय अधिक्रांत करते हुए जिन्हें ऐसे अधिक्रमण से पहले किया गया है या करने से लोप किया गया है कंपनी कार्य विभाग में क्षेत्रीय निदेशक, कंपनी राजस्ट्रार और शासकीय परिसमापक के कार्यालयों में अभिलेखपाल के पद पर भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनारे हैं, अर्थात् :—

- संक्षिप्त नाम और प्रारम्भ : (1) इन नियमों का संक्षिप्त नाम कंपनी कार्य विभाग, क्षेत्रीय निदेशक, कंपनी राजिस्ट्रार और शासकीय परिसमापक का कार्यालय (अभिलेखपाल) भर्ती नियम, 2000 हैं।
 - (2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. **पद-संख्या, वर्गीकरण और वेतनमान** : उक्त पद की संख्या, उनका वर्गीकरण और उसका वेतनमान वह होगा, जो इन नियमों स उपाबद्ध अनुसूची के स्तंभ (2) से स्तंभ (4) में विनिर्दिष्ट हैं।
- भर्ती की पद्धित, आयु-सीमा, अईताएं आदि : उक्त पद पर भर्ती की पद्धित, आयु-सीमा, अईताएं और उससे संबंधित अन्य बातें वे होंगी जो उक्त अनुसुची के स्तंभ (5) से स्तंभ (14) में विनिर्दिष्ट हैं।
- निरर्हता: वह व्यक्ति,—
 - (क) जिसने ऐसे व्यक्ति से जिसका पति या जिसकी पत्नी जीवित हैं, विवाह किया हैं, या
 - (ख) जिसने अपने पति या अपनी पत्नी के जीवित रहते हुए किसी व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा :

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह ऐसे व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि के अधीन अनुज्ञेय हैं और ऐसा करने के लिए अन्य आधार हैं तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी।

- 5. शिथिल करने की शक्ति : जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां वह उसके लिए जी कारण हैं उन्हें लेखबद्ध करके, इन नियमों के किसी उपबंध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी।
- 6. व्यावृत्ति : इन नियमों की कोई बात, ऐसे आरक्षण, आयु-सीमा में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर निकाले गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, अन्य पिछड़े वर्गी, भूतपूर्व सैनिकों और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।
