G.S.R. 56(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Company Affairs—Subordinate offices (Senior Hindi Translators) Recruitment Rules. 1992, except as respects things done or omitted to be done before such supersession, in so far as they relate to the

post of Senior Hindi Translator the Frestdent hereby makes the following rules regulating the medical of scenaminal to the post of (Senior Hindi Translators) in the Offices of in Regional Directors, Regional Conqueries and Official Equidator in the Department of Company Affairs, namely

- 1 Short title and commencement.—(1) These rules may be called the Department of Company Afaint Offices of the Regional Directors of Registrars of Companies and Official Liquidator (Senior Hind: Translators) Recurring Rules, 2000.
  - (2). They shall come into force on the date of their publication in the Official Gazzer.
- 2. Number of pests, classification and scale of pay.—The number of posts, us of ossification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- Method of recruitment, age limit and other qualifications.—The method of recruitment, to the said post age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (14) of the said Schedule.
  - 4. Disqualification.—No person.—
    - (a) who has entered into or contracted a marriage with a person having spouse living, or
    - (b) who, having a spouse living, has entered into or contracted a martiage with any person, shall be eligible for appointment to the soid post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, and relax any of the provisions of these rules with respect to any class or categories of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes. Other Backward Classes, Ex-serviceman and other special categories of persons in accordance with the Orders issued by the Central Government from time to time in this regard.
