## NOTIFICATION

New Delhi, the 31st January, 2001

- G. S. R. 62(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and an supersession of Department of Company Law Administration (Class I. II and III Posts) Recruitment Rules, 1962, in so far as they relate to the post of Upper Division Clerk except as respects things done or omitted to be gone before such ; supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Upper Division Clerk in the Offices of the Regional Directors, Registrats of Companies and Official Liquidator in the Department
- 1. Short title and commencement.—(1) These rules may be called the Department of Company Afrairs. Offices of the Regional Directors. Registrars of Companies and Official Liquidator (Upper Division Cierk) Recruitment Rules, 2000.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of Posts, classification and scale of Pay.—The number of posts, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule affiexed to these Rules.
- 3. Method of recruitment, age limit and other qualification.—The method of recruitment, to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule.
  - 4. Disqualification.—No person,—
    - (a) who has entered into or contracted a marriage with a person-having a sponse living or
- (b) who having a spouse living, has entered into or contracted a marriage with any person. shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to .! it may, by order, and for reasons to be recorded in writing relax any of the provisions of these rules with respect of class or category of persons.
