- 1. Short title and commencement:—(1) These rules may be called the Department of Company Affairs Offices of the Regional Directors. Pegistrars of Companies and Official Equidator (Hindi Typist) Recomment Rules, 2000.
 - (2) They shall come into force on the date of their publication in the Official Gozette.
- 2. Number of post, classification and scale of pay: —The number of post its classification an Title scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules
- 3. Method of recruitment, age limit and other qualifications:—The method of recruitment to the said post age fund, qualifications and other maters relating thereto shall be as specified in columns 5 to 14 of the said Schedule
 - 4. Disqualification :- No person:
 - (a) who has entered into or contracted a marriage with a person having spease to ring, or
 - (b) who having a spouse living, has enfered into or contracteed a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so denot exempt any person from the operation of this rule.

- 5. Powers to relax:—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing telax any of the provisions of these rules with respect to any class or entegory of persons.
- 6 Saving:—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicement and other special categories of persons in accordance with the orders issued by the Central Government from time to those in this regard.
