<u>Subject : Request for assistance in finding the seniority lists for NFU batch fixation for Category C officers</u>

A number of instructions, on how to process NFU benefits for serving/retired officers of organised Group A Central Civil Services, are available on its website. On the issue of batch fixation of Category C officers (entry as DR-STS/DR-JAG), DOPT had clarified the issues on 3-8-2012 and then again on 27-5-2013.

2. As per the latest clarification dt 27-5-2013, the seniority of the Category C officer, for NFU purpose, has to be seen with reference to his date of appointment (and not with reference to the beginning date of NFU that is 01-01-2006). Which means that for deciding the 'batch for NFU' for category C officer, the batch of next junior Category A officer in the seniority list, in which Category C officer had last entered/re-entered as DR-STS or DR-JAG, has to be seen. Accordingly, the date of entry in the last DR grade of Category C officer and the seniority list (which is to be located for finding next junior Category A officer in that list), is mentioned below, in respect of serving/retired Category C officers:
