Subject: Non functional upgradation (NFU) benefits to ICLS officers as per recommendations of 1<sup>st</sup> Screening Committee meeting dated 26-12-2012

The undersigned is directed to refer to existing DOPT instructions/clarifications on release of NFU benefits to officers of organised Group A Central Services and to intimate that as per these instructions/clarifications, the 1<sup>st</sup> Screening Committee Meeting for ICLS officers (serving on 01-01-2012) was held on 26-12-2012.

- 2. Out of a total of 78 cases, the Screening Committee recommended release of NFU benefits to 62 cases, complete and qualifying from all angles, from the dates and grades mentioned against each of them in **Annexure A.**
- 3. After approval of these recommendations by the competent authority, the controlling officers are now instructed for its implementation as per rules. In respect of those officers where NFU is allowed from 01-04-2013, the vigilance status has to be ascertained again in April 2013, before release of their benefits.
- 4. The screening committee meeting for serving officers for NFU in higher level and for retired officers (retired between Jan 2006 to Dec 2011) will be convened soon.

## Category and batch of officers for calculation of NFU entitlements as per DOPT instructions

- (i) Category for NFU: Category A officer means an officer inducted in JTS grade as DR and then progressed to all higher grades by promotion only. Category B officer means an officer inducted in JTS grade as promotee from feeder grades and then progressed to all higher grades by promotion only. Category C officer means an officer inducted in STS or/and JAG grade as DR.
- (ii) Batch for NFU: Batch for Category A officer, is the year following the year of examination. Batch for Category B officer is the batch of that nearest junior Category A officer with whom his seniority is clubbed in JTS grade. Batch for Category C officer is the batch of that nearest junior Category A officer, with whom his seniority is clubbed in the grade, for which he is screened for NFU. From 01.01.2013 onwards, in all the grade wise seniority lists, the batch for NFU shall also be mentioned.
