OFFICE ORDER

 - b) If at any point in future, it is found that any certificate or document or testimonial or information furnished by them, having a bearing on their eligibility for this appointment, is not in order or any information/ facts having bearing on his eligibility have not been disclosed or misrepresented by them, then their appointment is liable to be cancelled forthwith, without prejudice to any other punitive action under the relevant rules.

3. The appointment is also subject to satisfaction of all terms and conditions as mentioned in the 'Offer of Appointment' issued by Ministry of Corporate Affairs to them,

the provisions of ICLS Rules, 2015 and other rules of the Competent Authorities on the subject.

4. The above pay fixation is subject to post audit and overpayments, if any, in the form of arrears or otherwise will be recovered from the officers subsequently.


