## **ORDER**

With immediate effect and until further orders, the President is pleased to designate the Secretary, National financial Reporting Authority (NFRA) as 'Head of Department' under Rule 3 (f) of Delegation of Financial Power Rules (DFPR), 1978. Further, in accordance with the guidelines issued by the Ministry of Finance under OM No. F.10 (13)-E (Coord)/75 dated 10.04.1975 and OM No. 1/7/E-II (A)/2008 dated 30.05.2008, financial powers to the following extent is also delegated to 'Head of Department' of NFRA under Rule 32 (2) of DFPR, 1978 for incurring Contingent and Miscellaneous expenditure in accordance with Annexure to Schedule V & VI of DFPR-1978 as revised and amended from time to time:

- 3. The powers delegated are subject to provisions contained in Note 2 of Schedule V of DFPR 1978.

- 4. No power under Rule 13 (2) is delegated in respect of
  - (i) Creation of posts
  - (ii) Write off of losses
  - (iii) Re-appropriation of funds
- 5. All procurement including Hiring of vehicle would be made through GeM only. (Car make: Sedan, Category: High usage with 3000 Kms and 375 hours per month.)
- 6. This issues with the concurrence of JS & FA vide Dy. No. 1034 dated 27.05.2019 and approval of Secretary, CA vide Dy. No. 2346 dated 28.05.2019.
