Subject : Clarification on the point --- whether benefits of pay fixation in the cases of ACPS/MACPS granted in the 5th CPC scales of Rs. 8000-13500 has to be correspondingly fixed in PB 2 + GP of 5400 or in the PB 3 + GP of 5400 after 6th CPC implementation.

The undersigned is directed to say that on the representation received from Sh. Animesh Bose, STA, on the above issue, the opinion of D/O Personnel and Training (Establishment D) and D/O Expenditure (E.III.A) was sought.

2. On the basis of opinion(s) received, it is intimated to Sh. Animesh Bose, STA that this Ministry agrees to the proposal for grant of Grade Pay of 5400 in Pay Band of Rs. 15600-39100 in PB-3 to him on attaining financial up-gradation under ACP scheme prior to 31-8-2008.

3. This decision shall also apply to all similarly placed beneficiaries of ACP/MACPS schemes in the pre-revised scale of 8000-13500. The controlling officers may issue revised orders accordingly.

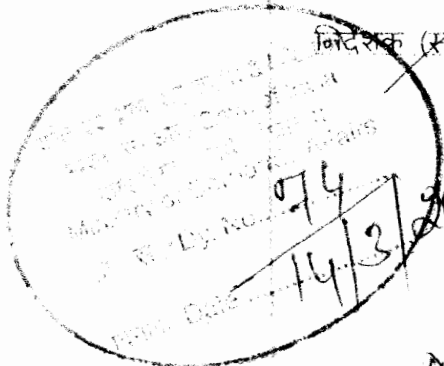
