Subject: Regular promotion of 40 Junior Technical Assistants (JTAs) to STA grade

The competent authority in the Ministry of Corporate Affairs (MCA) is pleased to promote **forty (40) JTAs**, mentioned in <u>Annexure A</u>, to the post of Senior Technical Assistant (STA) (Group B Non Gazetted) (Pay Band 2 + Grade Pay of 4600) with effect from the date of assumption of charge.

- 2. The competent authority has also decided to promote **four (4) JTAs** mentioned in <u>Annexure C</u> with effect from the future dates. However, in respect of these 4 JTAs before relieving them to accept promotions, the respective RDs are instructed to ascertain the vigilance status from vigilance section of MCA.
- 3. In respect of three (3) JTAs mentioned in <u>Annexure B</u> the vigilance clearance is not available due to their non submission of Annual Immovable Property Return (AIPR). All of them may submit their AIPRs directly to vigilance section. After receipt of vigilance clearance, they will be re-considered by DPC.
- 4. All promoted JTAs will assume the charge of their promoted post of STA, in their present offices only. Transfer of posts, if required, is also approved.
- 5. The vacancies created, due to above promotions, are required to be urgently intimated, in DR requisitions, to concerned SSCs if the vacated JTA post belongs to DR category. Similarly, they are to be filled up in next regional DPC, if vacated post belongs to DP category.
- 6. After above promotion, against 231 sanctioned posts of JTAs, the incumbency position of regular JTAs has come down to 101. About 80% of these 130 vacancies is in DR quota. To save from large scale shortage in JTA grade in field offices in coming months/years, respective RDs are instructed to regularly pursue the matter with concerned SSCs on priority. The latest position of vacancies in the region in DR-JTA category (after above promotion) and status report of all past/present action taken in this regard is required to be sent by RDs to the undersigned, latest by 01-10-2012. During the last 2 years, except Mumbai region, no other RD has reported any joining of DR-JTA candidates (through SSC) in their region.
