The Chief Controller of Accounts, MCA has informed that due to technical reasons bills for expenditure out of Budget Allocations 2016-17 will not be accepted by the PAO after 26.03.2017. Accordingly, all budget units are requested to prefer their bills for expenditure out of budget allocation 2016-17 to the Pay and Accounts Officer latest by 26.03.2017. The budget unites which fail to prefer their bills to PAO by the stipulated date, Heads of Department of such budget units will be held personally responsible for lapse of funds on account of delay in presentation of bills.

However, under exceptional circumstances, if a Budget Center wishes to prefer a bill after 26.03.2017, detailed justification for such delayed presentation of bill, with the approval of Secretary, CA, will have to be submitted to the Chief Controller of Accounts for seeking relaxation.

It is also advised that the budget units which intend to seek concurrence of JS&FA for expenditure upto 26.03.2017, proposals in this regards may be submitted to IF Division latest by 13:00 Hours on 24.03.2017. Any proposal after the timeline aforementioned will not be entertained in IFD.
