3. The competent authority in the MCA has approved all promotions recommended by the DPC, which will be effective from the dates of their joining in the offices, to be decided by the RD(WR). - 4. The ad-hoc appointments shall be subject to the following conditions:
 - i. All ad-hoc promotions, shall be <u>upto 17-3-2012</u> or until further orders or till regular UDC/JTAs become available through the normal channels of recruitment as per RRs of UDC/JTA, which ever is earlier.
 - ii. The adhoc appointment shall not confer on the appointees any right to continue in the grade indefinitely or for inclusion in the select list or to claim seniority in the UDC/JTA grade.
- iii. Adhoc appointments can be terminated at any point of time without giving any reason therefore;
- iv. The appointment on adhoc basis and consequential service benefits shall take effect from the date of taking over the charge of the post of UDC/JTA and;
- v. All rules of competent authorities on adhoc appointment shall apply.
- vi. To the extent possible, the officers promoted on ad-hoc basis may be continued in the same office.
- 5. After joining by all officers in their promoted posts, the revised staff position in Group B/C/D grades in the western region may be intimated.
