The terms and conditions are as under:-

- 1. Whether your company is having full infrastructure for the satisfactory repair of Duplo copy printer. Details in this regard may be furnished.
- 2. Whether the firm/agency is doing similar type of job in other Ministries/Departments. If so, copies of the contracts awarded by these Ministries/Departments may be enclosed.
- 3. The rates with parts and without parts have to be submitted.
- 4. An undertaking is to be given that in case of replacement of old damaged parts, only genuine parts will be installed.

- 5. The details of items covered under the comprehensive maintenance contract and the parts/items cost of which have to be borne by the Ministry may be given.
- 6. In case, the cost of damaged part or parts are to be borne by the Ministry, the firm has to intimate the same in advance in writing and will replace the same after obtaining the approval of competent authority.
- 7. The Company who has been awarded the contract will not assign the work to any second party and will attend to the complaints by themselves.
- 8. The Engineer of the company will have to visit two times in a week. In addition to that he will have to attend the urgent calls for rectifying the faults for keeping the machine in good working condition at any time on short notice.
- 9. The Ministry has the right to terminate the comprehensive AMC by giving one month's notice and vice versa, if the services rendered are not found satisfactory. In this case, the contractor will refund the proportionate amount of AMC for the rest of the period of the AMC, if any.
- 10. The payment will be made on quarterly basis after completion of the quarter.
