The flower pots proposed to be procured shall be of good quality. Seasonal flowers proposed to be placed for flower pots are indicated below:

2. The terms and conditions on which the intended work would be entrusted to the successful bidder are as follows:

- i) Flower pots are to be supplied on requirement basis for placing in rooms as directed by the Ministry from time to time.
- ii) The flowers proposed to be provided should be fresh and of the good quality.
- iii) Vase for the flower pots are to be provided by the supplier and these should be of the good quality. Broken vase should be replaced free of cost.
- iv) Flowers are to be placed in the rooms before 8.30 AM daily, on all working days, [Big size (20 pieces) flower with pots arrangement of Hon'ble MoS room and officers viz. Tata Rose, Kaneskan, Jarbara, Aseyatik, Guldavari Dalya, Lilies etc.] and time as directed by the Ministry from time to time.
- v) In case, the quality of flowers is found to be inferior or the flowers are not fresh, then this Ministry shall deduct the entire amount for the day on which flowers of inferior quality have been provided.
- vi) The Ministry reserves the right to terminate the contract at any time without assigning any reason therefore.
- vii) Flower bouquets are to be supplied on short notice as and when directed by the Ministry.
- viii) Payment of bills will be made after verifying that the firm have made supplies as per the directions of the Ministry.
- ix) The Bidder shall furnish proof/indicate that it is already supplying flowers/flowers pots to other Ministries/Departments/Organizations of repute for the last 2-3 years and its services have been satisfactory with a minimum turnover of Rs. 4.50 lacs per annum.

- x) Quotation must be accompanied with crossed Demand Draft for Rs.1000/-as EMD in favour of Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi.
- 3. The successful bidder will be required to furnish security deposit of Rs.10,000/- (Rupees ten thousand only) in the form of FDR or Bank Guarantee duly hypothecated in favour of DDO, Ministry of Corporate Affairs within 7 days of award of the work.
