SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

- 1. The Ministry of Corporate Affairs, located at 5th floor, Shastri Bhawan, Dr. R. P. Road, New Delhi, requires the services of reputed, well established and financially sound Manpower Service Providers to provide Stenographers, Office Assistants, Hindi Typists, Data Entry Operators and Drivers.
- 2. The contract for providing the aforesaid manpower is likely to commence from 01.06.2015 and would continue till 31st May, 2016. The period of the contract may be further extended beyond 31st May, 2016 provided the requirement of the Ministry for manpower persists at that time or may be curtailed / terminated before 31st May, 2016 owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of change in the Ministry's requirements. The Ministry, however, reserves the right to terminate this initial contract at any time after giving one week's notice to the selected Service Provider.
- 3. The bid of firm quoting impractically low or nil service charges are liable to be rejected on technical grounds.
- 4. A feedback on the reputation of the firm from its existing client Ministries/Departments specifically with reference to timely payment of salaries to staff, quality of staff deployed will be taken into account while considering the financial bid of the tenderer.
- 5. This Ministry has initial requirement for 31 English Stenographers, 32 Office Assistants, 03 Hindi Typists, 03 Data Entry Operators and 03 Drivers. The requirements may increase/decrease in any /all of the categories.
- 6. - 8. The tender is required to be submitted under two bid system i.e. Technical Bid and Financial Bid. The interested agencies are advised to submit two separate sealed envelopes super-scribing "Technical Bid for Providing Manpower Services to Ministry of Corporate Affairs" and "Financial Bid for providing manpower Services to Ministry of Corporate Affairs". Both sealed envelopes should be kept in one envelop with superscription "Bid for Providing Manpower Services to Ministry of Corporate Affairs".
- 9. The Earnest money Deposit (EMD) of Rs.25,000 (Rupees Twenty Five Thousand only), refundable (without interest), should be necessarily accompanied with the <u>Technical Bid</u> of the service provider in the form of Demand Draft / Pay Order drawn in a favour of Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi, failing which the tender shall be rejected summarily.
- 10. The successful tenderer will have to deposit a Performance Security Deposit of Rs.1,00,000 (Rupees One Lakh Only) in the form of Bank Guarantee from any Scheduled Commercial Bank drawn in favour of the Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi covering the period of contract. - 15. The Financial Bid of only those tenderers will be opened whose Technical bids are found in order. The Financial bids shall be opened at 03.30 PM on 05.05.2015 in Room No. 525, 5th Floor, A-Wing, Ministry of Corporate Affairs, Shastri Bhawan, Dr. R. P. Road, New Delhi in the presence of the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at that time.
- 16. The Competent Authority of the Ministry reserves the right to annul all bids without assigning any reason.

TECHNICAL REQUIREMENTS FOR THE TENDERING MANPOWER SERVICE PROVIDER

- 1. The tendering manpower service provider should fulfill the following technical specifications:
 - (a) The Registered Office or one of the Branch Offices should be located either in Delhi / New Delhi or in any of the Satellite Towns of Delhi
 - (b) They should be registered with the appropriate registration authority;
 - (c) They should have at least three years' experience in supplying manpower with minimum strength of 30 per month to perform official works or with minimum annual turnover of Rs. 25.00 Lakh for such works to Government Departments, Private Companies, Public Sector Companies/Banks, etc.;

- 1. The rates quoted by the tendering agency should be inclusive of all statutory/taxation liabilities in force at the time of entering into the contract.
- 2. The payment shall be made on conclusion of the calendar month only on the basis of no. of working days for which duty has been performed by each manpower.



TERMS AND CONDITIONS

GENERAL

- 1. The contract shall commence from tentatives from 01.06.2015 and shall continue till unless it is curtailed or terminated by this Ministry owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirement of the Ministry.
- 2. The contract shall automatically expire on 31.05.2016 unless extended further by the mutual consent of contracting agency and this Ministry.
- 3. The contract may be extended for a period of 2 years on the same terms and conditions or with some additions / deletions / modifications, on mutually agreed upon by the successful service provider and Ministry of Corporate Affairs on yearly basis.
- 4. The contacting service provider shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior written consent of this Ministry.
- 5. The Ministry, at present, has tentative requirement of 31 skilled English Stenographers, 32 Office Assistants, 93 Hindi Typists, 03 Data Entry Operators and 03 Drivers on urgent basis. The requirement of the Ministry may further increase or decrease marginally, during the period of initial contract also and the tenderer would have to provide additional manpower services, if required, on the same terms and conditions.
- 6. The tenderer will be bound by the details furnished by him / her to this Ministry while submitting the tender or at subsequent stage. In case, any of such documents furnished by him / her is found to be false at any stage, it would be deemed to be a breach of terms of contact making him / her liable for legal action besides termination of contract.
- 7. The Ministry reserves right to terminate the contract during initial period also after giving a week's notice to the contracting agency.
- 8. The persons deployed shall be required to report for work at 09.00 hrs. to Under Secretary (Admn. I) and would leave at 17.30 hrs. The person deployed may also be required to work beyond 17.30 hrs for which he/she would not be paid any extra remuneration. In case, the person deployed is absent on a particular day or comes late / leaves early on three occasions, proportionate deduction for one day will be made.
- 9. In case such a person is asked to work beyond 6.30 PM, he/she shall be entitled to late sitting cum transport compensation of Rs.100/- per day.
- 10. The Service Provider shall nominate a coordinator who would be responsible for immediate interaction with the Ministry so that optimal services of the persons deployed by the agency could be availed without any disruption.

- 11. The entire financial liability in respect of manpower services deployed in this Ministry shall be that of the service provider and this Ministry will in no way be liable.
- 12. For all intents and purposes, the service provider shall be "Employer" within the meaning of different Labour Legislations in respect of manpower so employed and deployed in this Ministry. The persons deployed by the service provider in this Ministry shall not have any claims whatsoever like employer and employee relationship against Ministry of Corporate Affairs.
- 13. The service provider shall be solely responsible for the redressal of grievances / resolution of disputes relating to persons deployed. This Ministry shall, in no way, be responsible for settlement of such issues whatsoever.
- 14. This Ministry shall not be responsible for any financial loss or any injury to any person deployed by service provider in the course of their performing the functions/duties, or for payment towards any compensation.
- 15. The persons deployed by the service provider shall not claim nor shall be entitled to pay, perks and other facilities to regular / confirmed employees of this Ministry during the currency or after expiry of the contract.
- 16. In case of termination of this contract on its expiry of otherwise, the persons deployed by the service provider shall not be entitled to and will have no claim for any absorption in the regular / otherwise capacity in this Ministry.

LEGAL

- 17. The personnel, during course of their work, shall be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take oath of confidentiality and breach of this condition shall make the service provider as well as the person concerned liable for penal action under IPC, Cr. P.C. or any other relevant provision besides, action for breach of contract.
- 18. The service provider will be responsible for compliance of all statutory provisions relating to Minimum Wages, Provident Fund, and Employees State Insurance etc. in respect of the persons deployed by it in this Ministry. The Ministry shall have no liability in this regard.
- 19. The service provider shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to Ministry of Corporate Affairs to the concerned tax collection authorities from time to time as per extant rules and regulations in the matter.
- 20. The service provider shall maintain all statutory registers under the Law. The agency shall produce the same, on demand, to the concerned authority of this Ministry or any other authority under Law.

- 21. The Tax Deduction at Source (T.D.S.) shall be done as per the provisions of Income Tax Act/Rules, as amended from time to time and a certificate to this effect shall be provided to the agency by this Ministry.
- 22. In case, the service provider fails to comply with any statutory / taxation liability under appropriate law, and as a result thereof the Ministry is put to any loss / obligation, monitory or otherwise, the Ministry will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the service provider, to the extent of the loss or obligation in monetary terms.

FINANCIAL

- 23. The Technical Bid should be accompanied with an Earnest Money Deposit (EMD), refundable without interest of Rs.25,000/- (Rupees Twenty five Thousand Only) in the form of Demand Draft / Pay Order drawn in favour of Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi failing which the tender shall be rejected out rightly.
- 24. The Earnest money Deposit in respect of the agencies which do not qualify the Technical Bid (First Stage) / Financial Bid (Second competitive stage) shall be returned to them without any interest. However, the E.M.D. in respect of the successful tenderer shall be adjusted towards the Performance Security Deposit. Further, if the agency fails to deploy the required manpower against the initial requirement within 30 days from date of placing the order the EMD shall stand forfeited without giving any further notice.
- 25. The successful tenderer will have to deposit a security amount of Rs.1,00,000/- (Rupees One Lakh Only) in the form of Bank Guarantee made in the name of the Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi covering the period of contract. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be accordingly renewed by the successful tenderer.
- 26. In case of breach of any terms and conditions attached to this contract the Performance Security Deposit of the agency will be liable to be forfeited by this Ministry besides annulment of the contract.
- 27. The agency shall raise the bill, in triplicate, along with attendance sheet [duly verified by Under Secretary (Admn. I) in respect of the persons deployed and submit the same to Under Secretary (Admn. I) in the first week of the succeeding month. As far as possible the payment will be released by the second week of the succeeding month.
- 28. The claims in bills regarding Employees State Insurance, Provident Fund, and Service Tax etc. should be necessarily accompanied with documentary proof pertaining to the concerned bill month. A requisite portion of the bills / whole of the bill amount shall be held up till such proof is furnished, at the discretion of this Ministry.



- 29. The amount of penalty calculated @ Rs.100/- day on account of delay, if any, in providing a suitable substitute for the period beyond three working days by the agency shall be deducted from the monthly bills of the service provider in the following month.
- 30. The Ministry of Corporate Affairs reserves the right to withdraw / relax any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage.
