NOTICE is hereby given that a petition under Section 433, 434 and 439 of the Companies Act, 1956 for winding up of the above named Company presented on 16.01.2014 was admitted by an order dated 07.05.2014 and the Provisional Liquidator has been appointed with usual powers under the Companies Act, 1956. Subsequently by an order passed by the Hon'ble High Court, Bombay dated 28.08.2014 in Company Petition No. 255 of 2014 presented by M/s. N. R. Traders Private Limited (Petitioners) M/s. # NOTICE TO WORKERS / CREDITORS TO PROVE THEIR CLAIMS
