NOTIFICATION

New Delhi, the 31st January, 2001

G. S. R. 60(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Company Law Administration (Class I, II and III Posts) Recruitment Rules, 1962, in so far as they relate to the post of Superintendent Grade II except as respects things done or ommitted to be done before such supersession, the President hereby makes the following rules regulating. The method of recruitment to the post of Superintendent Grade II in Offices of the Regional Directors, Registrars of Companies and Official Liquidator in the Department of Company Affairs, namely:—

1. Short title and commencement.—(1) These rules may be called the Department of Company Affairs, Office of the Regional Directors, Registrars of Companies and Official Liquidator (Superintendent Grade II) Recruitment

Rules, 2000.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and scale of pay.—The number of posts, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these Rules.

3. Method of recruitment, age limit and other qualifications.—The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule.

4. Disqualification.-No person.-

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any

person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
