Sir,

Please refer to your OM No- A-42011/35/2013-Ad-2 dated: 22nd Nov 2013 and 9th Jan 2014 and to state that my name has not been included for granting of NFU to eligible ICLS officers in SAG Scale, though I was fulfilling all the conditions as on 01-01-2006 i.e. the date from which the benefits of Sixth pay commission recommendation were due and admissible.

It may not be out of place to mention that, I retired in the month of Feb 2007, as Joint Director (Legal) in Non Functional Selection Grade (N F S G) of ICLS from the Office of Regional Director (NR), Ministry of Corporate Affairs, NOIDA, (U.P.). I was selected in Gr IV (JTS) of the Legal Branch of Central Company Law Service through Union Public Service Commission in the year 1979 and joined as Asstt. Registrar of Companies, in the office of Registrar of Companies Maharashtra, Ministry of Corporate Affairs Bombay on 25/5/1979. Further on 07/02/2001, I was promoted to JAG & with the same date NFSG was granted to me. As such I had completed more than 27 years regular service in Group 'A' post of ICLS including 6 years' service in JAG level on the date of retirement on attaining the age of superannuation. As on 1.01.2006 i.e. the effective date of granting of benefits of NFU as per DOPT OM No.AB 14017/64/2008-Estt.(RR) dated 24.04.2009, my regular Group A service in JAG level Of ICLS was more than 5 years.

The instructions for grant of Non Functional Up gradation (NFU) benefits as per 6th CPC recommendations had been issued in DOPT OM No.AB.14017/64/2008-Estt.(RR) dated 24th April, 2009, where in it has been very specifically stated that grant of higher scale under these instructions would be considered w.e.f. 01-01-2006 where ever due. As per DOPT OM No-AB.14017/64/2008-Estd (RR) dated: 25-09-2009 even the retired officers who are otherwise eligible as on due date would need to be consider. It has further been clarified the scheme for non-functional upgradation of officers of Organized Group A services in PB-3 and PB-4 is based on recommendation of sixth pay commission. These recommendations have been implemented w.e.f 01-01-2006.

Further DOPT vide OM No.14017/61/2008/Estt. (RR)/Pt .dated 15/12/2009 had directed all the Cadre controlling authorities of various organized group A services to initiate action for amendments in the service rules i.e., officers with 17 years regular service in Group 'A' posts in the service out of which at least 4 years' service should be in JAG level for promotion to SAG with out mentioning again the effective date of granting benefits under NFU . As the OM of the DOPT dated 15.12.2009 was nothing but an extension of clarification of DOPT OM No. AB 14017/64/2008-Estt. (RR) dated 24/04/2009, it was not considered necessary to mention effective date of grant of NFU since it was already mentioned in DOPT OM dated 24/4/2009 . Thus in the absence of any mention of effective date from which the benefits NFU are to be given to ICLS officers of Group A in the aforesaid circular of 15-12-2009 it has to be presumed that the benefit of these amendments are to be given to all the officers who have retired between 01.01.2006 to 14-12-2009 also in view of DOPT OM No. AB14017/64/2008-Estt (RR) dated 24.4.2009.

In view of above I request to you to indicate the reasons for non-inclusion of my name in the list of officers for approval of NFU benefits and supply me the attested photocopy of following:

1. A copy of file noting containing proposal sent by MCA on subject to DOPT with reference to which DOPT issued instructions /clarifications & relaxation vide their ID No.952567/13/Estt RR dated 09/12/2013 .(Both copy of MCA proposal as well as copy of ID dated 09/12/2013).
2. Agenda Note and Minutes of the Screening Committee Meeting by which NFU was granted to 22 officers of ICLS Group A service vide OM No- A-42011-35-2013-Ad-II dated: 22-11-2013 and
3. Agenda Note and Minutes of the Screening Committee Meeting by which NFU was granted to 6 officers of ICLS Group A service vide OM No- A-42011/35/2013-Ad-2 dated: 9th Jan 2014.
