By my letter dated 6th February 2014 (sent by speed post on 7 February 2014), along with requisite postal order, I had sought information from the Central Public Information Officer of the Ministry of Corporate Affairs, Government of India, New Delhi under the provisions of the Rights to Information Act 2005. Copy of my said letter is attached herewith.

However although more than thirty days have elapsed since my writing to the Central Public Information Officer (CPIO) of the Ministry of Corporate Affairs, Government of India, New Delhi, I have not received any reply from him. This I put on record as a violation of the provisions of the Rights to Information Act 2005 and I am hereby placing my first appeal to you under the provisions of the said Act for immediately providing the information I had sought from the CPIO, to me along with information about the reasons why the CPIO refrained from providing the information to me.

The issue involved is of extreme serious concern for me and since the damage is already done by the CPIO by not providing the information, I would request you to provide me the information at once.


