Sub: In the matter of Section 75 of the Limited Liability Partnership Act, 2008 (the Act)

With reference to the above subject, I am directed to state that the list of LLPs (attached as Annexure – 1) have made an application in Form 24 for striking off their respective names from the register in pursuance to Rule 37(1)(b) of the Limited Liability Partnership Rules 2009 (the Rules) and action under Rule 37(1) has been initiated against these LLPs.
