All the appointments of experts/ consultants/professionals/professional CA firms will be made with the approval of Ministry of Corporate Affairs.
- 3. Scheme for engagement of Consultants/Experts in the Serious Fraud Investigation Office is enclosed.
- 4. This issues in consultation with Ministry of Finance, Department of Expenditure vide their ID No. 68 dated 16.02.2015 and Integrated Finance Division vide their ID No. 166 dated 29.04.2015.

SCHEME FOR ENGAGEMENT OF EXPERTS/CONSULTANTS IN SERIOUS FRAUD INVESTIGATION OFFICE (SFIO) UNDER RULE 3 AND 4(D) OF THE COMPANIES (INSPECTION, INVESTIGATION AND INQUIRY) RULES, 2014

SCOPE OF THE SCHEME

The scheme would be operative for engagement of Individual Experts/Consultants or other professionals or professional firms for multiple disciplines where the skill sets are either not available inhouse or normally not available for deputation due to acute shortage of manpower within the government.

2. ENGAGEMENT OF INDIVIDUAL CONSULTANTS

2.1 GENERAL CONDITIONS

- (i) Professionals, retired employees from Govt. / autonomous organizations, with requisite qualifications and experience would be eligible for appointment
- (ii) Engagement would be on a full or part time basis for a fixed period, or a short term arrangement, for specific and time bound jobs.
- (iii) The Experts/Consultants would have no lien on any job in Serious Fraud Investigation Officer.
- (iv) The Experts/Consultants shall work in Serious Fraud Investigation Office at Headquarter at Delhi or any of its regional offices and shall perform the functions assigned to them by the competent authority of SFIO.
- (v) The requirement of expert(s) will be transparently advertised.

2.2 FUNCTIONS

The broad details of Terms of Reference for the work to be done would be as per the format prescribed at **Annexure-I** within the framework of provisions contained in-

- Chapter 6(II)- Procurement of Services (Rule 163 to 177) of General Financial Rules, 2005.
- Chapter VII Selection of individual consultants (Para 1.2.1, 7.1, 7.2& 7.3) of Manual of Policies and Procedures of Employment of Consultants issued by Department of Expenditure.

2.3 QUALIFCATIONS, EXPERIENCE AND FEE PAYABLE

- (i) The Qualification, experience and fee payable to 'Consultant-I' and 'Consultant-II' engaged by the Serious Fraud Investigation Office is given in **Annexure-II**.
- (ii) The fee for Experts/Consultants engaged on part time basis would be decided by the Consultancy Evaluation Committee (para 2.4 below) subject to the provisions and ceiling of **Annexure-II**.

2.4 PROCEDURE OF SELECTION, EXTENSION AND CANCELLATION OF ENGAGEMENT

(i) The recommendation of the panel of Experts/Consultants shall be made by a Consultancy Evaluation Committee (CEC) in order of merit comprising of the following members:

(a) Director, SFIO(b) Representative of MCA

ChairmanMember

(c) FA or his/her representative (d) Deputy Director (Admn) SFIO

- Member

Deputy Director (Admn), SFIO -Member-Secretary

The panel recommended by the CEC would be valid for a period of one year.

(ii) Period of engagement of consultants will initially be for 6 months which can be extended upto 1 year by Director, SFIO. Subsequent extensions, if any, shall be decided by the CEC on the recommendation of Director, SFIO on a case-to-case basis depending upon the specific job and time frame for its completion. While engaging the consultants, CEC will comply with the relevant provisions of GFR 2005 specifically Rule 169 (shortlisting of consultants), Rule 170 (ToR including task to be carried out, schedule time of completion of task, input to be provided to the consultants & the final output that will be required of the consultants) etc.

The maximum period of engagement of Experts/ Consultants shall be 5 years or attaining the age of 65years, whichever is earlier.

(iii) The Experts/Consultants would have no lien on any job, and such engagement may be cancelled at any time by the SFIO without assigning any reason.

- (iv) Before recommending a panel for engagement of a consultants, the CEC will carry out the background checks as considered necessary by it including report of the professional body regulating that profession, testimonials of past employments etc.
- (v) The employment as consultant is subject to clearance from the professional body regulating the profession wherever applicable. Further, the contract will remain provisional till police verification is received.

2.5 ALLOWANCES, TA/DA & LEAVE

The conveyance allowance, TA/DA payable and Leave to Experts/ Consultants, are given in Annexure III.

3. ENGAGEMENT OF I.T CONSULTANTS THROUGH NIC/NICSI

3.1 Engagement of consultants in the field of Information Technology shall be made through the IT consulting firms empanelled with NIC/NICSI as per its approved terms and conditions.

4. ENGAGEMENT OF PROFESSIONAL CHARTERED ACCOUNTANTS FIRMS

- 4.1 SFIO would draw a panel by inviting applications from willing professional CA firms through advertisement to be published in leading newspaper and also on the official website of SFIO. While drawing up a panel of professional firms, the procedure of minimum qualifying standard/criteria will be fixed using, inter alia, the following parameters:
 - i) Minimum experience including number of assignments handled by the firm similar to the area of assignment
 - ii) Turnover and financial parameters of the firm
 - iii) Minimum educational qualifications of each of the key professionals
 - iv) Minimum requirement of experience of the key professionals in an area similar to the proposed assignment
- 4.2 The panel so drawn would be valid for 3 years, which can be extended further for a period of one year, subject to satisfactory performance. While fixing the quantum of fees for an assignment, guidelines issued by the Institute of Chartered Accountants of India from time to time, will be followed.

5. CONTRACT AGREEMENT

- 5.1 The Experts/Consultants/Professional Firms on having accepted the offer shall enter into a contract with the Director, SFIO. The norms for secrecy will be as per Section 3& 4 of the Official Secret Act, 1923 so far as declaration of Fidelity & Secrecy is concerned as per Annexure IV (A) & IV(B). Security of sensitive data would be ensured through signing of non-disclosure agreement with the Experts/Consultants/Firms.
- 5.2 Without prejudice to and in addition to the legal remedies available to the Serious Fraud Investigation Office, breach of contract shall be considered a sufficient ground for termination of the contract.

6. POWERS TO RELAX

6.1 The Ministry of Corporate Affairs shall have the power to relax any of the conditions of this Scheme in special cases.
