

- (1) Notice is hereby given that the Registrar of companies had received applications from the above mentioned companies under section 248(2) of the Companies act, 2013 for removal of its/their name(s) from the register of companies either on the ground that they have failed to commence business within one year of their incorporation or on the ground that the company(ies) is/are not carrying on any business or operation for a period of two immediately preceding financial years and has/have not made any application(s) within such period for obtaining the status of a dormant company under section 455 of the Companies Act, 2013 or the company(ies) have obtained the status of dormant company, but it/they not wish to continue its/their registration as companies and have, therefor, requested for removal/strike off of its/their names from the register of companies.
