अटकल तज हा गइ एक बदा काग्रस विधायक भाजपा में शामिल होने की योजना बना रहे है लेकिन कुछ ने इसे यह कह कर खारिज किया कि उनका कदम जमीनी स्तर पर पार्टी को मजबूत करने के लिए है। मुख्यमंत्री एन वीरन सिंह के नेतृत्व में राज्य में भाजपा गठबंधन की सरकार चला रही है। कांग्रेस के इन 12 विधायकों ने प्रदेश कांग्रेस कमिटी के अध्यक्ष मैखनगम को अपना इस्तीफा सौंपा जो कांग्रेस कार्य समिति (सीडब्ल्यूसी) के भी सदस्य है। राज्य में 2017 के विधानसभा चुनावों के बाद कांग्रेस के 29 विधायक थे लेकिन उसके आठ विधायक पिछले साल भाजपा में शामिल हो गए थे जिससे 60 सदस्यीय सदन में भगवा पार्टी के विधायकों की संख्या 21 से बढ़ कर 29 हो गई थी।

बलात्कार की शिकार नाबालिग ने दिया प्रीमैच्योर बच्ची को जन्म

सीकर, (भाषा)। राजस्थान के सीकर जिले के कोतवाली थानाक्षेत्र में बलात्कार पीडिता नाबालिग द्वारा प्रीमैच्योर बच्ची को जन्म देने के बाद पड़ोस में रहने वाले आरोपी के खिलाफ बलात्कार और पोक्सो अधिनियम के तहत मामला दर्ज किया गया। पुलिस जांच अधिकारी भंवरलाल ने बृहस्पतिवार को बताया कि नाबालिग द्वारा प्रीमैच्योर बच्ची को जन्म देने के बाद पुलिस ने आरोपी आमिर काजी (20) के खिलाफ भारतीय दंड संहिता की धारा 376 और पोक्सो अधिनियम के तहत 28 मई को मामला दर्ज किया। उन्होंने बताया कि पीडिता का अस्पताल में बयान दर्ज कर लिया गया है। पीडिता और नवजात बच्ची को बृहस्पतिवार को अस्पताल से छुट्टी दे दी गई। उन्होंने बताया कि नाबालिग ने मंगलवार को यहां राजकीय जनना अस्पताल में प्रीमैच्योर बच्ची को जन्म दिया था। मामला दर्ज होने के बाद पुलिस ने आरोपी पड़ोसी युवक की तलाश शुरू कर दी है।

उन्होंने बताया कि 14 साल की इस किशोरी के पेट में दर्द की शिकायत पर परिजन उसे अस्पताल लेकर पहुंचे जहां चिकित्सकों ने जांच के बाद बालिका के परिजनों को बताया कि नाबालिग सात महीने की गर्भवती है।
