# 2. The terms and conditions on which the intended work would be entrusted to the successful bidder are as follows:

i) Flower pots are to be supplied on requirement basis for placing in rooms as directed by the Ministry.

- ii) The flowers proposed to be provided should be fresh and of the good quality.
- iii). Vase for the flower pots are to be provided by the suppliers and these should be of the good quality.
- iv) Rates for the above mentioned flowers as well as other flowers available in the market in respective season are to be quoted.
- v) Flowers are to be placed in the room before 8.30 AM daily, or on the days, [Big size (20 pieces) flower with pots arrangement of Hon'ble MoS room and officers viz. Tata Rose Kaneskan, Jarbara, Aseyatik, Guldavari Dalya, Lilies etc.] and time as desired by the Ministry.
- vi) In case, the quality of flowers is found to be inferior or the flowers are not fresh, then this Ministry shall deduct the entire amount for the day on which flowers of inferior quality have been provided.
- vii) The Ministry reserves the right to terminate the contract at any time without assigning any reason.
- viii) Flower bouquets are to be supplied on short notice as and when desired by the Ministry.
- ix) Payment of bills will be made after verifying that the firm have made supplies as per the directions of the Ministry.
- x) The Bidder shall furnish proof/indicate that it is already supplying flowers/flowers pots to other Ministries/Departments/Organizations of repute and its services have been satisfactory with a minimum turnover of Rs. 4.50 lacs per annum.

- xi) Quotation must be accompanied with crossed Demand Draft for Rs.1000/as EMD in favour of Pay & Accounts Officer, Ministry of Corporate Affairs, New Delhi.
- 3. An amount of Rs.10,000/- (Rupees ten thousand only) by Demand Draft in favour of DDO, Ministry of Corporate Affairs, New Delhi as security deposit will be required to be deposited with this Ministry on acceptance of the contract. It will not carry any interest and will be refunded only on satisfactory completion of the contract.
