National Company Law Tribunal, New Delhi invites 06 (Six only) fresh and cut flower arrangements consisting of 12/20 twigs each bid through National Company Law Tribunal (NCLT) website, e-publish system under CPPP (Central Public Procurement Portal) and reputed firms for supply of cute flowers in flower vases in the National Company Law Tribunal, Block No.3, CGO Complex, Lodhi Road, New Delhi. The rate contract shall be valid for a period of two year with a possibility of extension for the third year.

- The quotation in the prescribed Performa (enclosed) addressed to the undersigned by name in double sealed cover duly marked "QUOTATION FOR PROVIDING FRESH AND CUT FLOWER ARRANGEMENTS" should reach the Under Secretary, NCLT at the above mentioned address.
 - Last Date & Time of submission of quotations on 10th August, 2016 upto 1100 Hrs.
 - ii) Date & Time of Opening of Quotations on 10th August, 2016 at 1200 Noon in the presence of Committee Members and representative of the interested firms in Committee Room at Ground Floor Block No.3, CGO Complex, Lodhi Road, New Delhi.
- 4. The Quotation should accompany with an Earnest Money Deposit (EMD) of Rs.5,000/- (Rupees five thousand only) in the form of Bank draft in the favour of Pay and Account Officer, Ministry of Corporate Affairs, Delhi. The contract will be awarded for a period of two year from the date of issue of the contract with a possibility of extension for the third year depending on the satisfactory performance and mutual consent. However, in the event of services rendered being found unsatisfactory, the contract can be terminated at any time without assigning any reason thereof. The decision of the National Company Law Tribunal in this regard will be final. The demand draft of Rs.5,000/- as an earnest money is mandatory, which will be kept as security deposit of the firm to whom the contract will be awarded. The demand drafts of the other firms will be returned. No interest would be paid on the EMD.

Terms and Conditions

- The contract will be awarded for a period of two year from the date of issue of the contract with the possibility of extension for the third year subject to satisfactory performance and mutual consent.
- Payment will be made every month after production of pre-receipted bills along with the satisfactory certificates from the concerned officers or satisfaction of the whole department in this regard.
- The florist will look after the maintenance of the flower arrangements daily/alternatively as the case may be on all working days on regular basis. The fresh cut flowers replaced daily or thrice in a week (alternate working days) in the rooms as per the list given by the Ministry.
- 4. The flower arrangements will include seasonal flowers as desired by the National Company Law tribunal from the varieties of flowers like Gladiola, Tulip, Red Rose, Orchid Vase Laurel Leaf, Lily and Gerbera, Anthurium Cube, Rose and carnation Orchid Cock's comb (Celosia) Salvia etc. The cut flower will be of good quality and replacement will be made before 9.00 AM on each working day.
- A random check will be conducted to inspect the freshness, quality and quantity or otherwise of the flower arrangement. The decision of the NCLT in this regard will be binding on the contract holder.
- In case of any deficiency in service or unsatisfactory, arrangement of flowers, a penalty
 of 5% of the bill for each occasion will be imposed on you. The decision of the Tribunal
 in this regard shall be final and binding.
- In case of any dispute arising between the contract holder and the Tribunal or any
 consignment being party to the contract the sole authority for settlement of such a
 disputes, will rest with the arbitrator, appointed by the President, National Company
 Law Tribunal.
- 8. The firm may be asked over phone for supplying flower bouquet within 2 hours, if the firm fails to supply in stipulated time, the same shall be made from open market at risk and cost of contracted firm and the cost of such purchase shall be recovered from the contracted supplier. Additionally, if the competent authority in the Tribunal decided so, general damages, the value of which would depend upon the gravity of lapse on the part of the supplier and the damages suffered by the Tribunal, shall also be imposed on the contracted supplier.

- Tax shall be deducted at source as per the Income Tax Act from the monthly bills as per rules.
- The firm shall have all statutory licence/registration which are essential/mandatory of supplying/providing the required services in Delhi.
- Any damages, loss or theft will have to be borne by the firm.
- Enclosed Annexure –I Pre-requisite Documents, Annexure-II Rates of flower arrangement and Annexure-III Undertaking to be submitted by each bidder.
