



Subject: Submission of Annual Immovable Property Return for the year 2014 (as on 1st January, 2015).

This is about filing of Annual Immovable Property Return (AIPR) by Group "A" & "B" Officers in terms of Rule 18(1) (ii) of the CCS (Conduct) Rules, 1964, giving full particulars of his/her immovable property inherited by him/her or held by him/her on lease or mortgage either in his/her own name or in the name of any member of his/her family or in the name of any other person without any exception. **The said return has become due from all such officers as on 1-1-2015.**

2. Full details of Immovable Property are to be given and **expressions like "No change" or "same as last year" will not be accepted.** If an officer does not own any property he/she should state 'Nil' in the return rather leaving it blank and it should be duly signed by the officer with date.
3. All Group A & B Officers in the Ministry/all Officers of Attached/ Subordinate Offices are therefore requested to send the statement in the prescribed proforma of Immovable Property Return(**copy enclosed**) as on 1-1-2015 to the Vigilance Section of this Ministry **before 31-01-2015.** Head of all Offices are required to obtain the Immovable Property Return in respect of all Group A and B Officers who are working under them and the same with a "Completion Certificate" (**copy enclosed**) should be sent to Vigilance Section of this Ministry.
4. It may be noted that Vigilance clearance shall be denied to an Officer if he/she fails to submit his or her Annual Immovable Property Return of the previous year by 31st January of the following year in terms of DOP&T's Office Memorandum No.11012/11/2007-Estt(A) dated 27-9-2011.

- 8) The declaration form is required to be filled in and submitted by every member of Class I and Class II (Group A and Group B) services under rule 15(3) of the Central Civil Services (Conduct) Rules, 1955, {now rule 18(1) of the CCS (Conduct) Rules, 1964} on the first appointment to the service and thereafter at the interval of every twelve months, giving particulars of all immovable property owned, acquired or inherited by him or held by him on lease or mortgage, either in his own name or in the name of any members of his family or in the name or any other person dependent on Government servant.
- 9) The wording 'no change' or 'no addition' or 'as in the previous year' should be avoided and full details provided.
- 10) The columns should be filled up neatly in capital letters.
