- 2. The approximate expenditure on daily allowance for this period is coming to Rs. 1.9 lakhs for each probationer. With above distribution of expenditure liabilities, the issue of source of funds stands settled.
- 3. The above liability of each of the mentioned office is for the entire about 3 months period of 2<sup>nd</sup> phase attachment. Therefore, one third of the mentioned amount has to be released, directly to the officers account as DA advance, by concerned controlling officer immediately, without waiting for any request from the officer. The second one third has to be released on 01.06.2013 and the last one third has to be released on 01.07.2013, after the officer submits proof (photocopies) of incurring expenditure on accommodation/boarding/lodging from the previously released one third amount. The claim of final settlement has to be submitted in Hqrs after completion of this phase.
- 4. This expenditure has to be borne by all mentioned offices, in precedence over any other current/future liabilities against DTE object head. The controlling officers may submit their revised DTE requirement in RE 2013-14 or ask for any authorization from Budget section, but only after completing the release of DA advance to the officer, as per Para 2 and 3 above.
- 5. The above distribution of expenditure liabilities on account of daily allowance advance/expenditure to the officers, has the approval of JS&FA and Secretary, MCA.
- 6. The earlier two orders of even no. dated 18.04.2013 and dated 29.04.2012 stands superseded to the extent mentioned above. Sh JK Jolly, JD in ICLS Academy, shall be the nodal officer, between probationers and the field offices, on the issue of disbursement of advance or any matter related to it.
