Detailed quotations/rates duly signed by authorized person giving full name, address and contract Telephone numbers etc. may be furnished by 22<sup>nd</sup> May, 2017 up to 5.00 PM addressed to the O/O, Registrar of Companies Punjab & Chandigarh at the aforesaid address and the opening of bids shall take place on 25<sup>th</sup> May, 2017 at O/O, Registrar of Companies Punjab & Chandigarh, Corporate Bhawan, Plot No.4-B, Ist Floor, Sector-27-B, Madhya Marg, Chandigarh-160 019 Chandigarh at 2.00 P.M.

- 1. The bidder shall on inspection of the building should examine the reasons of water leakage in the building causing damage at ground floor of the building by employing the expert/engineer and take proper measurement for giving its estimate/quotation for said repair work.
- 2. The bidder shall clearly mentioned the specification of the work to be done for repair of Seepage & Leakage in the building. The bidder shall also clearly mention about the treatment/procedures to be adopted for repair of all roofs of the building. The bidder shall also mention the period within which the firm is able to complete the work after award the said work.
- 3. The bidder shall give the guarantee of the work to be completed for period of not less than 1 year after completion of the work. In terms of Rule 158 of GFR, the bidder shall furnish Bank Guarantee of 10% of its quotation amount as security for his performance guarantee given for repair of the building.
- 4. No advance amount will be given for the said repair work and the bidders shall use their own material & manpower in carrying out the above repair.

- 5. The bidder should preferable be based at Chandigarh and the bidders should be well conversant with the work to be carried out and must have already performed similar work within time frame of any other Govt. Office. The bidder shall adopt all safety measures under the law while carrying out the said repair work particularly working at top of the roof.
- 6 The submission of bid will not put this Office under any obligation for awarding the work to the bidder and the expenses incurred in this regard shall not be borne by the Govt.
- 7. The bidder should ensure the completion of work within stipulated time as mentioned in its quotation.
- 8. The bill for payment in duplicate should be submitted along with certificate of civil engineer that the said repair work has been completed as per specification of work mentioned in the quotation of the firm and in the engagement letter and also within the time frame mentioned in the contract/engagement letter for the said work.
- 9. If water Leakage in the building causing damage at ground floor is happening within one year from the completion of the work, the firm shall repair again at its own cost and fresh period of Guarantee will start from the 2<sup>nd</sup> time repair of the work and performance guarantee of 10% of amount will be revoked by the Government unless fresh bank guarantee 1 year is furnished by firm. The firm will also liable for all damage and cost to the Govt. on account of leakage in the building during the Guarantee period.
- 10. In case of non-completion of assignment beyond 3 months over stipulated time or any damage caused to the Govt. property/Building, no payment shall be made to the Contractor concerned. An affidavit to this effect is to be furnished by all the bidders along with the tenders.
