- 5. In view of upgradation in Grade Pay of the above posts, those who have applied for the above posts in response to advertisement/O.M. No. 10/121/2016-NCLT dated 22.02.2017 need to apply again, if eligible, and the applications received for filling the above posts in response to the said advertisement/O.M. will not be considered.
